PLACEMENT UPDATE & APPENDIX 3B

Further to the ASX release of 24 December 2018, Troy Resources Limited (**ASX: TRY**) (**Troy** or the **Company**) advises that, due to late acceptances of the placement offer, the share placement raised approximately \$2.76 million (before costs) at an issue price of \$0.105 per share ("Placement").

Proceeds from the Placement will be used to fund ongoing activities in Guyana, including exploration of the Ohio Creek Prospect and construction of a road from the Karouni Mill to Ohio Creek, as well as for general working capital purposes.

The Placement sees the issue of 26,284,808 shares from the Company's capacity available under ASX Listing Rule 7.1.

The ASX Appendix 3B for the issue of the shares and the Notification under S.708A of the *Corporations Act 2001* (Cth) is attached.

As per the earlier noted announcement, details and documentation for the Share Purchase Plan ("SPP") will be released shortly.

Under the SPP, individual shareholders will be able to subscribe for shares in the Company up to the value of \$15,000 which, at the issue price of \$0.105 per share, represents a maximum of 142,857 shares.
