1. Your Name and Address

This is the name and address on the Share Register of the Company as shown on the front of the proxy form.

2. Appointment of a Proxy

Short explanation for Resolutions 4 – 6: The directors agreed not to receive cash for their 2018 directors' fees and superannuation entitlements, but instead to receive either Class G Performance Rights (Mr Peter N Smith and Mr Michael J Povey) or fully paid ordinary shares (Mr Ewan E Smith), subject to shareholder approval. The purpose is to increase the incentive of the directors to work towards increasing shareholder value and to enable more cash for working capital and for the Company's research and exploration programs. In the event that Resolutions 4 to 6 do not get shareholder approval, the Directors' remuneration for the year ended 30 June 2018 will revert to being paid in cash. If this occurs the directors have agreed to defer payment until the Company has the cash resources to be able to pay.

Resolution 7 – Issue of Class H Performance Rights to director – Mr Peter N Smith

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an ordinary resolution.

Short explanation for Resolutions 7 & 8: The Executive Directors have not received a director fee increase, nor a consulting rate increase for over 7 years. In addition, the Executive Directors, Peter N Smith and Michael J Povey have agreed to assist the Company by deferring payment, without interest, to them of consulting fees owing as at 30 June 2018 for services rendered (net of GST) of \$420,964 and \$94,240 respectively. In recognition of these sacrifices the Shareholders are being asked to approve this issue of Class H Performance Rights to these Directors. This issue will also act to increase the incentive of the directors to work towards increasing shareholder value.

Resolution 9 – Issue of Shares to contractor – Mr Mark P Nelson

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an ordinary resolution.

“That, for the purpose of Listing Rule 7.1 and for all other purposes, Shareholders approve the issue of 512,000 fully paid ordinary shares to Mr Mark P Nelson. Further details of which are set out in the Explanatory Statement accompanying this Notice of General Meeting”.

EXPLANATORY MEMORANDUM

This Explanatory Memorandum has been prepared for the Shareholders of Truscott Mining Corporation Limited in connection with the business to be conducted at the forthcoming Annual General Meeting of the Company, or any adjournment thereof and should be read in conjunction with the accompanying notice of meeting.

The Directors recommend that Shareholders read this Explanatory Memorandum before determining whether or not to support the Resolutions.

Annual Financial Report

The financial report of the Company for the financial year ended 30 June 2018 (including the financial statements, directors' report and auditors' report) was included in the 2018 Annual Report of the Company. A link to the Annual Report is available on the Company's website at www.truscottmining.com.au.

Resolution 1 – Remuneration Report

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the Remuneration Report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the company or the directors of the company.

The remuneration report sets out the company's remuneration arrangements for the directors and senior management of the company. The remuneration report is part of the directors' report contained in the annual financial report of the company for a financial year.

The chair of the meeting must allow a reasonable opportunity for its shareholders to ask questions about or make comments on the remuneration report at the annual general meeting.

Voting consequences

Under the Corporations Act, a company is required to put to its shareholders a resolution proposing the calling of another meeting of shareholders to consider the appointment of directors of the company (Spill Resolution) if, at consecutive annual general meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report and at the first of those annual general meetings a Spill Resolution was not put to the vote. If required, the Spill Resolution must be put to the vote at the second of those annual general meetings.

If more than 50% of votes cast are in favour of the Spill Resolution, the company must convene a shareholder meeting (Spill Meeting) within 90 days of the second annual general meeting.

All of the directors of the company who were in office when the directors' report (as included in the company's annual financial report for the most recent financial year) was approved, other than the managing director of the company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as directors of the company is approved will be the directors of the company.

Previous voting results

At the Company's previous annual general meeting the votes cast against the remuneration report considered at that annual general meeting were less than 25%. Accordingly, the Spill Resolution is not relevant for this Annual General Meeting.

Proxy voting restrictions

Members of key management personnel, including the directors, of the Company will be excluded from voting on Resolution 1. In accordance with section 250R of the Corporations Act 2001 if a member directs their proxy vote on Resolution 1 to be at the discretion of the Chairman that vote will not be counted. If a member wants to cast a valid proxy vote on Resolution 1 then the member must indicate their voting intention by marking the appropriate box. If you abstain, your votes will not be counted in calculating the required majority if a poll is called on the resolution.

Resolution 2 – Re-Election of Director

Mr Michael J Povey

Pursuant to rule 11.3 of the Company's Constitution, at each Annual General Meeting, one third of the Directors, other than the Managing Director, (or, if their number is not a multiple of 3, then the number nearest to one third) must retire from office. The Directors retire by rotation, with the Directors who have been the longest in the office since being appointed or re-appointed being the Directors who must resign in any year. If 2 or more persons became directors (or were re-elected) on the same day, those to retire must be determined by lot unless they otherwise agree among themselves. All directors are entitled to offer themselves for re-election as a Director at the Annual General Meeting which coincides with their retirement.

Mr Povey is an accountant with public accounting experience with major accounting firms including Deloitte and KPMG. He has also lectured in both undergraduate and postgraduate business courses at Curtin University. Mr Povey subsequently established an accounting practice concentrating on taxation and company reporting. He has been the Company Secretary and an executive Director of the company since it was incorporated in September 2005.

Directors' recommendation:

Your Directors have reviewed the necessary competencies of the Board members and each candidate's contribution to the Board and, with Mr Povey abstaining, unanimously recommend Mr Povey's re-election.

Resolution 3 – Re-Election of Director

Dr Ewan E Smith

Pursuant to rule 11.12 of the Company's Constitution, where a person is appointed to fill a casual vacancy during the year they hold office only until the next Annual General Meeting of the Company and is then eligible for re-election as a Director at the Annual General Meeting.

Accordingly, Dr Ewan E Smith will retire in accordance with the requirements of the Company's Constitution at the Annual General Meeting. As he is entitled and is eligible for re-election, he seeks re-election as a director of the Company at the meeting.

Dr E E Smith B.Com (Man), BSC, MBBS was appointed a director of the company on 1 December, 2017. Mr Smith is a significant shareholder and has tertiary qualifications in commerce, science and medicine. He has operational experience in geophysics data acquisition, logistics and exploration activities and has the capability to make professional contributions to operational health and safety management.

Directors' recommendation:

Your Directors have reviewed the necessary competencies of the Board members and each candidate's contribution to the Board and, with Mr E Smith abstaining, unanimously recommend Mr Smith's re-election.

Resolutions 4 to 6 – Issue of Rights to the Executive Directors and Shares to the Non-Executive Director

Under Resolutions 4 to 6, the Company proposes to issue 5,929,000 Class G Performance Rights (**Class G Right**) to Peter N Smith and Michael J Povey and 1,484,000 fully paid ordinary shares (**Share**) to Ewan E Smith as follows:

On meeting the conditions of issue as disclosed in Annexure A, each Class G Right will convert to 1 fully paid ordinary share that will rank equally with all other ordinary shares then on issue.

The issue of the Class G Rights and the shares are to replace Directors' fees and superannuation payable as cash for the year ended 30 June 2018. The issue of Class G Rights and the shares encourages the Directors to have a greater involvement in the achievement of the Company's objectives and to provide an incentive to strive to that end by participating in the future growth and prosperity of the Company through the prospect of increased share ownership. The issue of Class G Rights and Shares in lieu of cash also greatly assists the company in retaining cash for working capital as well as for use in research and exploration activities without the need to go to the market to raise additional capital and with no capital raising costs, other than ASX listing fees. As outlined in Annexure A, these Class G Rights will only convert to ordinary shares in the event that the performance milestone is met before they expire. If the shareholders agree to the issue of these Class G Rights and the performance milestone is not met before the expiry date, the Class G Rights will expire and the Executive Directors would not have received any Directors' remuneration for the year ended 30 June 2018. The amounts of directors' fees and superannuation that the Class G Rights and shares replace are:

The number of Class G Rights to be issued to the Executive Directors has been based on the amount of remuneration foregone and the closing price of 1.6 cents for the Company's shares on 30 June 2018. Similarly the number of Shares to be issued to the Non-Executive director has been based on the amount of remuneration foregone and the closing price of 1.6 cents for the Company's shares on 30 June 2018. 5,929,000 Class G Rights for \$100,800 equates to 1.70 cents per Right and 1,484,000 shares for \$25,239 also equates to 1.7 cents per Share. This implies the directors are "paying" a premium of 6.3% by sacrificing their Directors' fees for the Class G Rights or Shares. Do also note that if the Class G Rights are approved and issued and the milestone is not reached in the 4 years to expiry, the Class G Rights lapse and the Executive Directors would not have received any amount for their 2017/18 Directors' fees. Included in the above table is the total deemed value of the rights if they were valued at 1.60 cents.

The full terms of the Class G Performance Rights can be found in Annexure A.

In accordance with listing rule 10.13, the following information is provided to shareholders:

- (1) The Class G Rights will be issued to Mr P N Smith and Mr M J Povey.
- (2) The Shares will be issued to Dr E E Smith.
- (3) The total number of Class G Rights to be issued is 5,929,000 and the total number of shares to be issued is 1,484,000. The break-down is as per the above Table 1.
- (4) The Class G Rights will be issued in accordance with the agreement of the executive directors to receive Class G Rights in lieu of cash for directors' fees and superannuation. The date the Class G Rights will be issued must be no later than 1 month after the date of this meeting. However, if the date of issue is later than 1 month after the date of the Annual General Meeting, an ASX waiver or modification will be sought prior to issue.
- (5) The Shares will be issued in accordance with the agreement of the non-executive director to receive the shares in lieu of cash for directors' fees and superannuation. The date the Shares will be issued must be no later than 1 month after the date of this meeting. However, if the date of issue is later than 1 month after the date of the Annual General Meeting, an ASX waiver or modification will be sought prior to issue.
- (6) Each Class G Right, once converted to one fully paid ordinary share, will rank pari passu with the Company's then issued shares.
- (7) Each Share once issued will rank pari passu with the Company's then issued shares.

- (8) No funds will be raised by the issue of the Class G Rights, but as stated above, there has been a saving of \$100,800 in the company's cash outflow resulting from the sacrifice of executive directors' fees and superannuation.
- (9) No funds will be raised by the issue of the Shares, but as stated above, there has been a saving of \$25,239 in the company's cash outflow resulting from the sacrifice of non-executive director's fees and superannuation.
- (10) The Class G Rights will be issued on one day and are expected to be issued no later than the day after the AGM.
- (11) The Shares will be issued on one day and are expected to be issued no later than the day after the AGM.

Further, the Company considers that it is in the interests of Shareholders to align the interest of the Directors and Shareholders by encouraging the Directors, subject to appropriate conditions, to have an equity holding in the Company. However the Company considers that similar to other Shareholders, this interest should arise through direct investment by the Directors.

In the event the issue of Class G Rights or Shares to the Directors is not approved at the AGM by the shareholders, the above amounts will be payable in cash as part of the normal remuneration of the Directors. If this occurs the directors have agreed to defer payment until the Company has the cash resources to be able to pay.

Resolutions 7 and 8 – Issue of Class H Performance Rights to the Executive Directors

Under Resolutions 7 and 8, the Company proposes to issue 5,929,000 Class H Performance Rights (**Class H Right**) to Peter N Smith and Michael J Povey as follows:

On meeting the conditions of issue as disclosed in Annexure B, each Class H Right will convert to 1 fully paid ordinary share that will rank equally with all other ordinary shares then on issue.

The Executive Directors have not received a director fee increase, nor a consulting rate increase for over 7 years. In addition, the Executive Directors, Peter N Smith and Michael J Povey have agreed to assist the Company by deferring payment, to them of consulting fees earned over the year ended 30 June 2018 for services rendered totalling \$116,100 (net of GST) and continuing to defer consulting fees earned over the previous three years totalling \$399,104, for a total of \$515,204 (net of GST) over the four years. These directors have not asked for any interest to be paid on these deferred amounts. This deferral is to last until the Company is in a position to make payment. These directors have further agreed to continue deferring part payment of their consulting fees under the same terms. In recognition of these sacrifices and the continuing support to the Company, the Shareholders are being asked to approve this issue of Class H Rights to these Directors. The issue of Class H Rights encourages the Directors to have a greater involvement in the achievement of the Company's objectives and to provide an incentive to strive to that end by participating in the future

growth and prosperity of the Company through the prospect of increased share ownership. As outlined in Annexure B, these Class H Rights will only convert to ordinary shares in the event that the performance milestone is met before they expire. If the shareholders agree to the issue of these Class H Rights and the performance milestone is not met before the expiry date, the Class H Rights will expire.

The full terms of the Class H Performance Rights can be found in Annexure B.

The number of Class H Rights to be issued to the Directors is considered reasonable. Based on the closing price of 1.60 cents for the Company's shares on 30 June 2018, these rights would have a deemed value of:

The date the Class H Rights will be issued must be no later than 1 month after the date of this meeting. However, if the date of issue is later than 1 month after the date of the Annual General Meeting, an ASX waiver or modification will be sought prior to issue.
- (4) Each Class H Right, once converted to one fully paid ordinary share, will rank pari passu with the Company's then issued shares.
- (5) No funds will be raised by the issue of the Class H Rights.
- (6) The Class H Rights will be issued on one day and are expected to be issued no later than the day after the AGM.

Further, the Company considers that it is in the interests of Shareholders to align the interest of the Directors and Shareholders by encouraging the Directors, subject to appropriate conditions, to have an increased equity holding in the Company. However the Company considers that similar to other Shareholders, this interest should arise through direct investment by the Directors.

Resolution 9 - Issue of Shares to sub-contractor for services rendered

Under Resolution 9 the Company seeks approval for the issue of 512,000 fully paid ordinary shares to Mark P Nelson.

Mr Nelson is a senior geologist who was contracted by the company to assist with its research and exploration programs. Mr Nelson agreed to accept part of his contract amount in fully paid ordinary shares as payment for his services. The amount of the contract to be satisfied

by the issue of these shares is \$12,800.

Subject to certain exceptions, none of which are relevant here, the Directors are restricted by Listing Rule 7.1 from issuing or agreeing to issue new securities in the Company in any 12 month period, which amount to more than 15% of the company's ordinary securities on issue without Shareholder approval (15% Limit Rule). Shareholder approval is being requested here for the issue of these shares so that the company has full access in the next 12 months to have the ability to issue up to 15% of the company's ordinary securities on issue without prior Shareholder approval (15% Limit Rule). In accordance with Listing Rule 7.3:

- The maximum number of shares to be issued is 512,000 fully paid ordinary shares;
- The shares will be issued on one day and are expected to be issued no later than the day after the AGM;
- The shares are being issued at 2.5 cents a share;
- The shares are being issued to Mark P Nelson;
- The shares will rank equally with all shares then on issue; and
- No funds are being raised from this issue, but there has been a saving in cash outflow of \$12,600.

Directors' recommendation:

All Directors were available to consider Resolution 9 – issue of shares:

Peter N Smith, Michael J Povey, and Ewan E Smith (who do not have an interest in Resolution 9) recommend to Shareholders that they vote in favour of Resolution 9 for the reasons outlined in this Explanatory Memorandum.

Corporations Act Requirements

Chapter 2E of the Corporations Act prohibits, subject to certain exceptions, a company from giving a financial benefit to a related party of the company without prior shareholder approval.

The Directors, Peter N Smith, Michael J Povey and Ewan E Smith (the parties to which Resolutions 4 to 8 relate), are considered "related parties" for this purpose, and the issue of Class G Rights and Class H Rights to P N Smith and M J Povey and the issue of Shares to E E Smith constitutes a "financial benefit" for this purpose.

The purpose of the Class G Rights and Share issues is to remunerate the specified Directors for past services, i.e. for the year ended 30 June 2018 for Directors' fees and superannuation. The Directors believe that the future success of the Company will depend in large measure on the skills and motivation of the people engaged in and overseeing the management of the Company's operations. It is therefore important that the Company is able to attract and retain people of the highest calibre.

The Directors considered that receiving the Class G Rights or Shares in lieu of directors' fees and superannuation conserved cash resources and allowed additional funds to be spent on research and exploration.

The purpose of the Class H Rights issue is to compensate the Executive Directors as they have not received a director fee increase, nor a consulting rate increase for over 7 years. In

addition, the Executive Directors, Peter N Smith and Michael J Povey have agreed to assist the Company by deferring payment to them of consulting fees earned over the year ended 30 June 2018 for services rendered totalling \$116,100 (net of GST) and continuing to defer consulting fees earned over the previous three years for services rendered totalling \$399,104 (net of GST), a total of \$515,204 (net of GST) over the four years. These directors have not asked for any interest to be paid on these deferred amounts. This deferral is to last until the Company is in a position to make payment. These directors have further agreed to continue deferring part payment of their consulting fees under the same terms. In recognition of these sacrifices and their continuing support to the Company, the Shareholders are being asked to

approve this issue of Class H Rights to these Directors. The issue of Class H Rights encourages these Directors to have a greater involvement in the achievement of the Company's objectives and to provide an incentive to strive to that end by participating in the future growth and prosperity of the Company through the prospect of increased share ownership.

The Class G and Class H Rights and the Share referred to in Resolutions 4 to 8 will be issued within one month of approval by the Shareholders. The full terms of the Class G and Class H Performance Rights can be found in Annexures A and B respectively.

In accordance with section 219 of the Act, the following information is provided to Shareholders to allow them to assess whether or not it is in the Company's interests to pass Resolutions 4 to 8:

- (a) The related parties to whom the proposed Resolutions would permit the financial benefits to be given are as follows:

The Directors, Peter N Smith, Michael J Povey and Ewan E Smith, are the related parties to whom the proposed Resolutions 4 to 8 would permit a financial benefit to be given. They are related parties of the Company by virtue of section 228 of the Corporations Act.

- (b) The nature of the financial benefit proposed to be given:

The nature of the financial benefit to be given to the related parties is the issue of Class G Rights or Shares in lieu of their directors' fees and superannuation for the year ended 30 June 2018, and the issue of Class H Rights in view of financial sacrifices made to the Company for the four years ended 30 June 2015 to 30 June 2018 and are still ongoing.

- (c) The combined number of Class G and Class H Rights or Shares to be issued to the Directors represents approximately 11.5% of the Company's share capital on issue immediately prior to the issue of the Rights or Shares. This is made up of: Mr P N Smith 5.85%; Mr M J Povey 4.39%; and Dr E E Smith 1.28%.

The consulting fees were payable either to the director or to entities associated with the respective directors. The directors' fees are the subject of resolutions 4 to 6 and have not yet been paid. If resolutions 4 to 6 are approved the Company will issue 5,959,000 Class G Performance Rights and 1,484,000 Fully Paid Ordinary Shares in lieu of the directors' fees and superannuation entitlements.

3,850,000 Class F Performance Rights were issued to the Executive Directors at the 2017 AGM in recognition of sacrifices made to the Company for the year ended 30 June 2017. The value of these Rights had not been included in the remuneration of the Executive Directors for

the year ended 30 June 2017. The value of the Class F Performance Rights was independently determined on the date of issue.

Class H Performance Rights

In order to further conserve cash, both Mr P N Smith and Mr M J Povey have not received any increases in executive director’s fees nor increases in consulting fee rates for over 7 years and also agreed to the postponement of part of their consulting fees until the company has the cash resources and the ability to pay. These directors have not asked for any interest to be paid on these deferred amounts. These directors have further agreed to continue deferring part payment of their consulting fees under the same terms. The amounts of deferred consulting fees for the year ended 30 June 2018 (net of GST) were: \$93,600 for Mr Smith and \$22,500 for Mr Povey for a total of \$116,100. The respective total amounts of deferred consulting fees for the years ended 30 June 2015 to 2017 (net of GST) were: \$327,364 and \$71,740 respectively for a combined total of \$399,104 for the three years. The total deferred amounts over the four years respectively is \$420,964 and \$94,240 for a combined total of \$515,204. Both the Class G and Class H Rights, plus the ordinary shares, are subject to shareholder approval under resolutions 4 to 8 and will only be issued once the approval has been received at the AGM. If such approval is not received for the Class G Rights and the Shares, the deferred Directors' fees totalling \$126,039 become payable in cash under the terms of their appointments. If there is no approval of the Class G Rights and the Shares the directors have agreed to defer payment until the Company has the cash resources to be able to pay.

Consultancy agreements

Remuneration and other terms of employment for Mr P N Smith and Mr M J Povey are formalised in consultancy agreements. Dr E E Smith's director's fees are covered in his letter of appointment. Each of the above agreements provide for directors' fees, superannuation and the provision of professional services. A summary of the agreements is as follows:

The term of each agreement was for 2 years commencing from 30 June 2011. If not renewed the agreements continue on a monthly basis.

Amounts payable were fixed for the 2 years. There has been no change in the rates since 30 June 2011.

The agreements may be terminated by giving 3 months' notice or the company paying 3 months consultancy fee in lieu of notice.

Upon termination of the agreement the consultant is not entitled to claim any compensation or damages from the Company in respect of the termination.
