TERMS AND CONDITIONS OF OPTIONS UNDER EIOP

The following is a summary of the key terms and conditions of the unlisted options:

(a) **Milestone**

2,400,000 Options will be issued to you, which will be exercisable upon satisfaction of the following milestones (**Milestone**):

- (i) 800,000 Options will vest and become exercisable, subject to you remaining employed by the Company, on the date which is 12 months after the date of issue of the Options;
- (ii) 800,000 Options will vest and become exercisable, subject to you remaining employed by the Company, on the date which is 24 months after the date of issue of the Options; and
- (iii) 800,000 Options will vest and become exercisable, subject to you remaining employed by the Company, on the date which is 36 months after the date of issue of the Options.

The Options will only vest if the applicable Milestone has been satisfied or has been waived by the Board.

(b) **Entitlement**

Each Option entitles the holder to subscribe for one fully paid ordinary share (**Share**) upon exercise of the Option (subject to the Option holder settling on a cashless basis (as set out below)).

(c) **Exercise Price**

Subject to paragraph (l), the amount payable upon exercise of each Option will be \$0.49 (**Exercise Price**), which is a 75% premium on the 5-day VWAP up to and including 13 February 2020.

(d) **Expiry Date**

Each Option will expire at 5:00 pm (AEDT) on 17 February 2024 (**Expiry Date**) which is four years after the anticipated date of issue. An Option not exercised before the Expiry Date will automatically lapse on the Expiry Date.

(e) **Exercise Period**

The exercise period for the Options (**Exercise Period**) will commence when the applicable Milestone has been satisfied and will end on the Expiry Date.

(f) **Notice of Exercise**

The Options may be exercised during the Exercise Period by notice in writing to the Company in the manner specified on the Option certificate (**Notice of Exercise**) and either payment of the Exercise Price for each Option being exercised in Australian currency by electronic funds transfer or other means of payment acceptable to the Company, or an election to use the Cashless Exercise Facility (as defined below) in respect of each Option being exercised.

(g) **Cashless Exercise Facility**

- (i) If the Shares of the Company are quoted on the ASX at the time of exercise of the Options, the holder of Options may, subject to paragraph (g)(ii) below, elect to pay the Exercise Price for an Option by setting off the exercise price against the number of Shares which they are entitled to receive upon exercise (**Cashless Exercise Facility**). By using the Cashless Exercise Facility, the holder will receive Shares to the value of the surplus after the Exercise Price has been set off.
- (ii) If the holder elects to use the Cashless Exercise Facility, the holder will only be issued that number of Shares (rounded down to the nearest whole number) as are equal in value to the difference between the total Exercise Price otherwise payable for the Options on the Options being exercised and the then market value of the Shares at the time of exercise (determined as the volume weighted average of the prices at which Shares were traded on the ASX over the last 20 trading days immediately prior to the date that the Company receives the notice of option exercise) calculated in accordance with the following formula:

(h) **Exercise Date**

A Notice of Exercise is only effective on and from the later of the date of receipt of the Notice of Exercise and the date of receipt of the payment of the Exercise Price for each Option being exercised in cleared funds (**Exercise Date**).

(i) **Notification to Holder**

The Company shall notify the Holder in writing when the Milestone has been satisfied.

(j) **Timing of issue of Shares on exercise**

Within five Business Days after the Exercise Date, the Company will:

- (i) issue the number of Shares required under these terms and conditions in respect of the number of Options specified in the Notice of Exercise and for which cleared funds have been received by the Company;
- (ii) if required, give ASX a notice that complies with section 708A(5)(e) of the Corporations Act, or, if the Company is unable to issue such a notice, lodge with ASIC a prospectus prepared in accordance with the Corporations Act and do all such things necessary to satisfy section 708A(11) of the Corporations Act to ensure that an offer for sale of the Shares does not require disclosure to investors; and
- (iii) if admitted to the official list of ASX at the time, apply for official quotation on ASX of Shares issued pursuant to the exercise of the Options.

If a notice delivered under (j)(ii) for any reason is not effective to ensure that an offer for sale of the Shares does not require disclosure to investors, the Company must, no later than 20 Business Days after becoming aware of such notice being ineffective, lodge with ASIC a prospectus prepared in accordance with the Corporations Act and do all such things necessary to satisfy section 708A(11) of the Corporations Act to ensure that an offer for sale of the Shares does not require disclosure to investors.

(k) **Shares issued on exercise**

Shares issued on exercise of the Options rank equally with the then issued shares of the Company.

(l) **Reconstruction of capital**

If at any time the issued capital of the Company is reconstructed, all rights of an Option holder are to be changed in a manner consistent with the Corporations Act and the ASX Listing Rules at the time of the reconstruction.

(m) **Participation in new issues**

There are no participation rights or entitlements inherent in the Options and holders will not be entitled to participate in new issues of capital offered to Shareholders during the currency of the Options without exercising the Options.

(n) **Change in exercise price**

An Option does not confer the right to a change in Exercise Price or a change in the number of underlying securities over which the Option can be exercised.

(o) **Transferability**

The Options are transferable subject to any restriction or escrow arrangements imposed by ASX or under applicable Australian securities laws.
