## Results of Tyranna Resources Limited Annual General Meeting

Resolution 5 and 8 were not passed as special resolutions with voting conducted by poll.


Resolution 1 - Adoption of Remuneration Report for the year ended 30 June 2019, which is a non-binding ordinary resolution, received a total of 32.03% votes cast against the resolution which constitutes a "first strike" for the purpose of the Corporation Act 2001.
