Magnum Mining and Exploration Limited ('Magnum' or 'the Company') is pleased to announce the conversion of 990 unsecured redeemable convertible notes ('Convertible Notes') to shares in the Company, at the conversion price of \$0.05 per share (20,000 shares per convertible note), pursuant to the Note Deed. The convertible notes were issued on 2 November 2018, at a face value of \$1,000 per convertible note. There will be a balance of 260 convertible notes on issue redeemable or convertible by 2 November 2019.

As a result, the Company has today issued 19,800,000 Ordinary Fully Paid shares in the Company which will rank equally with existing shares on issue. The Company welcomes a number of new shareholders onto the Magnum register and notes that they will also have an opportunity to participate in the Pro-rata Non-renounceable Entitlement Offer, as announced on 12 August 2019.
