### **COMPLETION OF PLACEMENT, CLEANSING NOTICE AND APPENDIX 2A**

New World Resources Limited (ASX:NWC) (“the Company”) advises that further to its announcement of 7 August 2020, it has now completed the placement of 129,629,630 ordinary shares (“Shares”) at an issue price of \$0.027 per Share (“the Placement”). The Placement was undertaken pursuant to the Company’s available capacity under Listing Rules 7.1 (31,053,602 Shares) and 7.1A (98,576,028 Shares).

#### **Cleansing Notice**

    - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - (B) the rights and liabilities attaching to fully paid ordinary shares.
