CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 15 July 2020 Carnaby Resources Limited (the **Company**) announced the placement of 1,838,000 fully paid ordinary shares in the Company to be issued pursuant to the Company's existing capacity under ASX Listing Rule 7.1 (the **Shares**).
