

CLEANSING NOTICE PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001

AuMEGA Metals Ltd (formerly Matador Mining Ltd) (**ASX: AAM | TSXV: AUM | OTCQB: AUMMF**) (“AuMEGA” or “the Company”) gives notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (“**Corporations Act**”).
