#### **COMPLETION OF APPLYFLOW BUSINESS SALE AND APPOINTMENT OF JOINT COMPANY SECRETARY**

Applyflow Limited (ACN 107 371 497) (ASX:AFW) (to be renamed FMR Resources Limited) (**Company**) is pleased to advise that the disposal of the Applyflow business through the sale of all of the issued capital of Applyflow International Pty Ltd completed today.

The disposal, as announced to ASX on 19 April 2024 and approved by shareholders on 23 May 2024, was undertaken by way of a management buy-out by an entity controlled by the Applyflow business acting CEO, Richard Swanton. Further details on the Applyflow business, the terms of the disposal and related matters are set out in the 19 April 2024 announcement.

In addition to the disposal, on 23 May 2024 shareholders also approved all other resolutions put to the general meeting in connection with the Company's proposed acquisition of the highly prospective Fairfield Copper and Fintry REE Projects in Canada and re-compliance listing on ASX.
