RLF Completes Acquisition of LiqaForce

RLF AgTech Ltd (RLF or the **Company**) (ASX: RLF) is pleased to announce that the Company has satisfied all conditions precedent and completed the acquisition of the LiqaForce assets (**LiqaForce** or the **Assets**), as announced on 2 May 2024.

Key Highlights:

- RLF has completed the acquisition of the business and certain assets of LiqaForce Pty Ltd.
- Upfront consideration of \$3m in cash and \$0.75m of RLF shares, with a deferred payment of \$0.75m in cash payable on or before 30 September 2024.
- The acquisition provides a solid platform for growth, immediately delivering increased Australian revenue and market growth opportunities in the Queensland region.

RLF is pleased to advise that the business integration process is advanced, including the streamlining of corporate and administrative functions, production processes, and supply chain optimisation. RLF will deploy additional working capital management facilities and credit structures, supporting the business to reach its growth potential.
