The Company only has two independent directors (John) Campbell Smyth and Peter Secker and therefore does not meet this requirement.

Only (John) Campbell Smyth and Peter Secker are considered to be independent and therefore the Company does not meet the requirements.

- (b) As noted above, the Company does not have a separate Audit and Risk Management Committee given the size of the Board and the fact the Board does not consider the Company would benefit from its establishment. The Board carries out the duties that would ordinarily be carried out by the Audit and Risk Management Committee including the following processes to oversee the entity's risk management framework. "Risk" is considered at each Board meeting whereby any changes in tenement title, operational safety or any changes to the general risk profile of the Company from prior period are noted by the Managing Director. The Board are encouraged to update and challenge the matters disclosed with respect to the Company's risk at and between each Board meeting and raise any material risks that they believe are not adequately dealt with.
