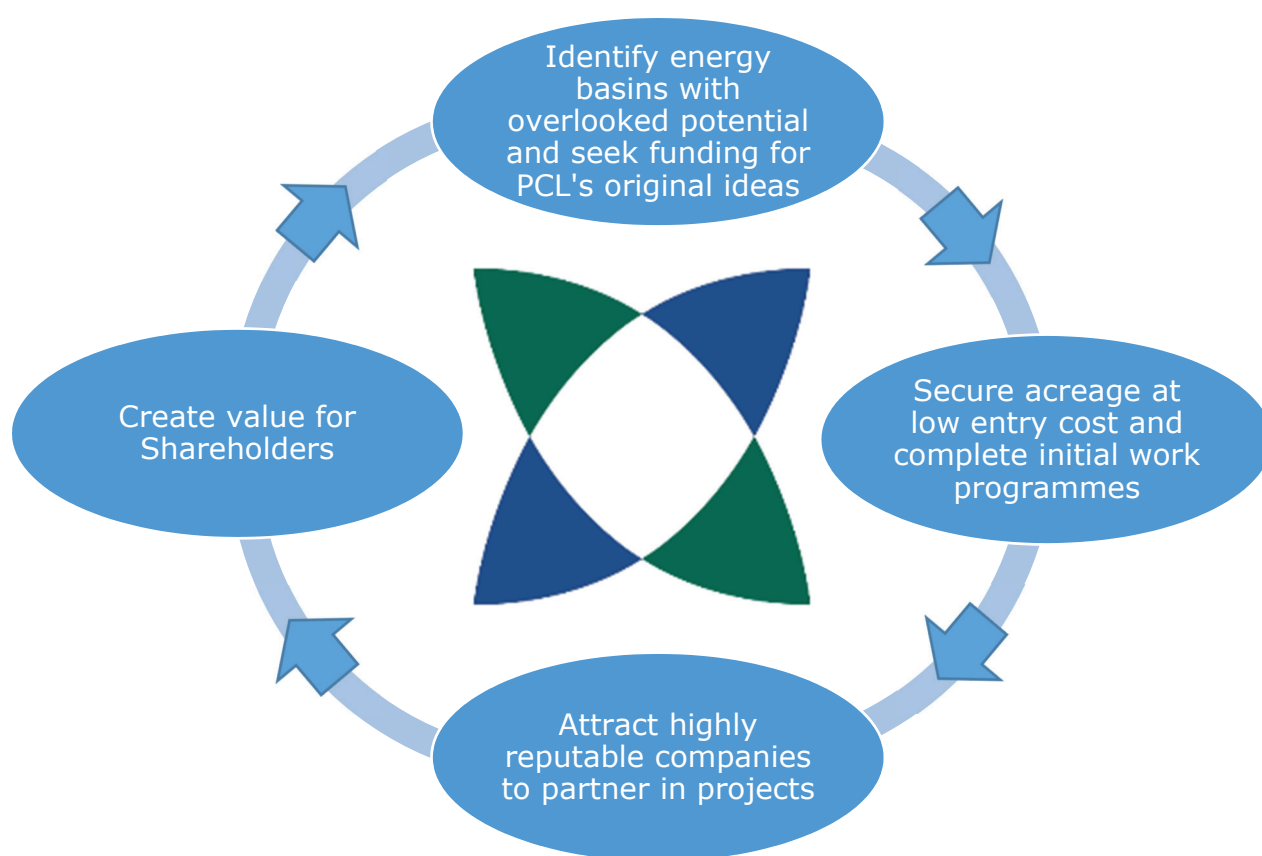
Who we are

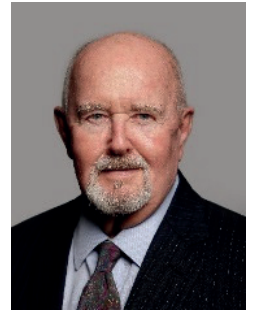




Dear Shareholder,

The Board of Directors of Pancontinental Energy NL is pleased to present to you the Company's 2022 Annual Report.

This has been an exciting year for Pancontinental due to the major oil discoveries offshore Namibia; firstly Shell with Graff-1 and secondly TotalEnergies with Venus-1X have focused industry attention on the Orange Basin, offshore Namibia. Both discoveries are on trend to Pancontinental's PEL 87 Orange Basin area.



TotalEnergies' Venus-1X discovery is similar geologically and in seismic character to our very large Saturn Turbidite Complex and this is of considerable interest within the industry. We believe that Pancontinental has positioned itself very favourably in this exciting new oil play.

Pancontinental continues with the farmout process on PEL 87 and is encouraged by the interest being shown by some major energy companies. The Orange Basin has become a focus for energy majors since the Shell and TotalEnergies discoveries.

We have taken the decision to discontinue with our endeavours on PEL 37 in the Walvis Basin, offshore Namibia, and focus on PEL 87. The end of the PEL 37 licence term was approaching and we had insufficient time left to do any meaningful exploration, in addition to not being able to come to an agreement with the remaining joint venture partner. Since entering the PEL 37 Block over 10 years ago, Pancontinental has attracted a joint venture partner and had 3D seismic and a well carried out.

The Cooper Basin Project, consisting of ATP 920 and the Ace Area of ATP 924, contains a number of prospects which are being reviewed for further exploration.

Post June year end Pancontinental carried out a well-supported capital raising of \$2 million before costs.

Pancontinental's track record of farmouts has been notable with a number of well-known international companies joining Pancontinental over the years and bringing capital investment into its projects. Examples include when Pancontinental was free carried in the Mbawa-1 well in Kenya. The well was a geological and historical success as it uncovered Kenya's first offshore hydrocarbon discovery with gas encountered. The Sunbird-1 well was another geological success not only for Pancontinental and the joint venture but for Kenya, as it was the second offshore hydrocarbon discovery and the first oil find. The management of the Company then is the management of the Company now and these historical finds show that Pancontinental has been and is capable of achieving great success for its shareholders. High impact projects do take time and effort to reap rewards however Pancontinental is confident of the quality of its Namibian project just as it was in Kenya.

I would like to thank the small, hardworking team at Pancontinental for their efforts and loyalty over the past year. The COVID restrictions made it difficult at times, particularly with travel, but hopefully the future will be trouble free.

Our loyal Shareholders, as always I also thank you for your support and patience and I am confident that there are exciting times ahead.

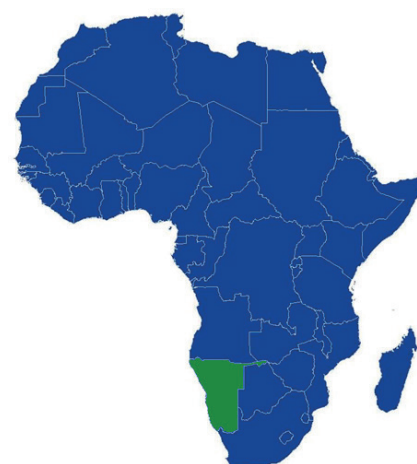

Petroleum Exploration Licence 87 over Block 2713 is located in the Orange Basin, offshore Namibia. The block is situated in water depths ranging from 500m to 3,200m and is 10,947 square kilometres in size. The PEL 87 joint venture which was founded in 2017, consists of Pancontinental with a 75% interest, local company Custos Investments (Pty) Ltd; 15% and the National Petroleum Corporation of Namibia holding 10%.

Pancontinental has been present in Namibia for over ten years. The Company as a partner in various joint ventures has completed numerous exploration programmes, including the drilling of the Cormorant-1 well in recent years. The country has been of great interest to the Company's technical team over this time, with their belief in the prospectivity of the region growing with each Namibian venture. Business dealings with the Ministry and local partners have always been carried out with professionalism which has made Pancontinental's 10+ year stay in the Namibian exploration industry a positive experience.

Technical work programmes over the years since the commencement of the licence have included the joint venture acquiring over 2,800 line kilometres of good quality 2D seismic as well as numerous other reports and studies. The Saturn Turbidite Fan complex ("Saturn") was discovered during these technical assessments. Saturn is about 280 metres thick and is almost wholly within PEL 87. It is located approximately 120 kilometres offshore. Modelling produced by the technical team has indicated high quality seals and independent closures. A number of leads are located within the vast 2,400km² Saturn structure which is of Aptian age and encased in sealing shales according to interpretation conducted by Pancontinental. Saturn covers a core area of more than 2,400 square kilometres with an overall area of about 4,000 square kilometres and holds significant oil potential.

There are four factors to consider when assessing the presence of an active petroleum system. These are; petroleum source rocks, reservoir rocks, seal and trap. The Company believes that the area covered by the PEL 87 licence exhibits characteristics which would indicate the presence of an active petroleum system. High quality Kudu Shale oil source can be inferred via seismic extension using data from nearby Moosehead-1 and other regional wells. Full Oil Maturity is confidently modelled at the Saturn location. Depositional characteristics have been used to infer good Reservoir quality and Saturn is likely to be sealed by the very critical slightly over pressured shale.

During the term of the licence, the joint venture is required to satisfy certain licence commitments. With the work carried out to date, the joint venture has completed a number of those requirements. In addition to external consultants, in house expertise is utilised to save on costs. In June 2022, Pancontinental and joint venture partners Custos and Namcor received an executed deed extending the Initial Exploration Period of PEL 87 by one year. The current Initial Exploration Period, as extended, can be followed by three additional two-year Periods, subject to certain conditions.

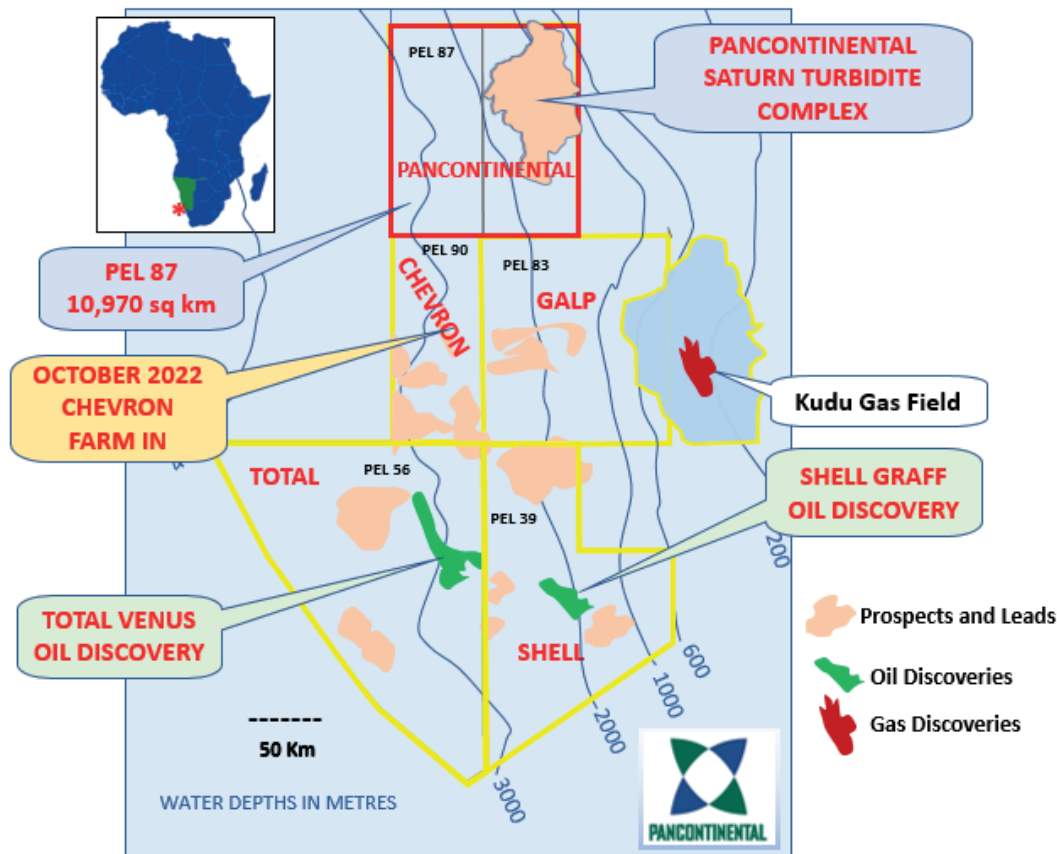


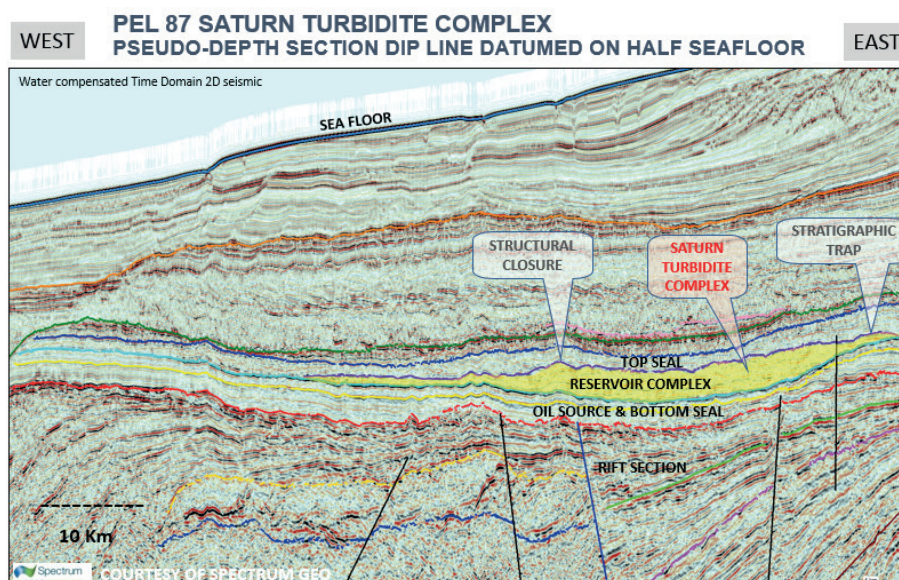
The Company has been working on securing a farminee to advance exploration on the PEL 87 licence. The farmout process is going well with interest from a number of international companies. Technical staff have provided access to the Company's project dataroom for interested parties. In the meantime additional exploration work continues to add value to the Project.

In early 2022, two major oil discoveries were announced offshore Namibia; firstly Shell with Graff-1 and secondly TotalEnergies with Venus-1X. The discoveries have focused industry attention on the Orange Basin. Both discoveries are on trend to Pancontinental's PEL 87 Orange Basin area and are located approximately 130km south. Pancontinental and its industry peers eagerly awaited the drilling, as the results are of utmost importance to explorers in the region and will provide valuable data. The Venus Prospect and the Saturn Turbidite complex overlie the same high-quality mature Oil Source Rock, and both lie immediately below the major Regional Seal. Pancontinental's Saturn play is very large and very similar geologically to TotalEnergies' Venus Prospect, however is located in shallower water. Even though the Graff Prospect is geologically shallower than both Venus and Saturn, the success of the Graff-1 well is extremely meaningful. Both of these wells drilled offshore Namibia have received worldwide recognition as two of the most important oil exploration wells to be drilled this year.

Pancontinental is pleased to have successfully positioned itself with a significant 75% interest in a very large licence area in this prime exploration hotspot, together with the very large Saturn turbidite complex that has already been mapped at the same level as Total's Venus oil discovery. The Company looks forward to the future for the PEL 87 licence and what can be achieved through farmout and upcoming exploration programme results.

Namibia Offshore PEL 37

[Post financial year end - Application for an extension process withdrawn]

Pancontinental was a founding partner in the PEL 37 Joint Venture in 2011. Since that time, the joint venture completed a number of work programmes. The Company also successfully negotiated the entry of joint venture partners for carried exploration work.

The last of the licence commitments prior to expiry was the drilling of the Cormorant-1 well in 2018. The joint venture then secured an additional year's extension from the Ministry of Mines and Energy in Namibia.

Following the withdrawal of Tullow, Pancontinental, on behalf of the joint venture, made an application for a one year extension of the licence to enable an assessment of the prospectivity of the Block and also to seek a farminee. The Company has not been able to reach agreement with the remaining joint venture partner on a way forward and time was running out to do any meaningful work.

Post year end, on 9 September 2022, Pancontinental Energy's 66.67% owned subsidiary; Pancontinental Namibia announced its intention to withdraw from the process of seeking an extension to the original PEL 37 Licence offshore Namibia.

Pancontinental farmed into the Meeba Project, Cooper Basin, Onshore Queensland during 2019. COVID-19 as well as a number of natural disasters in the Eastern States have set back the planned activities on the Authorities to Prospect for operator Key Petroleum Limited ("Key") and the joint venture.

During the financial year, an application was made by Key on behalf of the joint venture to DNRME for Project Status which was duly approved. Project Status allows the joint venture to transfer commitments between the Authorities to Prospect, enabling the joint venture to focus its efforts on the most prospective areas. A detailed review of the projects is being conducted to determine the focus areas for future exploration.

New Ventures

The Company is continually searching for, and evaluating new ventures that could be pursued to complement the Company's existing portfolio of exploration assets. The Company is mindful that any new venture must be the right fit and add value for its Shareholders. Many factors are considered when assessing any new project. Not only does the Company assess the prospectivity of the area and how it could bring returns for its Shareholders, it also looks at the risks involved in the project. Environmental, social and governance risks play an important role in the assessment of each new venture. The impact of the project on climate change is an important factor and with this in mind, Pancontinental is carefully assessing projects to select the most suitable for the Company.

Corporate

Fundraising

During the financial year, the Company completed a bookbuild to raise \$1.0 million through the placement of 1,037,507,325 shares at an issue price of \$0.001 per share to sophisticated and professional investors. \$917k for the issue of 917,507,325 shares was received and shares duly granted. The remaining 120,000,000 shares were subject to shareholder approval at the General Meeting held on 21 October 2021. Resolutions for the ratification of the placement and Directors' contributions to the placement of \$120,000 (120,000,000 shares) were put forward to the meeting and passed on a poll with an approval percentage above 96%.

General Meeting

During the March 2021 quarter, the Company raised \$710,000 via a Placement of 710,000,000 shares at \$0.001. The shares were issued to sophisticated and professional investors as well as Directors. A General Meeting of shareholders was conducted on 29 July 2021. Resolutions put to the meeting covered the placement and Director participation as well as the name change to Pancontinental Energy NL. All of the resolutions were passed on a poll with an approval percentage above 97%.

Annual General Meeting

Pancontinental's Annual General Meeting of shareholders was held on 29 November 2021. All resolutions put to the meeting; the remuneration report, re-election of directors and amendment of the constitution were passed on a poll with an approval percentage above 95%.

Non-Executive Director Resignation

In February 2022, Ms Marie Malaxos resigned from the position of Non-Executive Director. Ms Malaxos has been a valuable member of the board since her appointment in 2017 and the Company is grateful for her contribution and wishes her well in her future endeavours.

Cost Cutting

The Company is continuing with cost cutting measures brought in at the commencement of the COVID-19 pandemic. All possible discretionary costs have been reduced or eliminated and the Company is running on a very cost effective model.



COVID-19

There were no direct material impacts of COVID-19 on the Financial Statements for the year ended 30 June 2022 and the Directors consider that the going concern basis for the Consolidated Entity is still appropriate.

Pancontinental continues to align its work practices with the recommendations of the World Health Organisation as well as State and Federal Department of Health's requirements. The Company continues to monitor global activity and take the advice of relevant government and global agencies.

Pancontinental has set as its priorities the health and safety of its Staff and Directors as well as the conservation of its asset base and the continuation of its project activity.

At the commencement of the COVID-19 pandemic, the Company acted swiftly with a number of key responses, such as significant fee and salary reductions for Directors and Staff and a detailed budgetary review to lower all discretionary expenditure. This included moving the Company's head office to much smaller premises as sub tenants where the three staff members share an office. These measures proved to be effective with over \$700,000 in cost savings over the financial years since the pandemic commenced. In addition, Pancontinental has followed regulatory requirements concerning physical interactions in its workplace and the Company has eliminated all non-essential travel for its personnel. Personnel are still encouraged to take advantage of digital communications and flexible work locations whenever possible.

Climate Change

Pancontinental is mindful of the developing and continued interest of stakeholders in climate change issues. Climate risk has evolved to become an important consideration in investment and corporate strategic decisions. It is now widely recognised as a critical risk to business, industry and capital markets. So much so, that the guidance recommends that listed companies consider disclosing climate change risk separately to other general risk categories, which is what Pancontinental has adopted (please see Directors' Report for detailed discussion on risk and climate change).

The G20 Financial Stability Board established the Task Force on Climate-related Financial Disclosures ("TCFD") which is an industry-led task force that has published recommendations for financial report preparers to assist in providing investors the most relevant climate change disclosures. The Company has utilised the publication as well as other recommended publications as a guide in providing our stakeholders with the appropriate information in this regard which can be found in the Directors' Report.

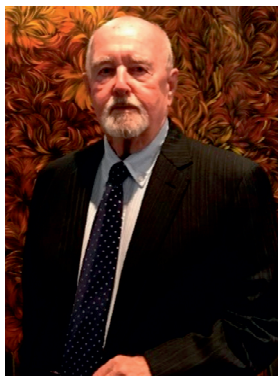

Names, qualifications, experience and special responsibilities



Henry David Kennedy MA (Geology), SEG (Non-Executive Chairman)

Mr Kennedy is a Geologist with a long history in Australian and New Zealand oil and gas companies. During his time as a Technical Director he was instrumental in the formation and development of a number of successful listed companies. These companies were involved in numerous discoveries in Western Australia and New Zealand. At Pancontinental, Mr Kennedy has used his wide knowledge base to assist with the strategic direction of the Company. Mr Kennedy has been a Director of Pancontinental since August 1999.

Mr Kennedy retired as a Non-Executive Director of Norwest Energy NL in March 2020. (Director since April 1997).



Ernest Anthony Myers CPA (CEO & Executive Director)

Mr Myers, an Accountant by profession, has held senior management and executive roles within a number of ASX listed companies. During his career he has been instrumental in the capital raisings and financial management of these companies. He has played a key role in managing the Group's African portfolio. Mr Myers joined Pancontinental in March 2004, was appointed Executive Director in January 2009 and Chief Executive Officer in November 2018.

Mr Myers is currently also Non-Executive Chairman of Norwest Energy NL (since November 2018).



Roy Barry Rushworth, BSc (Executive Director - Technical)

Mr Rushworth is a Geologist who brings extensive experience in petroleum exploration to the Company. Mrs Petrovic is an Accountant who holds a Bachelor of Commerce, Major in Accounting and Business Law and has completed the Graduate Diploma in Applied Corporate Governance from the Governance Institute of Australia.

Roles in accounting and finance of numerous publicly listed entities, particularly those involved in Africa have provided Mrs Petrovic a base from which to contribute to the accounting and governance functions at Pancontinental.

Mrs Petrovic was appointed Company Secretary in April 2010, Executive Director in December 2016, Alternate for Mr Kennedy in July 2017 and reappointed Executive Director in September 2018.

CORPORATE INFORMATION

Corporate structure

Pancontinental Energy NL (ACN 003 029 543) is a no liability Company incorporated and domiciled in Australia. The Company's registered office is Level 2, 30 Richardson Street, West Perth WA 6005.

Nature of operations and principal activities

The principal activity during the year of Entities within the Consolidated Entity was exploration for energy sources.

Business drivers are the key inputs and activities that drive the operational and financial results of a business. For a Company in the exploration stage, business drivers include the management of working capital and sensible capital investment decisions as well as technical excellence in sourcing, assessing and providing guidance for projects which will create value for the Entity and its Shareholders.

There have been no significant changes in the nature of those activities during the year.

Objectives

Objectives of the Group include:

- Continue exploration on the Company's current portfolio of permits;
- Extract value from the Company's asset base;
- Seek new ventures suitable for inclusion in the Group's asset structure;
- Manage risks involved in the exploration industry; and
- Maintain liquidity.

The Group's targets and strategies for meeting the above objectives include:

- Approve work programmes best suited for exploration success which are within the Company's financial capacity;
- Consider strategic alliances through joint ventures to minimise risks to the Group;
- Focus on cost cutting in all non-essential areas; and
- Review appropriate fundraising proposals.

The result from the financial year ended 30 June 2021 was a loss of \$788,165. The current financial year also produced a loss, at \$823,179. While the Company has always operated on a low cost and overhead model, the recent situation internationally has affected businesses across every industry albeit some more than others. The Company has responded by working carefully to decrease each and every discretionary and non-essential expenditure item as well as seeking reductions for essential expenditure.

Employees

The Consolidated Entity had three (3) Employees as at 30 June 2022, (2021: three (3)). The Consolidated Entity employs the services of specialised consultants where and when needed.

OPERATING AND FINANCIAL REVIEW

Projects

Namibia PEL 87 – Offshore [75% interest]

The PEL 87 joint venture consists of Pancontinental with a 75% interest, local company Custos Investments (Pty) Ltd; 15% and the National Petroleum Corporation of Namibia holding 10%.

Over the years since the commencement of the licence, the joint venture has acquired over 2,800 line kms of good quality 2D seismic as well as numerous other reports and studies. This technical data has assisted the joint venture in identifying a number of leads within a vast, 2,400km² Turbidite Fan complex ("Saturn") of Aptian Age that, based on Pancontinental's interpretation is encased in sealing shales. The Saturn Turbidite Fan complex covers a core area of more than 2,400 square kilometres with an overall area of about 4,000 square kilometres and holds significant oil potential.



The exploration programme completed so far has indicated findings that would support the presence of an active petroleum system within the PEL 87 licence. Using data from nearby Moosehead-1 and other regional wells, high quality Kudu Shale oil source can be inferred via seismic extension. Full Oil Maturity is confidently modelled at the Saturn location. Depositional characteristics have been used to infer good Reservoir quality and Saturn is likely to be sealed by the very critical slightly overpressured shale. These are the four components of an active petroleum system; petroleum source rocks, reservoir rocks, seal and trap. The PEL 87 licence has a number of conditions which are to be satisfied within the licence timeframe and the joint venture has completed a number of requirements.

Pancontinental is seeking a farminee to advance exploration on the PEL 87 Block. The farmout process is ongoing and in the meantime additional work is being undertaken to add value to the Project.

During the financial year, Pancontinental and joint venture partners Custos and Namcor received an executed deed extending the Initial Exploration Period of PEL 87 by one year. The current Initial Exploration Period, as extended, can be followed by three additional two-year Periods, subject to certain conditions.

In early 2022, two major oil discoveries were announced offshore Namibia; firstly Shell with Graff-1 and secondly TotalEnergies with Venus-1X. The discoveries have focused industry attention on the Orange Basin. Both discoveries are on trend to Pancontinental's PEL 87 Orange Basin area and are located approximately 130km south. Pancontinental and its industry peers have been eagerly awaiting the drilling, as the results will be of utmost importance to explorers in the region and will provide valuable data. The Venus Prospect and the Saturn Turbidite complex overlie the same high-quality mature Oil Source Rock, and both lie immediately below the major Regional Seal. Pancontinental's Saturn play is very large and very similar geologically to TotalEnergies' Venus Prospect, however is located in shallower water. Even though the Graff Prospect is geologically shallower than both Venus and Saturn, the success of the Graff-1 well is extremely meaningful. Both of these wells drilled offshore Namibia have received worldwide recognition as two of the most important oil exploration wells to be drilled this year.

Pancontinental has had a long relationship with Namibia and has been present in country for over a decade. The Company strongly believes in the prospectivity of the region and has completed numerous exploration programmes, including the drilling of the Cormorant-1 well in recent years. Also during that time, Pancontinental has built up a database of information which indicates the prospectivity of offshore Namibia. Pancontinental's theories have been validated by the two high profile discoveries made by Shell and TotalEnergies with their Graff-1 and Venus-1X wells respectively.

Namibia PEL 37 – Offshore [Post financial year end - Application for an extension process withdrawn. New licence to be applied for]

Pancontinental was a founding partner in the PEL 37 Joint Venture in 2011. Since that time, the joint venture has completed a number of work programmes. The Company has also successfully negotiated the entry of joint venture partners for carried exploration work.

The last of the licence commitments prior to expiry was the drilling of the Cormorant-1 well in 2018. The joint venture then secured an additional year's extension from the Ministry of Mines and Energy.

Following the withdrawal of Tullow, Pancontinental, on behalf of the joint venture, made an application for a one year extension of the licence to enable an assessment of the prospectivity of the Block and also to seek a farminee. The Company has not been able to reach agreement with the remaining joint venture partner on a way forward and the application for an extension would not be considered by the Ministry until the partners were in alignment.

Post year end on 9 September 2022, Pancontinental Energy's 66.67% owned subsidiary, Pancontinental Namibia announced its intention to withdraw from the process of seeking an extension to the original PEL 37 Licence offshore Namibia. As the Company has not been able to reach agreement with its joint venture partner Pancontinental will apply for a new longer term licence.

Queensland Australia ATP 920 & 924 [20-25% earning interest]

Pancontinental farmed into the Meeba Project, Cooper Basin, Onshore Queensland during 2019. COVID-19 as well as a number of natural disasters in the Eastern States have set back the planned activities on the Authorities to Prospect for operator Key Petroleum Limited ("Key") and the joint venture.

During the financial year, an application was made by Key on behalf of the joint venture to DNRME for Project Status which was duly approved. Project Status allows the joint venture to transfer commitments between the

Authorities to Prospect, enabling the joint venture to focus its efforts on the most prospective areas. A detailed review of the projects is being conducted to determine the focus areas for future exploration.

Corporate

Fundraising

During the financial year, the Company completed a bookbuild to raise \$1.0 million through the placement of 1,037,507,325 shares at an issue price of \$0.001 per share to sophisticated and professional investors. \$917k for the issue of 917,507,325 shares was received and shares duly granted. The remaining 120,000,000 shares were subject to shareholder approval at the General Meeting held on 21 October 2021. Resolutions for the ratification of the placement and Directors' contributions to the placement of \$120,000 (120,000,000 shares) were put forward to the meeting and passed on a poll with an approval percentage above 96%.

General Meeting

During the March 2021 quarter, the Company raised \$710,000 via a Placement of 710,000,000 shares at \$0.001. The shares were issued to sophisticated and professional investors as well as Directors. A General Meeting of shareholders was conducted on 29 July 2021. Resolutions put to the meeting covered the placement and Director participation as well as the name change to Pancontinental Energy NL. All of the resolutions were passed on a poll with an approval percentage above 97%.

Annual General Meeting

Pancontinental's Annual General Meeting of shareholders was held on 29 November 2021. All resolutions put to the meeting; the remuneration report, re-election of directors and amendment of the constitution were passed on a poll with an approval percentage above 95%.

Non-Executive Director Resignation

In February 2022, Ms Marie Malaxos resigned from the position of Non-Executive Director. Ms Malaxos has been a valuable member of the board since her appointment in 2017 and the Company is grateful for her contribution and wishes her well in her future endeavours.

Cost Cutting

The Company is continuing with cost cutting measures brought in at the commencement of the COVID-19 pandemic. All possible discretionary costs have been reduced or eliminated and the Company is running on a very cost effective model.

New Ventures

Pancontinental has for some time expressed its interest in seeking new projects which will add value for shareholders and expand the asset base.

Group Overview

Pancontinental Energy NL was incorporated in 1985 and listed on the Australian Securities Exchange in 1986.

The Pancontinental Group is comprised of the Parent Company along with three subsidiary companies.

Dynamics of the Business

The Company is continually working on development of its existing projects and evaluates emerging opportunities as they become available. While the Company's main focus has been in Africa, the technical team is open to jurisdictions outside of Africa if they are compatible with the strengths of the team at Pancontinental.



Performance Indicators

The Board closely monitors and discusses the Group's operating plans, financial budget and overall performance as well as the Company's share price on a regular basis.

The underlying drivers which contribute to the Company's performance and that can be managed internally include a disciplined approach to reducing the Group's non-essential costs and allocating funds to those areas which will add shareholder value. The Company's share price is used as a performance indicator however, the share price is not entirely indicative of a Company's performance and can be influenced by factors outside the control of Management and the Board such as market conditions.

Risk Management

Risk management at Pancontinental begins with the Board who delegate authority throughout the organisation. The Board monitors, identifies, analyses and responds to any risks that will impact the Company in realising its strategic direction as well as potential risks that are perhaps not expected, but could cause a disruption.

Risk management is a day to day part of the business which is considered in all decision making. Project management, financial planning, corporate actions, strategic partnerships, conducting business abroad and the like. The process of identifying and analysing risk factors includes both quantitative and qualitative factors. The Board is responsible for ensuring that risks and opportunities are identified on a timely basis and that the Group's objectives and activities are able to continue without disturbance.

The Group believes that it is crucial for all Board members to be a part of this process and as such the Board has not established a separate Risk Management Committee. The Board has identified business risks specific to Pancontinental and the industry it operates in. These include:

Operating Risks

- **Health and Safety** – The safety and health of the people at Pancontinental is paramount. The physical and mental wellbeing of its Directors and Employees is crucial to the Company achieving success. For example, during the recent COVID-19 pandemic, the Company protected its workers while continuing business operations by adhering to recommended guidelines to prevent the spread of the virus including restricted travel, alternative office access options, provision of hygiene consumables and social distancing.
- **Joint Venture Operators** - Currently some of Pancontinental's assets are managed by Joint Venture Operators who are responsible for the day to day operation of the permits. As such, regular review of Joint Venture activities is crucial in safeguarding the assets of the Company. Attendance at joint venture meetings is important to keep abreast of any emerging risks that could impact the Company due to its joint venture activities.
- **Foreign Jurisdictions** - Conducting business in foreign jurisdictions carries with it a risk of change in business, legal, tax, accounting, political, environmental and technical practices which may have a material effect on the Company.
- **Loss of Key Data** – Pancontinental has a tried and tested backup system of all its data. The Company is confident that no unauthorised access could compromise key data. However, there is still a level of risk involved due to cyber-attacks or outages. If there was a violation it could cause serious business interruption such as loss of data, damage to the data system and privacy breaches. In recent years, the Company moved to a cloud based system which provides for ease of remote access for Staff and faster recovery in the event of an attack or outage.

Financial Risks

- **Access to Funding** – In the past, Pancontinental has funded its operations by several means; funds received from the divestment of project areas, investment partner expenditure on the Company's behalf (carried expenditure) and equity markets. Volatility in capital markets or the exploration industry could limit the Company's access to future funding. Pancontinental has successfully reached out to the equity market this year, with broker support and without issue. The Company has maintained a long and successful relationship with the broking house who has supported the majority of funds raised this year. The Company continues to seek partnering opportunities such as those negotiated in the past which have allowed the Company to participate in multi-million dollar exploration programs such as drilling exploration wells in Kenya and Namibia.
- **Market Prices** - Oil and gas price volatility as well as currency fluctuations in Australian and United States dollars. Commodity prices and foreign exchange rates are subject to global economic forces. Although the Company is not in production and there is not a material business risk in that regard, the Company's operations are affected due to exploration budgets and overall activity in the exploration sector.



Strategic Risks

- **Climate Change Risk** - Certain research has shown that the global climate is changing and may continue to change. Extreme weather events such as flooding and drought are thought to be increasing in severity and frequency. As such, this affects the planning and day to day running of businesses and industry. Pancontinental will consider climate change risk in its everyday business decisions and how it can adapt to changing conditions believed to be caused by climate change. Governments, regulators, lenders and investors are becoming more and more interested in how companies are managing the impacts of climate change. Pancontinental may be impacted by increased regulation and costs associated with climate change. Climate change risk is discussed in detail in the following section.
- **Extraordinary Events** - Extraordinary events such as the COVID-19 pandemic. The Company may be affected by future events similar to those experienced during the COVID-19 pandemic which affected lives and businesses worldwide. The Company must be prepared to again act quickly should a similar situation arise.
- **Regulatory Change** - Pancontinental's operations and finances may be affected by a changes to government policy, regulations or legislation. Unexpected changes may impact longer term projects and their viability to provide returns for shareholders.
- **Social Risks** - Social exposures may include; diversity and inclusion and health and safety. Pancontinental has consistently exceeded the industry average for diversity.

The Group has advised each Director, Employee and Consultant that they must comply with a set of ethical standards maintaining appropriate core Company values and objectives. Such standards ensure shareholder value is delivered and maintained. Standards cover legal compliance, conflict resolution, privileged information and fair dealing.

The Board provides Shareholders with information using a Continuous Disclosure Policy which includes identifying matters which have a material effect on the underlying security price. ASX announcements, the web page of the Company and other media resources are used to convey such information. The Board encourages full participation by Shareholders at the Annual General Meeting and Shareholders are requested to vote on Board and Executive remuneration aggregates as well as Employee Incentive Schemes.

The Company's Board prevents the occurrence of risks by undertaking regular reviews of the Group's business practices to identify potential risks. Techniques used for identifying risks include:

- Evaluating each function of the business and identifying anything that could have a negative impact on the Group's operations;
- Reviewing records to identify previous issues that could have a current impact;
- Considering any external risks that could affect the Group; and
- Consulting with Employees and independent contractors as well as auditors to identify risks and in turn implementing risk prevention measures.

Once potential risks have been identified, managing risks involves developing cost effective options on how to best to deal with the risks. Risks can be:

- **Avoided** - by changing business processes or equipment to achieve a similar outcome with less risk;
- **Reduced** - if a risk can't be avoided the Group can reduce its likelihood and consequence. This could include Staff training, documenting procedures and policies, complying with legislation, maintaining equipment, practicing emergency procedures, keeping records safely secured and contingency planning;
- **Transferred** - transfer some or all of the risk to another party through contracting, insurance, partnerships or joint ventures; and
- **Accepted** - this may be the only option.

The continued monitoring of risk within the Group is directed at evaluating:

- The effectiveness and efficiency of operations;
- The reliability of financial and management internal processes and reporting; and
- Compliance with laws and regulations

to enable the Group to safeguard its assets.



Climate Change

Pancontinental is mindful of the developing and continued interest of stakeholders in climate change issues. Climate risk has evolved to become an important consideration in investment and corporate strategic decisions. It is now widely recognised as a critical risk to business, industry and capital markets. So much so, that the guidance recommends that listed companies consider disclosing climate change risk separately to other general risk categories, which is what Pancontinental has adopted.

The G20 Financial Stability Board established the Task Force on Climate-related Financial Disclosures ("TCFD") which is an industry-led task force that has published recommendations for financial report preparers to assist in providing investors the most relevant climate change disclosures. The Company has utilised the publication as a guide in providing our stakeholders with the appropriate information in this regard.

The TCFD structured its recommendations around four thematic areas that represent core elements of how organisations operate: governance, strategy, risk management and metrics and targets. The four recommendations are supported by recommended disclosures that build out the framework that will help investors and others understand how the reporting organisation has assessed climate-related risks and opportunities.

The voluntary disclosure recommendations issued by the TCFD are specifically designed to help companies produce information that is useful for investors (among others).

Climate change risk, as defined by the TCFD falls into two main categories; risks related to the transition to a lower-carbon economy and risks related to the physical impacts of climate change:

1. Transition risks – transitioning to a lower-carbon economy may entail extensive policy, legal, technology and market changes to address mitigation and adaption requirements related to climate change.

2. Physical risks – physical risks resulting from climate change can be acute or chronic. Acute physical risks refer to those that are event-driven, including increased severity of extreme weather events, such as cyclones or floods. Chronic physical risks refer to longer-term shifts in climate patterns.

In addition to risks, climate change can also bring about opportunities. Companies will need to consider that with any change, opportunities can arise.

Pancontinental will continue to use the recommendations of the TCFD as a reference for climate change related disclosures which we expect to continue to evolve over the coming years.

During the year, to provide the market with high-quality training on climate disclosure and provide an overview of the Task Force on Climate-related Financial Disclosures (TCFD) recommendations, ASX collaborated with the UN Sustainable Stock Exchanges, the International Finance Corporation and CDP. The programme provides a multifaceted, CPD-certified course for issuers and other key stakeholders which was a very helpful resource for the employees at Pancontinental.

The first session, TCFD 101, provides an overview of what climate-related reporting is and why it is important. It also provides participants with the global and regional context and focus on the initial steps on how to address the TCFD recommendations.

The second session, TCFD 102, provides an in-depth programme during which participants peer-review each other's TCFD reports and wider good practice. For markets with no or very little reporting on TCFD, the course focuses on setting up internal processes for reporting and potential first areas to get started on.



COVID-19

There were no direct material impacts of COVID-19 on the Financial Statements for the year ended 30 June 2022 and the Directors consider that the going concern basis for the Consolidated Entity is still appropriate.

Pancontinental continues to align its work practices with the recommendations of the World Health Organisation as well as State and Federal Department of Health's requirements. The Company continues to monitor global activity and take the advice of relevant government and global agencies.

Pancontinental has set as its priorities the health and safety of its Staff and Directors as well as the conservation of its asset base and the continuation of its project activity.

At the commencement of the COVID-19 pandemic, the Company acted swiftly with a number of key responses, such as significant fee and salary reductions for Directors and Staff and a detailed budgetary review to lower all discretionary expenditure. This included moving the Company's head office to much smaller premises as sub tenants where the three staff members share an office. These measures proved to be effective with over \$700,000 in cost savings over the financial years since the pandemic commenced. In addition, Pancontinental has followed regulatory requirements concerning physical interactions in its workplace and the Company has eliminated all non-essential travel for its personnel. Personnel are still encouraged to take advantage of digital communications and flexible work locations whenever possible.

Investments for Future Performance

The Board is continually assessing the Company's assets and considering how it could position itself to execute its growth strategy which is aimed at enhancing shareholder value while utilising the expertise and experience of its Board and personnel.

Treasury Policy

The Board has not considered it necessary to establish a separate treasury function because of the size and scope of the Group's activities.

Liquidity and Funding

During the financial year, the Company issued 917,507,325 shares grossing \$917,507 and conducted a further issue of 230,000,000 shares to Directors upon approval by Shareholders in General Meeting.

Post year end, Pancontinental completed a bookbuild to raise \$2 million before costs through a Placement of 400,000,000 shares at an issue price of \$0.005 per share to sophisticated and professional investors. The Placement received strong support from existing and new sophisticated and professional investors.



SHARE OPTIONS

Unissued shares

As at 30 June 2022, there were 78,926,830 ordinary shares under options exercisable at \$0.006. These options expired post year end. Refer to the notes for further details on the options outstanding. All options were granted in previous financial years.

During the financial year, 72,500,000 unlisted options, exercisable at \$0.006 each expired and 118,390,245 unlisted options, exercisable at \$0.006 each were cancelled.

199,999,998 listed options exercisable at \$0.012 each and an expiry date three years from issue were issued after financial year end. The options were free attaching options issued under a prospectus to participants in the August 2021 placement which was concluded during the financial year. In addition, 100,000,000 broker options were also issued under the same conditions.

Shares issued as a result of the exercise of Options

There were no shares issued as a result of the exercise of options during the financial year.

SIGNIFICANT CHANGES IN THE STATE OF AFFAIRS

No significant changes in the state of affairs of the Company occurred during the financial year.

SIGNIFICANT EVENTS AFTER THE BALANCE DATE

8 July 2022

The Company advised that it had completed a bookbuild to raise \$2 million before costs through a placement of up to 400,000,000 shares at an issue price of \$0.005 per share to sophisticated and professional investors. Investors in the placement were offered one free attaching option for every two placement shares issued (with the options exercisable at \$0.012 each and an expiry date three years from issue). In addition, the Lead Manager would receive 100 million broker options.

18 July 2022

Pancontinental issued the above mentioned 400,000,000 ordinary shares at an issue price of \$0.005 per share which raised \$2 million before costs.

25 July 2022

The Company advised that 78,926,830 unlisted options, exercisable at \$0.006 each expired and that the Company does not have any further options on issue.

29 July 2022

An option prospectus was lodged with the ASX for the free attaching options to the placement announced in July 2022.

8 August 2022

299,999,998 listed options were issued. This number was updated from 300,000,000 due to rounding. 199,999,998 for the participants in the July 2022 placement and 100,000,000 broker options.

29 August 2022

In accordance with section 329(5) of the *Corporations Act 2001*, the Company received the resignation of the audit firm that traded as Rothsay Auditing and ASIC's consent to that resignation. Rothsay Audit & Assurance Pty Ltd has been appointed auditor of the Company and this appointment will continue until the next annual general meeting. At the Company's next annual general meeting, it will be proposed that Rothsay Audit & Assurance Pty Ltd be appointed as auditors of the Company thereafter.

9 September 2022

Pancontinental Energy's 66.67% owned subsidiary, Pancontinental Namibia announced its intention to withdraw from the process of seeking an extension to the original PEL 37 Licence offshore Namibia. Pancontinental has held the licence since 28th March 2011. Since the withdrawal of farminee Tullow on 21 March 2021, Pancontinental Namibia has been endeavouring to reach agreement with its remaining joint venture partner and to seek an extension from the Ministry to enable a review the Cormorant well data. As the Company has not been able to reach agreement Pancontinental will apply for a new longer term licence.



Other than the matters discussed above, there has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of Directors of the Company, to affect significantly the operations of the Group, the results of those operations, or the state of affairs of the Group, in future financial years.

LIKELY DEVELOPMENTS AND EXPECTED RESULTS

The economic Entity expects to maintain the present status and level of operations and hence currently there are no likely developments in the Entity's operations.

ENVIRONMENTAL REGULATION AND PERFORMANCE

Pancontinental is committed to complying with any requirement for environmental management in any jurisdiction and country that it operates.

Currently some of Pancontinental's assets are managed by Joint Venture Operators who are responsible for the day to day operations of the permits. As such, regular review of the Joint Venture activities is crucial in safeguarding the assets of the Company. Technical and financial executives review the work programmes and budgets in place to ensure compliance with approved documents. Updates on operational activities that are provided by the Joint Venture partners are reviewed and will include any environmental operational issues if applicable.



INDEMNIFICATION AND INSURANCE OF DIRECTORS AND OFFICERS

Since the end of the previous financial year, the Company has paid insurance premiums in respect of Directors' and Officers' liability and legal expenses insurance contracts. The Directors have not included details of the nature of the liabilities covered or the amount of the premium paid in respect of the Directors and Officers and legal expenses insurance contracts as such disclosure is prohibited under the terms of the contract. The Non-Executive Directors receive a fixed fee for their services. If additional duties are performed by the Non-Executive Directors they are remunerated at market rates. The Chief Executive Officer receives a fixed fee for his respective executive services. Executive Directors are paid a salary. Directors do not receive any termination or retirement benefits.

Remuneration Committee

The full Board carries out the role of the Remuneration Committee.

Remuneration structure

In accordance with best practice corporate governance, the structure of Non-Executive and Executive remuneration is separate and distinct.

Non-Executive Director remuneration

Objective

The Board seeks to set aggregate remuneration at a level which provides the Company with the ability to attract and retain Directors of the highest calibre, whilst incurring a cost which is acceptable to Shareholders.

Structure

The Constitution and the ASX Listing Rules specify that the aggregate fees of Non-Executive Directors shall be determined from time to time by a general meeting. An amount not exceeding the amount determined is then divided between the Directors as agreed. The latest determination was at the Annual General Meeting held on 29 November 2007 when Shareholders approved an aggregate remuneration of \$400,000 per year. The amount of aggregate remuneration sought to be approved by Shareholders and the manner in which it is apportioned amongst Directors is reviewed annually. The Board considers advice from external sources as well as the fees paid to Non-Executive Directors of comparable companies when undertaking reviews. The Non-Executive Directors of the Company can participate in Employee Option Incentive Schemes with Shareholder approval. The remuneration of Executive and Non-Executive Directors for the period ending 30 June 2022 is detailed in Table 1 of this report.

Senior Management and Executive Director remuneration

Objective

The Board seeks to set aggregate remuneration at a level which provides the Company with the ability to attract and retain Executives of the highest calibre, whilst incurring a cost which is acceptable to Shareholders.

Structure

In determining the level and make up of Executive remuneration, the Board may take independent advice from external sources when necessary.

The Chief Executive Officer, Mr Myers receives a salary of \$100,000 per annum (this was reduced from \$200,000 during COVID-19) for his respective executive services. The Company and Mr Myers do not currently have a contract between them for the CEO and Executive Director position. Mr Myers was reappointed Executive Director and appointed Chief Executive Officer on 15 November 2018.

The Board regularly reviews compensation levels to take into account market-related factors such as cost of living changes, any change to the scope of the role performed and any other relevant factors of influence.

Fixed remuneration

Objective

The level of fixed Directors' fees is set so as to provide a base level which is both appropriate to the position and is competitive in the market.

Structure

Fixed primary remuneration is paid on a cash basis and there are no fringe benefits or other costs incurred by the Company.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This Financial Report was authorised for issue by the Directors on 30 September 2022.

Statement of Compliance

The Financial Report is a General Purpose Financial Report which has been prepared in accordance with Australian Accounting Standards, including Australian interpretations adopted by the Australian Accounting Standards Board ('AASB') and the *Corporations Act 2001*. The Consolidated Financial Report of the Consolidated Entity and Company also complies with IFRSs and interpretations adopted by the International Accounting Standards Board.

Basis of preparation

The report has been prepared on the basis of historical costs and except where stated does not take into account changing money values or current valuation of non-current assets. The accounting policies adopted are consistent with those of the previous year. The following specific accounting policies have been consistently applied, unless otherwise stated.

(a) Income Tax

Income tax on the profit or loss for the year comprises current and deferred tax. Income tax is recognised in the income statement except to the extent that it relates to items recognised directly in equity, in which case it is recognised in equity.

Current tax is the expected tax payable on the taxable income for the year, and any adjustment to tax payable in respect of prior years.

Deferred tax is provided using the balance sheet liability method, providing for temporary difference between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. A deferred tax asset is recognised only to the extent that it is probable that future taxable profits will be available against which the asset can be utilised.

(b) Exploration Expenses

Exploration and evaluation expenditure incurred is accumulated in respect of each identifiable area of interest. These costs are only carried forward to the extent that the costs are expected to be recouped through the successful development of the area or where activities in the area have not yet reached a stage which permits reasonable assessment of the economically recoverable reserves.

Accumulated costs in relation to an abandoned area are written off in full against operating results in the year in which the decision to abandon the area is made. When production commences the accumulated costs for the relevant area of interest are classified as development costs and amortised over the life of the project area according to the rate of depletion of the economically recoverable reserves.

Where independent valuations of areas of interest have been obtained, the valuations are brought to account. Subsequent expenditure on re-valued areas of interest is accounted for in accordance with the above principles. A regular review is undertaken of each area of interest to determine the appropriateness of continuing to carry forward costs in relation to that area of interest.

As at the end of the financial year, the Directors considered that the carrying value of the exploration interests of the Consolidated Entity was as shown in the Statement of Financial Position and no further impairments arises other than that already recognised.

(c) Principles of consolidation

The Consolidated Financial Statements are those of the Consolidated Entity, comprising Pancontinental Energy NL (the Parent Entity) and all Entities which Pancontinental Energy NL controlled from time to time during the year and at balance date.

Information from the financial statements of subsidiaries is included from the date the Parent Company obtains control until such time as control ceases. Where there is loss of control of a subsidiary, the Consolidated Financial Statements include the results for the part of the reporting period during which the Parent Company has control.

Notes to the Financial Statements



All intercompany balances and transactions, including unrealised profits arising from intra-group transactions, have been eliminated in full.

(d) Foreign currencies

Translation of foreign currency transactions

Transactions in foreign currencies of Entities within the Consolidated Entity are converted to local currency at the rate of exchange ruling at the date of the transaction.

Foreign currency monetary items that are outstanding at the reporting date (other than monetary items arising under foreign currency contracts where the exchange rate for that monetary item is fixed in the contract) are translated using the spot rate at the end of the financial year.

A monetary item arising under a foreign currency contract outstanding at the reporting date where the exchange rate for the monetary item is fixed in the contract is translated at the exchange rate fixed in the contract.

All resulting exchange differences arising on settlement or re-statement are recognised as revenues and expenses for the financial year. Any gains or costs on entering a hedge are deferred and amortised over the life of the contract.

(e) Cash and cash equivalents

For the purposes of the Statement of Cash Flows, cash includes cash on hand and in banks, and money market investments readily convertible to cash within two working days, net of outstanding bank overdrafts.

Interest expense is charged as an expense as it accrues.

(f) Receivables

Trade receivables are recognised and carried at original invoice amount less a provision for any uncollectible debts. An estimate for doubtful debts is made when collection of the full amount is no longer probable. Bad debts are written-off as incurred.

Receivables from related parties are recognised and carried at the nominal amount due. Bills of exchange and promissory notes are measured at the lower of cost and net realisable value.

(g) Investments

Investments in Controlled Entities are carried in the Company's Financial Statements at the lower of cost and recoverable amount.

(h) Recoverable Amount

The carrying amounts of non-current assets valued on the cost basis, other than exploration and evaluation expenditure carried forward are reviewed to determine whether they are in excess of their recoverable amount at reporting date. If the carrying amount of a non-current asset exceeds its recoverable amount, the asset is written down to the lower amount. The write down is expensed in the reporting period in which it occurs.

(i) Property, plant and equipment

Cost and valuation

Property, plant and equipment is measured at cost.

Depreciation

Depreciation is provided on a diminishing value basis on all property, plant and equipment.

(j) Joint ventures

Interests in the joint venture operations are brought to account by including in the respective classifications, the share of individual assets employed and share of liabilities and expenses incurred.

In the Company's Financial Statements, investments in joint venture operations were carried at the lower of cost and recoverable amount.



(k) Going concern

The Directors consider that the going concern basis for the Consolidated Entity is appropriate. This basis has been determined after consideration of the following factors:

- The ability to issue additional share capital under the *Corporations Act 2001*, if required, by a share purchase plan, share placement or rights issue;
- The option of farming out all or part of the Consolidated Entity's exploration projects and;
- The ability, if required to dispose of interests in exploration assets.

Accordingly, the Directors believe that the Consolidated Entity will obtain sufficient cash inflows to enable it to continue as a going concern and that it is appropriate to adopt that basis of accounting in the preparation of the Financial Statements.

(l) Payables

Liabilities for trade creditors and other amounts are carried at cost which is the fair value of the consideration to be paid in the future for goods and services received, whether or not billed to the Consolidated Entity.

Payables to related parties are carried at the principal amount.

Deferred cash settlements are recognised at the present value of the outstanding consideration payable on the acquisition of an asset discounted at prevailing commercial borrowing rates.

(m) Provisions

Provisions are recognised when the economic Entity has a legal, equitable or constructive obligation to make a future sacrifice of economic benefits to other entities as a result of past transactions or other past events, it is probable that a future sacrifice of economic benefits will be required and a reliable estimate can be made of the amount of the obligation.

(n) Contributed equity

Issued and paid up capital is recognised at the fair value of the consideration received by the Company.

Any transaction costs arising on the issue of ordinary shares are recognised directly in equity as a reduction of the share proceeds received.

(o) Revenue recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Entity and the revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recognised:

Rendering of Services

Where the contract outcome can be reliably measured, control of the right to be compensated for the services and the stage of completion can be reliably measured. Stage of completion is measured by reference to the labour hours incurred to date as a percentage of total estimated labour hours for each contract.

Where the contract outcome cannot be reliably measured, revenue is recognised only to the extent that costs have been incurred.

Interest Revenue

Control of the right to receive the interest payment. Interest revenue is recognised as it accrues, taking into account the effective yield on the financial asset.

(p) Taxes

Where assets are revalued no provision for potential capital gains tax has been made.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST except:

- where the GST incurred on a purchase of goods and services is not recoverable from the taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable; and
- receivables and payables are stated with the amount of GST included.



The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables in the Statement of Financial Position. Cash flows are included in the Statement of Cash Flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the taxation authority, are classified as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the taxation authority.

(q) Employee benefits

Provision is made for Employee benefits accumulated as a result of Employees rendering services up to the reporting date. These benefits include wages and salaries, annual leave, sick leave and long service leave.

Liabilities arising in respect of wages and salaries, annual leave, sick leave and any other Employee benefits expected to be settled within twelve months of the reporting date are measured at their nominal amounts based on remuneration rates which are expected to be paid when the liability is settled.

Employee benefit expenses and revenues arising in respect of the following categories:

- wages and salaries, non-monetary benefits, annual leave, long service leave, sick leave and other leave benefits; and
- other types of Employee benefits

are charged against profits on a net basis in their respective categories.

(r) Earnings per share

Basic EPS is calculated as net profit attributable to members, adjusted to exclude costs of servicing equity (other than dividends) and preference share dividends, divided by the weighted average number of ordinary shares, adjusted for any bonus element.

Diluted EPS is calculated as net profit attributable to members, adjusted for:

- costs of servicing equity (other than dividends);
- the after tax effect of dividends and interest associated with dilutive potential ordinary shares that have been recognised as expenses; and
- other non-discretionary changes in revenues or expenses during the period that would result from the dilution of potential ordinary shares;

divided by the weighted average number of ordinary shares and dilutive potential ordinary shares, adjusted for any bonus element.

(s) Comparatives

Where necessary, comparatives have been reclassified and repositioned for consistency with current year disclosures.

(t) Financial Instruments

(u) New accounting standards and interpretations

18. SEGMENT INFORMATION

Segment accounting policies

The Group has adopted AASB 8 *Operating Segments* which requires operating segments to be identified on the basis of internal reports about components of the Group that are reviewed by the chief operating decision-maker in order to allocate resources to the segment and to assess its performance.

During the period the Group operated predominately in one business segment, being the oil and gas sector. Accordingly, under the management approach outlined only one operating sector has been identified and no further disclosures are required in the notes to the Consolidated Financial Statements.

19. FINANCIAL INSTRUMENTS

Financial risk management

Overview:

The Board of Directors has overall responsibility for the establishment and oversight of the risk management framework. Management monitors and manages the financial risks relating to the operations of the Group through regular reviews of the risks.

(a) Credit risk:

Credit risk is the risk of financial loss to the Group if a customer or counterparty to a financial instrument fails to meet its contractual obligations. In this industry, it arises principally from the receivables of joint venture re-charges and recuperations of cost. For the Group in this financial year, it arises primarily from trade debtors, receivables due from subsidiaries, GST and VAT refunds, prepayments and bonds.

(i) Trade and other receivables:

The Group operates predominantly in the oil and gas exploration sector; it does not ordinarily have material trade receivables and is therefore not ordinarily exposed to credit risk in relation to trade receivables.

(ii) Loans to subsidiaries:

The Company has provided funding to its subsidiaries by way of loans. Repayment of these loans will occur through future business activities of each respective Entity.
