The lenders received 6.67 million options exercisable at \$0.25 each expiring 30 April 2023. All the lenders, elected to convert their debt to shares under the Entitlement Offer which closed on 28 September 2022. The shares will be issued to the lenders on completion of the Shortfall Offer.</p>
