September 2022 Quarterly Activities Report

Protean Energy Ltd (**Protean** or the **Company**) provides shareholders its quarterly report for the three-month period ending 30 September 2022.

On 10 October 2022, the Company received notice that it would be suspended from quotation in accordance with Listing Rule 17.3. Protean notes the suspension will continue until it is able to demonstrate compliance with Listing Rule 12.1.

The Company is continuing to review and consider project and business acquisition opportunities, which may not be in the mining sector, whilst reducing operational spend.

Additional ASX Information

Protean provides the following information pursuant to ASX Listing Rule requirements:

1. ASX Listing Rule 4.7C.1: The Company's net cashflow used in operations for the quarter was \$154,000. The Company's operational expenses mainly comprised of staff costs (\$28,000), administration and corporate costs (\$122,000) which included expenditure in relation to the termination of exploration activity in South Korea of \$38,000.
2. ASX Listing Rule 4.7C.3: In item 6 of the attached Appendix 4C, payments to related parties of approximately \$54,000 comprising of Director Services (\$28,000) and Non-Director Services – company secretarial services (\$12,000), accounting services (\$9,000) and serviced office (\$5,000) were paid during the quarter.
