**Updated Form 604 – following close of off-market takeover bid by V B S Exchange Pty Limited for Altamin Limited (ASX: AZI)**

We act for V B S Exchange Pty Limited ACN 109 106 201 (**VBS Exchange**), in relation to its off-market takeover offer (**Offer**) for all of the ordinary shares in Altamin Limited ACN 078 510 988 (ASX:AZI) (**Altamin**) as detailed in the replacement bidder's statement (**Bidder's Statement**) lodged with the ASX on 20 May 2022.

On behalf of VBS Exchange, we confirm that following the completion of a reconciliation of all accepted Offers before 7:00pm (Sydney time) on 1 August 2022, being the time and date of the close of the Offer, VBS Exchange had a final voting power of 39.02% and not 38.76% as was previously disclosed in the Form 604 dated 1 August 2022.

We enclose a new Form 604 reflecting the current voting power of VBS Exchange of 39.02%.


