Cleansing Notice

Disclosure Notice Under Section 708A(5)(e) of the Corporations Act 2001 (Cth)

*Orcoda Limited (ASX: ODA) (**the Company**) refers to the 750,000 fully paid ordinary shares (**Shares**) issued on 2 September 2022 to Geoff Williams. The negotiated bonus of 750,000 Shares is an accrued entitlement satisfied by this issue.*

The Act restricts the on-sale of securities issued without disclosure unless the sale is exempt under sections 708 or 708A of the Act. By the Company giving this notice, a sale of the Shares will fall within the exemption in section 708A(5) of the Act. The purpose of this cleansing notice is that the resulting Shares upon quotation may be on-sold without restriction.

 - b. that investor or their professional advisers would reasonably require for making an informed assessment of:
 - i. the assets and liabilities, financial position and performance, profits and losses, and prospects of the Company; or
 - ii. the rights and liabilities attached to these Shares.
