Deep Porphyry Drilling Underway

Revised deep porphyry target based on recent data review

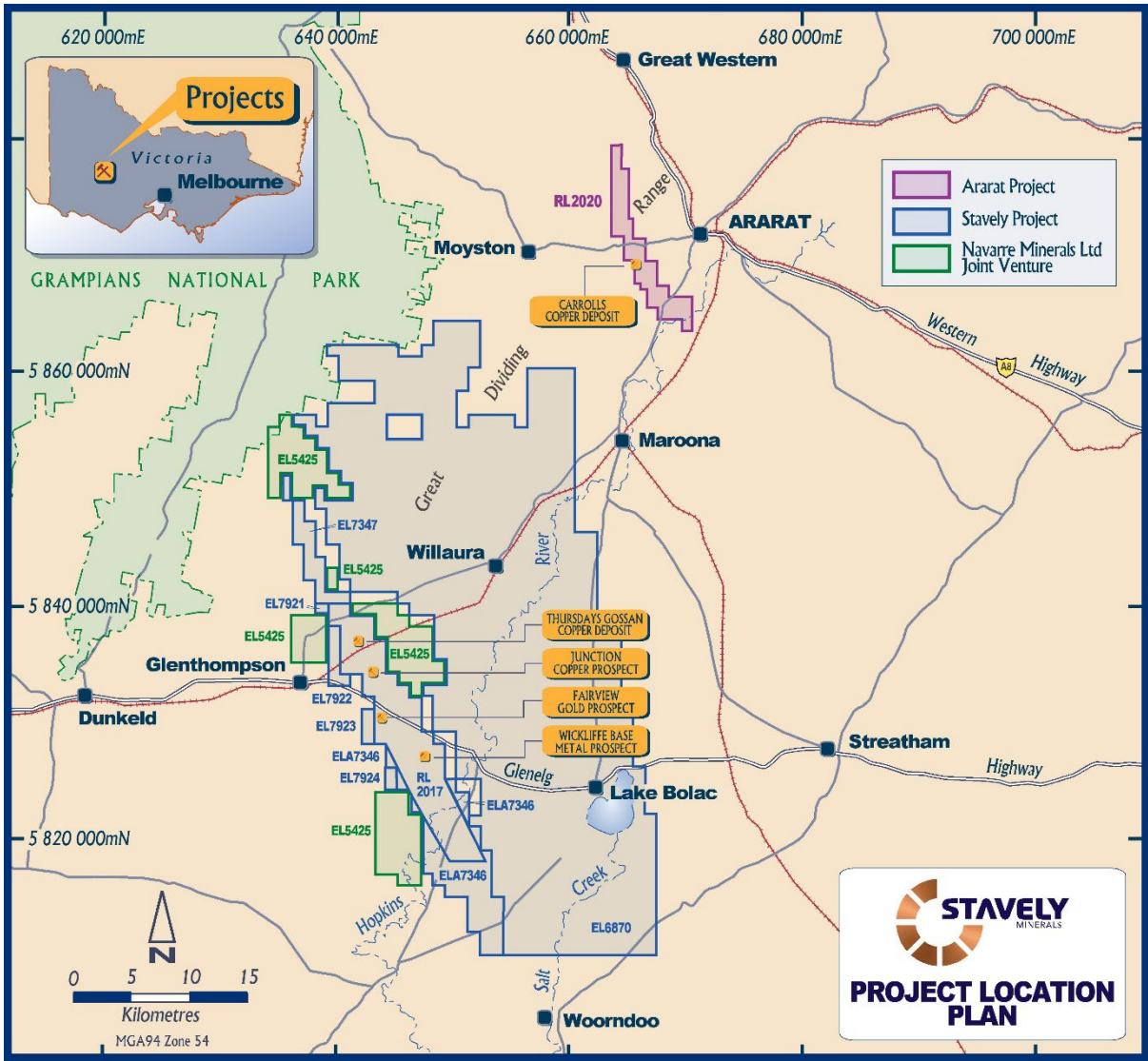


Figure 1. Stavely Project location map.

Further to its announcement of 22 June 2023, Stavely Minerals Limited (ASX Code: **SVY** – “Stavely Minerals”) is pleased to advise that deep drilling has commenced at the Thursday's Gossan prospect, part of the 100%-owned **Stavely Copper-Gold Project** in western Victoria (Figure 1), to test a revised deep porphyry target.

The target was generated following an extensive review of previous diamond drilling data, which was undertaken by porphyry expert Dr Steve Garwin in collaboration with Stavely Minerals' in-house geological team.

A drier winter is forecast for western Victoria and Stavely Minerals has previously drilled through winter by employing track-mounted diamond drill rigs and tracked support vehicles to minimise the use of rubber-tyre vehicles in the paddocks. This significantly reduces the impact of bogged vehicles and rutting.

Stavely Minerals Executive Chair and Managing Director, Mr Chris Cairns, said: *“Working closely with our on-site team, Dr Garwin has identified an exciting deep porphyry target that warrants immediate drill testing. We are very excited to be back drilling to continue vectoring towards the centre of the porphyry system.”*

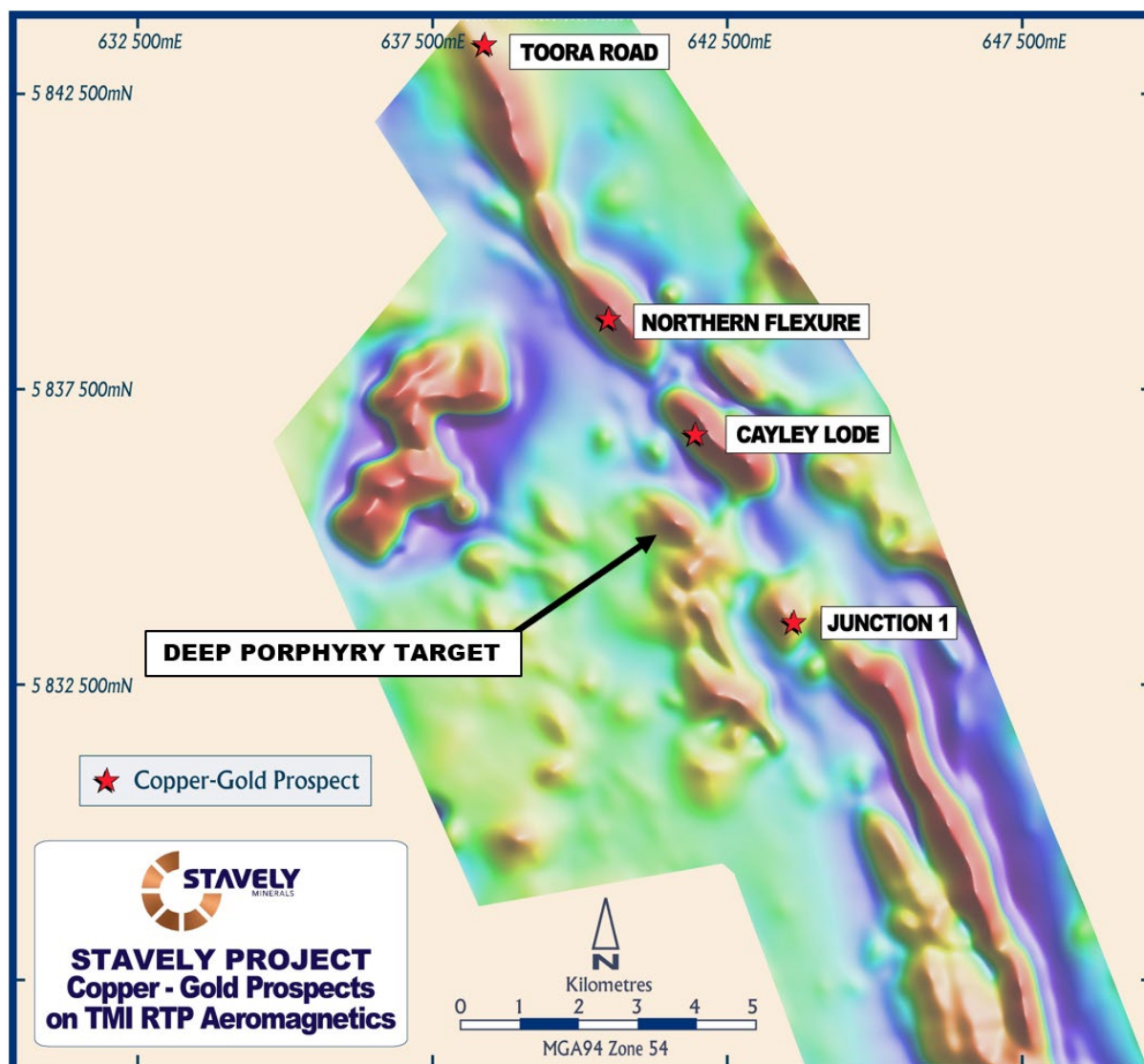


Figure 2. New drill target on magnetics enhanced to display deep-seated strong magnetic anomalies.
