Rebekah Letheby said, "Peter has built an experienced team of professionals with a deep understanding of additive manufacturing which will serve our future business strategies well. I look forward to the challenge to lead the business to our next success as Aurora has significant opportunity to utilise its commercial printing technologies as Australia looks to compete in the sustainable, value add manufacturing industries".

Peter Snowsill said: "I am proud of the quality of the team at Aurora, the maturity of our technology and the underpinning we have for a strong services business. I wish, Grant and the Board, and Rebekah and the team, every success in the ongoing commercialisation journey."
