# Chairman's Letter

**Dear Fellow Shareholders,**

**Welcome to the 2023 Annual Report for Carnaby Resources Limited (ASX: CNB). Reflecting on an exciting period for the Company during its fourth full year as a copper and gold focussed explorer, this Annual Report marks the commencement of a transitional pathway with the Greater Duchess Copper Gold Project maturing from a successful exploration story to an exciting development prospect.**

The Company's highly successful exploration efforts in FY 2022, embodied by the Nil Desperandum and Lady Fanny Discoveries at our Australian Copper Gold tenements near Mount Isa in Queensland, were reinforced this year with the successful drill out of the recently acquired Mount Hope Prospects. Making use of the continued market momentum experienced into early 2023, the Group was able to again raise \$20 million via a placement of its shares, which provided the robust cash position required to maintain the aggressive expansion of the new discoveries whilst crucially, minimising the dilution to existing shareholders.<sup>1</sup>

The Greater Duchess Copper Gold Project, containing the Mount Hope, Nil Desperandum and Lady Fanny Copper Gold discoveries, has grown during the year to over 1,921km<sup>2</sup> of prospective tenure. This growth is attributed the recently announced Farm-In and Joint Venture Agreement with Rio Tinto Exploration relating to the Devoncourt Exploration Project located just to the east of the Company's current exploration activities.<sup>2</sup> This unique opportunity to explore a Tier 1 sized target is particularly exciting and we look forward to commencing initial exploration activities on the Devoncourt tenement package which will be run in tandem with continued operations at the Company's existing discoveries.

This year's news flow has been dominated by the successful exploration of the Mount Hope Mining Lease, which contains the discoveries at both the Mount Hope North and Mount Hope Central Prospects. Mount Hope Central has been a particularly significant discovery for the Company, where continual RC and Diamond drilling has revealed numerous mineralised lodges below the historical open pit, each of which remain completely open. A high volume of outstanding assay results received from the Prospect during the

year include 138m @ 2.1% Copper from 250m and 39m @ 5.2% Copper from 158m.<sup>3</sup> Mount Hope North has also yielded fantastic assay results from mineralisation hosted in a vein lode structure which include 75m @ 1.7% copper from 221m.<sup>4</sup>

Such exploration results have made the Mount Hope Central and North Prospects the crowning discoveries to date in the Company's growing copper portfolio.

Exploration work at the Nil Desperandum and Lady Fanny discoveries has been limited during the year as a result of the Company's focus on Mount Hope. Both deposits remain open at depth and present enticing regional exploration opportunities. Particularly within the 3km Nil Desperandum to Lady Fanny corridor where numerous Induced Polarisation (**IP**) anomalies signify walk-up drill targets.

Testing of such targets and broader regional exploration is expected to recommence in the coming months pending the finalisation and announcement of the Company's much anticipated maiden Mineral Resource Estimate for the Greater Duchess Copper Gold Project.

On behalf of our board of directors and you, our valued shareholders I would like to commend Rob Watkins, our Managing Director, along with his talented colleagues, for an outstanding effort over the preceding twelve months. They have skilfully positioned Carnaby as one of the most prospective copper stories domiciled within Australia.


### 6. Principal activities

The principal activity of the Company during the financial year was mineral exploration.

### 7. Operating and financial review

#### 7.1 Review of operations

During the year the Group continued its primary focus at its Greater Duchess Copper Gold Project in the Mount Isa Inlier of Queensland, greatly expanding discovered mineralisation at each of the three significant copper-gold discoveries at the Mount Hope, Nil Desperandum and Lady Fanny prospects. Minimal exploration was conducted at the Company's Western Australian projects due to prioritisation of the Greater Duchess Project in Queensland, however with encouraging results coming from both the Pilbara Gold and Lithium, and Yilgarn Margin Projects in past exploration programs, the Company remains committed to further progressing activities in Western Australia (Figure 1).

## GREATER DUCHESS COPPER AND GOLD PROJECTS, MOUNT ISA INLIER, QUEENSLAND




Figure 2 | Greater Duchess Copper Gold Project and Tick Hill Gold Project.<sup>5</sup>

The Company's Greater Duchess Copper and Gold Projects which were acquired by the Company in April 2019, have since expanded with the acquisition of the Mount Hope Mining Lease in April 2022 and the recent announcement of a Farm-in and Joint Venture Agreement with Rio Tinto Exploration relating to its nearby Devoncourt Project. The exploration package now covers a substantial landholding of 1,921 km<sup>2</sup> within the world class Mt Isa copper district (Figure 2).


### Greater Duchess Copper Gold Project (CNB 82.5% – 100%)

The Greater Duchess Copper Gold Project lies approximately 70 km southeast of Mount Isa, Queensland on a landholding of approximately 1,921 km<sup>2</sup> with multiple undeveloped copper rich Iron Oxide Copper Gold (**IOCG**) targets over a 100 km corridor.

During the period the Company expanded its portfolio of copper-gold discoveries, with significant deposits being uncovered at the Mount Hope Central and Mount Hope North Prospects to complement the existing discoveries at the Lady Fanny and Nil Desperandum Prospects to the south (Figure 3). Regional exploration potential remains prolific across the tenement package. Extensive Induced Polarisation (**IP**) surveys conducted in 2022 and the resultant anomalies have correlated exceptionally well with copper mineralisation across the project. This has led to the identification of several new prospects in the vicinity of the Lady Fanny and Nil Desperandum copper discoveries which remain untested.

The Company is targeting the release of its maiden Mineral Resource Estimate (**MRE**) in 2023. Potential exists to define several shallow open pittable resources that can be amalgamated into a single mining project and hauled to a regional processing facility (Figure 2) or fed into a potential stand-alone processing plant.

### *Mount Hope Prospects (CNB 100%)*

The Group rapidly accelerated exploration at the Mount Hope Mining Lease during the period with the discovery of two new copper-gold deposits at Mount Hope Central and Mount Hope North. Continuous Diamond and Reverse Circulation (**RC**) drilling was conducted throughout the period and remains on-going. As such, the Mount Hope Prospects constitute the Company's main exploration focus throughout and subsequent to the period.





Figure 4 | Mount Hope Central Boomerang and Binna Burra Lodes Long Section<sup>7</sup>

Extensive drilling at Mount Hope Central has uncovered numerous mineralised lodes beneath the historical shallow open pit (Figure 4 & Figure 5). The first discovered Boomerang and Binna Burra lodes which are present at surface have yielded outstanding results throughout and subsequent to the period. Mineralisation remains completely open, with ongoing drilling currently testing the lower western section of the deposit due to recent indications that the Boomerang Lode plunge appears to be shifting at depth to the west but remains steep (Figure 4). A new high-grade sub-parallel mineralised lode named the Chalcus Lode was also discovered in early 2023 whilst testing for depth extensions of the Boomerang lode. The Chalcus Lode remains completely open in all directions and remains the target of ongoing drilling as its extent and orientation has not yet been fully delineated (Figure 5). An additional new lode discovered in the footwall to the Chalcus Lode in June 2023 is also the target of ongoing drilling. Downhole EM has been completed to assist with targeting. Stand-out results received from the Chalcus Lode during and subsequent to the period include<sup>8</sup>:


At Mount Hope North, mineralisation is hosted in a vein lode structure which strikes ENE and dips steeply to the south. RC and diamond drilling produced numerous broad and high-grade intersections during and subsequent to the period with significant results including<sup>10</sup>:

#### ***Nil Desperandum Prospect (CNB 82.5%, DCX 17.5%)***

The Nil Desperandum discovery is a high-grade breccia shoot which has so far been drilled to 800m down-plunge and 500m below surface (Figure 6). The mineralisation remains open down-plunge to the southwest and down-dip to the southeast however due to the prioritisation of the Mount Hope Prospects, minimal exploration has been conducted at Nil Desperandum during the period. Significant results from drilling at Nil Desperandum to date include<sup>11</sup>:



### Lady Fanny Prospect (CNB 100%)

The Lady Fanny Prospect is located approximately 3km north of Nil Desperandum (Figure 3) and comprises of two historically relinquished mining leases which were amalgamated into the Group's surrounding exploration tenement. Limited drilling was completed at Lady Fanny during the period due to the priority drill out at the Mount Hope discovery 10 km to the north. Lady Fanny continues to show excellent potential for a large, open pitable resource with the most recent drilling targeting strike and depth extensions guided by strong IP chargeability anomalies which continue to provide an excellent vector to copper sulphide mineralisation (Figure 7). Wide, high-grade, and very shallow copper gold mineralisation has now been intersected over a core zone of 300m strike length which remains strongly open to the north and at depth with highlighted drilling results to date including<sup>13</sup>:

The southern extension of the Lady Fanny corridor, named Lady Fanny South remains sparsely drilled but with strong IP chargeability anomalies suggesting high potential for copper gold mineralisation. Drilling targeting the strongest IP chargeability line at Lady Fanny South has intersected copper sulphide mineralisation, however the core of the IP anomaly is yet to be adequately tested as shown in the Figure 7 long section above. To date only a single drill section has been completed at Lady Fanny South.

The results showed exceptional copper recoveries and good gold recoveries from all ore sources and no deleterious elements were detected in the test samples.<sup>16</sup> The metallurgical test work completed and reported represents only the first scoping level stage. More extensive metallurgical studies will be completed in future studies.

### Devoncourt Project (CNB Earning 51%)


Subsequent to the reporting period the Group announced the signing of a Farm-in and Joint Venture Agreement with Rio Tinto Exploration Pty Ltd (RTX), a subsidiary of Rio Tinto Limited (ASX: RIO), which adds a high quality advanced exploration target and greatly expands the land position of the Group's Greater Duchess Copper Gold Project.<sup>17</sup> The Devoncourt Project encompasses 838 km<sup>2</sup> of exploration tenure covering the Wimberu granite which has an elliptical aerial extent of approximately 30km x 30km (Figure 9). The Wimberu granite is concentrically zoned grading from more mafic granodiorite rim to more felsic compositions towards the core and belongs to the Williams-Naraku super suite of oxidised, I-type granitoids (ca 1520-1490 Ma) which is thought to be an important source of Cu-bearing fluids in deposits such as Ernest Henry, Selwyn and Mount Elliot and most likely the Greater Duchess deposits as well. The Wimberu granite is considered to be a potential source of iron ore copper gold (IOCG) mineralised fluids and also a potential host of such mineralisation within the differentiated granite plutons.

The Group will initially complete a regional review and targeting exercise before considering the methodology to explore the targets, which may involve further geophysical surveys prior to drilling. Given the early indications of widespread IOCG alteration and mineralisation at the Wimberu Prospect, The Group considers the broader Devoncourt Project to be highly prospective for the discovery of new IOCG mineralisation within the tenement package.

#### **Tick Hill Gold Project (CNB 100%)**

The Tick Hill open pit cutback is forecast to produce 63,300t @ 6.1 g/t for 12,500oz<sup>18</sup>. A decision to develop, consolidate and/or divest part or all of the open pit cutback project is in progress.

No further proceeds from a now ceased 5% royalty on the Tick Hill Tailing Retreatment Project<sup>19</sup> were received during the period with cumulative royalties received to date remaining at \$381,000. The 24-month operational term of the original Tick Hill Tailings Stockpile sale agreement expired on 8 October 2022 without an extension being granted by the Group. As such, ownership of the remaining reserves contained within the Tick Hill Tailings facility reverted to the Group during the period.

#### **PILBARA GOLD AND LITHIUM PROJECTS, MALLINA BASIN, WESTERN AUSTRALIA**

The Company's Pilbara Gold and Lithium Projects comprise 442km<sup>2</sup> of highly prospective tenure located along the Berghaus and Tabba Tabba Shear Zones in the Mallina Basin. Exploration activities in prior periods have focussed primarily on the Strelley Gold Project, which lies approximately 70 km northeast of De Grey Mining Ltd's (ASX: DEG) Hemi Gold Deposit, and the Big Hill Gold and Lithium Project.



Due to prioritisation of exploration resources towards the Greater Duchess Copper Gold Project in Queensland, no on-ground exploration was conducted at Strelley during the period.

Multiple programs of RC drilling have been completed at Strelley during previous periods, where significant gold mineralisation was intersected along the newly identified 4km Strelley Gold Corridor, targeting the Alcazar, Stockade and Bastion Prospects (Figure 10).

At the Alcazar Prospect, an encouraging result from drilling conducted in FY 2022 of 2m @ 1.63g/t from 110m in PLRC0051<sup>21</sup> was followed up by further promising assays with a composite result of 5m @ 1.82g/t from 160m in PLRC0114.<sup>22</sup> A single RC hole was drilled 160m to the south of the PLRC0051, which intersected a highly encouraging broad zone of gold mineralisation with composite results of 20m @ 0.45g/t gold from 105m including 5m @ 1.52g/t from 110m in PLRC0112. The intersections are hosted by a wide intrusion and mineralisation remains open to the south and to the north.

At the Bastion Prospect, initial RC drilling intersected 2m @ 5.21 g/t gold from 85m including 1m @ 9.75 g/t gold from 85m.<sup>23</sup> In the follow-up drilling program, the target intrusion and encouraging alteration were recorded at the northern end of the Bastion Intrusion where composite results of 5m @ 1.03 g/t gold from 110m in PLRC0071 and 5m @ 0.41g/t gold from 95m in PLRC0157 were intersected.<sup>24</sup>

Wide zones of gold mineralisation were intersected at the Stockade Prospect in drill hole PLRC0035, which was drilled targeting a bottom of hole aircore drilling anomaly. Results of 7m @ 2.83 g/t gold from 119m, including 2m @ 8.82 g/t gold from 119m were recorded in PLRC0035.<sup>25</sup>

The results to date from the Strelley Gold Project continue to warrant follow up exploration given the extensive mineralisation identified over a greater than 4 km long corridor from shallow and wide spaced drilling (Figure 10) Ultrafine soil sampling appears to be working well through the ~10m of sand cover masking the prospective basement rock.

### **Big Hill Gold and Lithium Project (CNB 100%)**

Due to prioritisation of exploration resources towards the Greater Duchess Copper Gold Project in Queensland, no on-ground exploration was conducted at Big Hill during the period.

Soil sampling results released during FY 2022 from the Big Hill Project highlighted a large 1.5 km by 0.5 km lithium soil anomaly with soil results up to 179 ppm Li.<sup>26</sup> The lithium soil anomaly is associated with elevated caesium (Cs) and tantalum (Ta) confirming a LCT pegmatite type anomaly target. The Big Hill lithium soil anomaly is coincident with a discrete magnetic high unit located on a major fault structure (Berghaus Shear Zone) on the edge of the large Split Rock Super Suite intrusion, considered to be a similar geological setting to the world class Pilgangoora and Wodgina lithium deposits located 60 km and 80 km north respectively.

First pass soil sampling conducted during the period also defined two significant parallel gold soil anomalies, each over 2 km in strike within the Berghaus Shear Zone.<sup>27</sup> Several occurrences of strongly altered mafic greenstone sub-crop have been identified at Big Hill. The previously unrecognised presence of greenstone rocks at Big Hill within the Berghaus Shear Zone is a very encouraging sign for potential gold mineralisation.

First pass drill testing of the Big Hill lithium soil anomaly and Big Hill gold soil anomaly were completed in FY 2022. Shallow RC drilling was completed in two traverses across the lithium soil anomaly and a single traverse was completed across the gold soil anomaly. Pegmatites were intersected in the drilling, however no clearly identifiable lithium bearing minerals were identified.<sup>28</sup>

### **Mount Grant Gold Project (CNB 80%)**

In Q4 2020, a high-resolution aeromagnetic survey was completed at Mount Grant. Results from the survey highlighted several new "Hemi style" intrusion targets along the main granite greenstone contact that is interpreted to represent the northern continuation of the Tabba Tabba Shear Zone.<sup>29</sup>

The Mount Grant tenement is completely overlain by alluvial cover and is unexplored for gold mineralisation. The intrusion style targets identified represent distinct bullseye targets for first pass drill testing and form a pipeline of prospects that will be tested with drilling in the future.

### **Pardoo (CNB 100%)**

The Pardoo exploration license application covers 110 km<sup>2</sup> along a significant structural trend that is overlain by alluvial cover and is previously unexplored for gold mineralisation. Several distinct intrusion type targets have been identified within the tenement which form a pipeline of prospects that will be tested with drilling in the future.

### **Goldsworthy (CNB 100%)**

The Goldsworthy tenement application contains approximately 4 km strike of unexplored granite / greenstone contact along the interpreted eastern extension of the Tabba Tabba Shear Zone. The Tabba Tabba Shear Zone is considered to be a fertile structure for gold mineralisation. Systematic exploration of the Goldsworthy tenement will be completed in due course.

## **YILGARN MARGIN, WESTERN AUSTRALIA**

The Company's Yilgarn Margin projects comprise the Throssel Project and the Malmac Project. Both Throssel and Malmac are considered prospective for orogenic gold, sedimentary exhalative (SEDEX) and volcanogenic massive sulphide (VHMS) base metals deposits, and nickel and platinum group elements (PGE's).

### **Malmac Project (CNB 100%)**

The Malmac Project covers 810 km<sup>2</sup> within the northern Yilgarn margin mobile belt. Further soil, rock chip and portable XRF readings were completed at Malmac during the period with results currently being compiled. A total of 796 soil samples on a nominal 400m x 200m spacing were collected targeting broad copper and gold soil anomalies from previous reconnaissance programs. Infill and extension soil, stream sediment and rock chip sampling were completed across the western edge of the Malmac West tenement (E69/3509) during late 2021 (Figure 11). Results from the soil sampling have further defined copper gold anomalism along the Salvation Fault. The highest 2021 copper soil result, assayed using Ultrafine analysis, was 51.5 ppm with the highest gold assay being 13.8 ppb. Rock chip samples collected over a 20 km strike length along the Salvation Fault zone during the 2021 campaign returned peak lab assayed copper values of 0.33% and outcrop XRF readings of up to 0.78% copper.<sup>30</sup>



The surface sampling highlighted a second coherent copper gold soil anomaly, located on the WNW Salvation Fault approximately 13km WNW of the previously identified soil anomaly in 2020.<sup>31</sup> This new copper soil anomaly (>30 ppb) is coincident with a magnetic high has a strike extent of 2.5km and encapsulates elevated lab assayed rock chips up to 475 ppm copper. The highest 2021 soil gold result of 13.8 ppb is located just 1km SW of the new copper soil anomaly and is located on a lower intensity magnetic high.

These anomalous copper and gold results taken at a minimum of 500m sample spacing are considered very encouraging and will be systematically evaluated in future field programs. The project lies on the northern margin of the Earraheedy Basin and comprises a package of rocks variously termed the 'Troy Creek Beds' or 'Troy Creek Schist'. Rocks in this area are poorly understood and poorly described, with no firm depositional age or depositional environment clearly described. The Troy Creek package has been affiliated with the Bryah Group (host to the Degruessa, Monty and Horseshoe Lights Cu-Au massive sulphide deposits), Yerrida Group (host to the epithermal-style Thaduna Copper Deposit) and the Earraheedy Group (host to the recent Chinook Zn-Pb discovery by Rumble Resources Limited).

### Throssel Project (CNB 100%)

The Throssel Project covers 162 km<sup>2</sup> located 70 km north of the Gruyere Gold Deposit being developed by Gold Road Resources and Goldfields Ltd. The project area covers a potential 20 km strike of unexplored greenstone belt under shallow cover. A first pass soil and rock chip sampling program was carried out subsequent to the period. Results from these initial exploration activities are yet to be received.

### 7.2 Financial performance

The Company's net loss after tax attributable to the shareholders for the year to 30 June 2023 was \$12,233,779 (2022 Loss: \$8,216,492). The Group's net assets increased \$8,081,471 (2022 increased: \$12,928,146). The Group's cash and restricted cash position as at 30 June 2023 was \$27,302,130 (2022: \$18,308,521).

### 7.3 Corporate

On 8 May 2023 Mr Steven Bowler was appointed as Joint Company Secretary of the Company alongside incumbent Company Secretary and Non-Executive Director, Mr Greg Barrett.

During the year, the Group successfully completed a \$20 million non-underwritten placement of approximately 16.4 million new fully paid ordinary shares at an offer price of \$1.22 per share.<sup>33</sup> The Placement received very strong support from existing shareholders as well as introducing a number of new institutional and sophisticated investors to the register. Euroz Hartleys Limited, Macquarie Capital (Australia) Limited and Petra Capital Pty Ltd were the Joint Lead Managers and Bookrunners to the Placement.

The Group also received the final proceeds from the sale of the Lainejaur Project in Sweden for total consideration of \$1.5 million.<sup>34</sup> The last payment of \$375,000 was received in Q4 FY 2023, completing the transaction.

The exercise of Unlisted Share Options by Directors resulted in the Group receiving total proceeds of \$405,000 during the period.

## 8. Dividends

No dividend was paid or declared by the Company during the year and up to the date of this report.

## 9. Significant changes in the state of affairs

There have been no significant changes in the state of affairs of the Group during the financial year, other than as set out in this report.

## 10. Events subsequent to the reporting date

Subsequent to the period, the Group announced the signing of a Farm-in and Joint Venture Agreement with Rio Tinto Exploration Pty Ltd (RTX), a subsidiary of Rio Tinto Limited (ASX: RIO), which adds a high quality advanced exploration target and greatly expands the land position of the Greater Duchess Copper Gold Project in Mt Isa, Queensland.<sup>35</sup> The Group can achieve a 51% joint venture interest in the Devoncourt Project (Figure 2) by sole funding A\$5,000,000 of exploration by 1 August 2028 in accordance with the following conditions:

1. The Group to make an up-front payment of A\$100,000 to RTX and may elect to make the payment in either cash or fully paid ordinary shares in the Company.
2. As part of the expenditure commitment, the Group must complete a minimum of 4,000m of diamond core and/or reverse circulation (RC) drilling.
3. The Group undertakes a minimum expenditure commitment of A\$500,000 including 2,000m of diamond core and/or RC drilling by 1 August 2025 before it can withdraw from the agreement.

Scope is present in the agreement for the Group to earn an additional 29% interest in the Project through the completion of further exploration milestones.

## 11. Likely developments

The Board will continue to advance exploration and development opportunities in relation to its projects.

## 12. Environmental performance and regulations

The operations of the Company are presently subject to environmental regulation under the laws of the Commonwealth of Australia. The Board believes that the Group has adequate systems in place for the management of its environmental requirements and is not aware of any breach of those environmental requirements as they apply to the Group.

## Changes since 30 June 2022

There were no changes in the Tick Hill Project Mineral Resource for the Open Pit or Underground Resource during the period. The 24-month operational term of the original Tick Hill Tailings Stockpile sale agreement (see ASX release dated 3 August 2020) expired on 8 October 2022. As such, ownership of the remaining reserves contained within the Tick Hill Tailings facility and Historic ROM Stockpile reverted to the Company during the period. The Tick Hill Tailings Eastern Cell was depleted due to mining under the sale agreement. The Historic ROM Stockpile was re-estimated following grade control drilling and also partially depleted due to mining under the sale agreement. The remaining ROM resource and reserve has been calculated at a 0.5g/t cutoff. For further details regarding the maiden Tick Hill Ore Reserve and Mineral Resource, refer ASX Announcement 5 June 2020. # Notes to the Consolidated Financial Statements

## 1. Reporting entity

Carnaby Resources Limited (the **Company**) is a for profit company limited by shares and incorporated in Australia, whose shares are publicly traded on the Australian Securities Exchange. The address of the Company's registered office is 78 Churchill Avenue, Subiaco, Western Australia.

The consolidated financial statements of the Company as at and for the period from 1 July 2022 to 30 June 2023 comprise the Company and its subsidiaries (together referred to as the **Group** and individually as **Group Entities**). The nature of the operations and principal activities of the Group are described in the Directors' Report

## 2. Basis of preparation

### (a) Statement of compliance

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards (**AASBs**) (including Australian Interpretations) adopted by the Australian Accounting Standards Board (**AASB**) and the Corporations Act 2001. The consolidated financial report of the Group complies with International Financial Reporting Standards (**IFRSs**) and interpretations adopted by the International Accounting Standards Board (**IASB**).

The financial statements were approved by the Board of Directors on 19 September 2023.

### (b) Basis of measurement

The consolidated financial statements have been prepared on accruals basis under the historical cost convention.

### (c) Functional and presentation currency

These consolidated financial statements are presented in Australian dollars, which is the Company's functional currency.

### (d) Use of estimates and judgements

Set out below is information about assumptions and estimation uncertainties that have a significant risk of resulting in a material adjustment within the next financial year.

#### (i) Restoration obligations

Significant estimation is required in determining the provision for site restoration as there are many factors that may affect the timing and ultimate cost to rehabilitate sites where construction, mining and/or exploration activities have taken place. These factors include future development and exploration activities, changes in the cost of goods and services required for restoration activities and changes to the legal and regulatory framework governing restoration obligations. These factors may result in future actual expenditure differing from amounts currently provided. Refer to note 16 for further information.

#### (ii) Share-based payment transactions

The Company measures the cost of equity-settled transactions and cash-settled share-based payments with employees and third parties by reference to the fair value of the equity instruments at the date at which they are granted. The fair value at the grant date is determined using the Black and Scholes option pricing model taking into account the terms and conditions upon which the instruments were granted and the assumptions detailed in note 20.

## 3. Significant accounting policies

### (a) Basis of consolidation

#### (i) Subsidiaries

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The financial statements of subsidiaries are included in the consolidated financial statements from the date on which control commences until the date on which control ceases.

#### (ii) Transactions and balances eliminated on consolidation

Intra-group balances, and any unrealised income and expenses arising from intra-group transactions, are eliminated in preparing the consolidated financial statements.

**(iii) Acquisitions of subsidiaries*****Business combinations***

In each transaction that results in the acquisition of a subsidiary, the Company determines if AASB 3 'Business Combinations' shall apply to the transaction by assessing if the Company has acquired a "business". A business is an integrated set of activities that is capable of being managed to provide a return to investors by way of dividends, lower costs or other economic benefits. A business generally consists of inputs, processes applied to those inputs and the ability to create outputs. If the Company determines that the acquisition results in the acquisition of a business, then the Company applies the requirements of AASB 3 to the acquisition.

***Asset acquisitions***

If the Company determines that the acquired subsidiary does not constitute a business, then the transaction is accounted for as an acquisition of an asset (or group of assets) that do not constitute a business combination within the scope of AASB 3. In the acquisition of a group of assets, the cost of the acquisition is allocated between the individual assets and liabilities in the group based on their relative fair values at the date of acquisition.

**(b) Segment Reporting**

The Group determines and presents operating segments based on the information that is provided to the board of directors, who are the Group's chief operating decision makers.

An operating segment is a component of the Group that engages in business activities from which it may earn revenues and incur expenses, including revenues and expenses that relate to transactions with any of the Group's other components. An operating segment's operating results are reviewed regularly by the Board to make decisions about the allocation of resources to the segment and to assess its performance, and for which discrete financial information is available. Segment results that are reported to the Board include items directly attributable to a segment as well as those that can be allocated on a reasonable basis. Unallocated items comprise predominantly of administrative expenses. Segment capital expenditure is the total cost incurred during the period to acquire property, plant and equipment, and intangible assets other than goodwill.

**(c) Income Tax**

Income tax expense comprises current and deferred tax. Income tax expense is recognised in profit or loss except to the extent that it relates to items recognised directly in equity, in which case it is recognised in equity.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the reporting date, and any adjustment to tax payable in respect of previous years.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. Deferred tax is not recognised for the following temporary differences: the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit, and differences relating to investments in subsidiaries to the extent that it is probable that they will not reverse in the foreseeable future. Deferred tax is measured at the tax rates that are expected to be applied to the temporary differences when they reverse, based on the laws that have been enacted or substantively enacted by the reporting date.

Deferred tax assets and liabilities are offset if there is a legally enforceable right to offset current tax liabilities and assets and they relate to income taxes levied by the same tax authority on the same taxable entity, or on different tax entities, but they intend to settle current tax liabilities and assets on a net basis or their tax assets and liabilities will be realised simultaneously. A deferred tax asset is recognised to the extent that it is probable that future taxable profits will be available against which the temporary difference can be utilised. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realised.

**(d) Goods and Services Tax (GST)**

Revenue, expenses and assets are recognised net of the amount of goods and services tax and equivalent indirect taxes, except where the amount of tax incurred is not recoverable from the taxation authority. In these circumstances, the tax is recognised as part of the cost of acquisition of the asset or as part of the expense. Receivables and payables are stated with the amount of tax included. The net amount of tax recoverable from, or payable to, the taxation authority is included as a current asset or liability in the balance sheet. Cash flows are included in the statement of cash flows on a gross basis. The tax components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the taxation authority is classified as operating cash flows.

**(e) Financial instruments*****Recognition, initial measurement and derecognition***

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instrument and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Financial assets are derecognised when the contractual rights to the cash flows from

the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

### ***Classification of financial assets***

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price in accordance with AASB 15, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets are classified into the following categories upon initial recognition:

- amortised cost;
- fair value through profit or loss (**FVPL**);
- equity instruments at fair value through other comprehensive income (**FVOCI**); and
- debt instruments at fair value through other comprehensive income (**FVOCI**).

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The Group's business model for managing the financial asset; and
- The contractual cash flow characteristics of the financial assets.

### ***Subsequent measurement financial assets***

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows; and
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Group's financial assets comprise cash and cash equivalents, restricted cash and trade and other receivables.

### ***Impairment of financial assets***

AASB 9's impairment requirements use more forward looking information to recognise expected credit losses (the 'expected credit losses (**ECL**) model'). Instruments within the scope of the new requirements included loans and other debt-type financial assets measured at amortised cost and FVOCI, trade receivables, contract assets recognised and measured under AASB 15 and loan commitments and some financial guarantee contracts (for the issuer) that are not measured at fair value through profit or loss.

The Group considers a broader range of information when assessing credit risk and measuring expected credit losses, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk (**Stage 1**); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low (**Stage 2**).

'Stage 3' would cover financial assets that have objective evidence of impairment at the reporting date.

'12-month expected credit losses' are recognised for the first category while 'lifetime expected credit losses' are recognised for the second category.

Measurement of the expected credit losses is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

### ***Classification and measurement of financial liabilities***

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Group designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss (other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

#### **(i) Non-derivative financial instruments**

The following summarises the accounting treatment of the Group's non-derivative financial instruments;

##### ***Cash and cash equivalents***

Cash and cash equivalents comprise cash at bank, cash on hand and short term deposits at call. Short term deposits have original maturities of 3 months or less that are readily convertible to known amounts of cash and are subject to insignificant risk of changes in fair value.

##### ***Restricted cash***

Restricted cash comprises cash at bank and short term deposits that have been given as security. As the Group has given security over these balances they are not eligible for recognition as cash and cash equivalents.

##### ***Trade and other receivables***

The Group makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. The Group uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix. The Group assess impairment of trade receivables on a collective basis as they possess credit risk characteristics based on the days past due.

##### ***Trade and other payables***

Trade and other payables are carried at amortised cost. The amounts are unsecured and are typically settled in 30 to 60 days of recognition. Due to their short term nature, balances are generally not discounted.

#### **(ii) Share capital**

##### ***Ordinary shares***

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

##### ***Dividends***

Dividends are recognised as a liability in the period in which they are declared.

#### **(f) Impairment of non-financial assets**

The carrying amounts of the Group's non-financial assets (excluding deferred tax assets and inventories) are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists then the asset's recoverable amount is estimated. The recoverable amount of an asset or CGU is the greater of its value in use and its fair value less costs to sell. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. For the purpose of impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or groups of assets, known as CGU's.

An impairment loss is recognised if the carrying amount of an asset or its CGU exceeds its recoverable amount. Impairment losses are recognised in profit or loss. Impairment losses recognised in respect of CGU's are allocated to reduce the carrying amount of assets in the unit (group of units) on a pro rata basis. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

#### **(g) Property, plant and equipment**

##### **(i) Recognition and measurement**

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

Gains and losses on disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment and are recognised net within other income or other expenses in profit or loss. When re-valued assets are sold, the amounts included in the revaluation reserve are transferred to retained earnings.

## (ii) Subsequent costs

The cost of replacing part of an item of property, plant and equipment is recognised in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Group and its cost can be measured reliably.

The carrying amount of the replaced part is derecognised. The costs of the day-to-day servicing of property, plant and equipment are recognised in profit or loss as incurred.

## (iii) Depreciation

Depreciation is charged to the statement of profit and loss and other comprehensive income on a straight line basis over the estimated useful lives of each asset. In the current and comparative periods, useful lives are as follows:

- plant and equipment      2 - 20 years
- fixtures and fittings      5 - 10 years

Depreciation methods, useful lives and residual values are reviewed at each reporting date.

## (h) Leases

### *The Group as a lessee*

For any new contracts, the Group considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition the Group assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group;
- the Group has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract; and
- the Group has the right to direct the use of the identified asset throughout the period of use. The Group assess whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Group depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Group also assesses the right-of-use asset for impairment when such indicators exist.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments.

When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

The Group has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these are recognised as an expense in profit or loss on a straight-line basis over the lease term.

### *The Group as a lessor*

As a lessor the Group classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset, and classified as an operating lease if it does not.

**(i) Employee benefits**

***Share based payments***

The Group operates an equity-settled share based payment employee option scheme. Refer to note 3(p) for further discussion.

***Defined contribution plans***

A defined contribution plan is a post-employment benefit plan under which an entity pays fixed contributions into a separate entity and will have no legal or constructive obligation to pay further amounts. Obligations for contributions to defined contribution plans are recognised as a personnel expense in profit or loss when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in future payments is available.

***Short term benefits***

Short-term employee benefits are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Group has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

***Long-term benefits***

The Group's net obligation in respect of long-term employee benefits is the amount of future benefit that employees have earned in return for their service in the current and, where applicable, prior periods plus related on costs; that benefit is discounted to determine its present value and the fair value of any related assets is deducted. The discount rate is the yield at the reporting date on high quality corporate bonds that have maturity dates approximating the terms of the Group's obligations.

**(j) Provisions**

A provision is recognised if, as a result of a past event, the Group has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability.

***Site restoration***

Site restoration costs include the costs of dismantling and demolition of infrastructure or decommissioning, the removal of residual material and the remediation of disturbed areas specific to the site. Provisions are recognised at the time that the environmental disturbance occurs. The provision is the best estimate of the present value of the future cash flows required to settle the restoration obligation at the reporting date, based on current legal requirements and technology. Future restoration costs are reviewed annually and any changes are reflected in the present value of the restoration provision at the end of the financial year.

The amount of the provision for future restoration costs is recognised as exploration and evaluation assets during the exploration phase according to the Company's policy for exploration and evaluation assets (refer note 3 (n)). Upon the commencement of commercial production, future restoration costs are recognised as mine property assets.

Future restoration costs are depreciated on a unit-of-production basis over the economically recoverable reserves of the mine concerned, resulting in an amortisation charge proportional to the depletion of the economically recoverable mineral resources. Amortisation begins at the commencement of commercial production. The unwinding of the effect of discounting on the provision is recognised as a finance cost. Restoration expenditure is capitalised to the extent that it is probable that the future economic benefits associated with restoration expenditure will flow to the Group.

**(k) Foreign currency**

***Foreign currency transactions***

Transactions in foreign currencies are translated to the functional currency of the operation at exchange rates at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies at balance sheet date are translated to the presentation currency at the balance date at the exchange rate at that date. The foreign currency gain or loss on monetary items is the difference between amortised cost in the functional currency at the beginning of the period, adjusted for the effective interest and payments during the period, and the amortised cost in foreign currency translated at the exchange rate at the end of the period.

Non-monetary assets and liabilities denominated in foreign currencies that are measured at fair value are retranslated to the functional currency at the exchange rate at the date that the fair value was determined. Non-monetary items in a foreign currency that are measured in terms of historical cost are measured using the exchange rate at the date of the transaction.

Foreign currency differences arising on retranslation are recognised in profit or loss, except for qualifying cash flow hedges which are recognised in the other comprehensive income to the extent the hedge is effective.

***Foreign operations***

The assets and liabilities of foreign operations, including goodwill and fair value adjustments arising on acquisition, are translated to Australian dollars at exchange rates at reporting date. The income and expenses of foreign operations are translated to Australian dollars at average exchange rates prevailing during the period. Foreign currency differences are recognised in the foreign currency

translation reserve. When a foreign operation is disposed of, in part or in full, the relevant amount in the foreign currency translation reserve is transferred to the income statement.

**(l) Finance income and expense**

Finance income and expense comprises interest income and foreign currency gains or losses. Foreign currency gains and losses are reported on a net basis.

**(m) Revenue**

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are net of returns, trade allowances, rebates and amounts collected on behalf of third parties. Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured.

Revenue is recognised at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

***Revenue from Contracts with Customers***

To determine whether to recognise revenue, the Group follows a five-step method established by AASB 15: 1. Identifying the contract with a customer; 2. Identifying the performance obligation in the contract; 3. Determining the transaction price; 4. Allocating the transaction price to the performance obligations in the contract; and 5. Recognise revenue when/as performance obligations are satisfied.

Revenue is recognised, based on the transaction price allocated to the performance obligation, after consideration of the terms of the contract and customary business practices and control of the asset passes to the customer. The transaction price is the amount of the consideration that the Group expects to be entitled to receive in exchange for transferring the promised goods or services to a customer, excluding amounts collected on behalf of third parties (ie sales taxes and duties). The consideration promised in a contract with a customer may include fixed amounts, variable amounts or both.

***Interest income***

Specifically in relation to interest income; revenue from interest is recognised on a time proportionate basis, taking into account the effective yield on the related financial asset.

**(n) Exploration and evaluation expenditure**

Exploration and evaluation expenditure, excluding acquisition costs, are expensed as incurred. Acquisition costs are accumulated in respect of each separate area of interest.

Acquisition costs include:

- (i) Consideration paid to acquire exploration and/or mining license's;
- (ii) Stamp duty;
- (iii) Professional fees attributable the acquisition; and
- (iv) Site restoration costs assumed or recognised.

Exploration and evaluation assets are only recognised if the rights to the area are current and either:

- (i) the acquisition costs are expected to be recouped through successful development and exploitation of the area of interest; or
- (ii) activities in the area of interest have not at the reporting date, reached a state which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves and active and significant operations in, or in relation to, the area of interest are continuing.

Exploration and evaluation assets are assessed for impairment if:

- (i) sufficient data exists to determine technical feasibility and commercial viability; and
- (ii) facts and circumstances suggest the carrying amount exceeds the recoverable amount.

For the purposes of impairment testing, exploration and evaluation assets are allocated to CGU's to which the exploration activity relates. The CGU shall not be larger than the area of interest.

Once technical feasibility and commercial viability of the extraction of mineral resources in an area of interest are demonstrable, exploration and evaluation assets attributable to that area of interest are first tested for impairment and then reclassified to mine property assets within property, plant and equipment.

In the event that an area of interest is abandoned or if the directors consider the exploration and evaluation assets attributable to the area of interest to be of reduced value, the exploration and evaluation assets are impaired in the period in which the assessment is

made. Each area of interest is reviewed at each reporting period and accumulated costs are written off to the extent that they will not be recoverable in the future.

#### **(o) Earnings per share**

The Group presents basic and diluted earnings per share (**EPS**) data for its ordinary shares. Basic EPS is calculated by dividing the profit or loss attributable to ordinary shareholders of the Company by the weighted average number of ordinary shares outstanding during the period. Diluted EPS is determined by adjusting the profit or loss attributable to ordinary shareholders and the weighted average number of ordinary shares outstanding for the effects of all dilutive potential ordinary shares.

#### **(p) Share based payment transactions**

##### ***Employee benefits***

The Group operates equity-settled share based payment employee option scheme. The fair value of the equity to which employees become entitled is measured at grant date and recognised as an expense over the vesting period, with a corresponding increase to share based payments reserve. The fair value of options is ascertained using a recognised pricing model which incorporates all market vesting conditions. The fair value of options is measured using the Black-Scholes formula.

Measurement inputs include share price on measurement date, exercise price of the instrument, expected volatility (based on weighted average historic volatility adjusted for changes expected due to publicly available information), weighted average expected life of the instruments (based on historical experience and general option holder behaviour), expected dividends, and the risk-free interest rate (based on government bonds). Service and non-market performance conditions attached to the transactions are not taken into account in determining fair value.

The cost of share based payment transactions is recognised, together with a corresponding increase in equity, over the period in which the performance conditions are fulfilled, ending on the date on which the relevant employees become fully entitled to the award (vesting date). The cumulative expense recognised for share based payment transactions at each reporting date until vesting date reflects (i) the extent to which the vesting period has expired and (ii) the number of awards that, in the opinion of the directors of the Company, will ultimately vest. This opinion is formed based on the best available information at balance date. No adjustment is made for the likelihood of market performance conditions being met as the effect of these conditions is included in the determination of fair value at grant date.

No expense is recognised for awards that do not ultimately vest, except for awards where vesting is conditional upon a market condition. Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. However, if a new award is substituted for the cancelled award, and designated as a replacement award on the date that it is granted, the cancelled and new award are treated as if they were a modification of the original award.

##### ***Other share based payments***

The Group has entered into equity-settled share based payment transactions with non-employees of the Company. The cost of equity-settled transactions with non-employees is measured by reference to the fair value of goods and services received unless this cannot be measured reliably, in which case the cost is measured by reference to the fair value of the equity instruments granted.

#### **(q) New accounting standards, amendments and interpretations**

##### ***New accounting standards***

Certain new accounting standards and interpretations have been published that are not mandatory for 30 June 2023 reporting periods and have not been early adopted by the group. These standards are not expected to have a material impact on the entity in the current or future reporting periods and on foreseeable future transactions. There are no other standards that are not yet effective and that are expected to have a material impact on the Group in the current or future reporting period and in the foreseeable future.

##### ***Issued but not yet effective for these financial statements***

At the date of authorisation of these financial statements, several new, but not yet effective, Standards and amendments to existing Standards, and Interpretations have been published by the IASB. None of these Standards or amendments to existing Standards have been adopted early by the Group.

Management anticipates that all relevant pronouncements will be adopted for the first period beginning on or after the effective date of the pronouncement. New Standards, amendments and Interpretations not adopted in the current year have not been disclosed as they are not expected to have a material impact on the Group's financial statements.

#### 4. Financial risk management

This note presents information about the Group's exposure to credit, liquidity and market risks and objectives, policies and processes for measuring and managing financial risk and the management of capital.

The Group does not use any form of derivatives as it is not at a level of exposure that requires the use of derivatives to hedge its exposure. Exposure limits are reviewed by management on a continual basis. The Group does not enter into or trade financial instruments, including derivatives, for speculative purposes.

The Board of Directors has overall responsibility for the establishment and oversight of the risk management framework. Management monitors and manages the financial risks relating to the operations of the Group through regular reviews of the risks.

##### (a) Credit risk

Credit risk is the risk of financial loss to the Group if a customer or counterparty to a financial instrument fails to meet its contractual obligations and arises principally from the Group's cash and cash equivalents, restricted cash and trade and other receivables.

##### *Cash, cash equivalents*

Cash and cash equivalents comprise cash on hand and demand deposits. The Group limits its credit risk by holding cash balances and demand deposits with reputable counterparties with acceptable credit ratings.

##### *Restricted cash*

Restricted cash comprises cash balances used as security for the Company's transactional bank facilities. Cash balances used as security are held with reputable counterparties with acceptable credit ratings.

##### *Trade and other receivables*

The Group's trade and other receivables are neither past due nor impaired.

##### *Exposure to credit risk*

The carrying amount of the Group's financial assets represent maximum exposure to credit risk, as follows:

##### (b) Liquidity risk

Liquidity risk is the risk that the Group will not be able to meet its financial obligations as they fall due. The Group's approach to managing liquidity is to ensure, as far as possible, that it will always have sufficient liquidity to meet its liabilities when due, under both normal and stressed conditions, without incurring unacceptable losses or risking damage to the Group's reputation. The Group manages liquidity risk by maintaining adequate cash reserves from funds raised by the Company in various capital raisings and continuously monitoring forecast and actual cash flows.

### (c) Market risk

Market risk is the risk that changes in market prices, such as foreign exchange rates, interest rates and equity prices will affect the Group's income or the value of its holdings of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimising the return.

The Group is exposed to market risk in the form of fluctuations in interest rates.

#### *Interest rate risk*

Interest rate risk is the risk that a financial instrument's value will fluctuate as a result of changes in the market interest rates on interest-bearing financial instruments. The Group is exposed to interest rate risk on cash and cash equivalents and restricted cash. The Group does not use derivatives to mitigate these exposures.

Cash and cash equivalents and restricted cash (together "cash") are held at variable and fixed interest rates. Cash in term deposits are held for fixed terms at fixed interest rates maturing in periods less than twelve months. The Group's other cash balances are held in deposit accounts at variable rates with no fixed term.

Subsequent to the period, the Group announced the signing of a Farm-in and Joint Venture Agreement with Rio Tinto Exploration Pty Ltd (RTX), a subsidiary of Rio Tinto Limited (ASX: RIO), which adds a high quality advanced exploration target and greatly expands the land position of the Greater Duchess Copper Gold Project in Mt Isa, Queensland.<sup>36</sup> The Group can achieve a 51% joint venture interest in the Devoncourt Project (Figure 2) by sole funding A\$5,000,000 of exploration by 1 August 2028 in accordance with the following conditions:

1. The Group to make an up-front payment of A\$100,000 to RTX and may elect to make the payment in either cash or fully paid ordinary shares in the Company.
2. As part of the expenditure commitment, the Group must complete a minimum of 4,000m of diamond core and/or reverse circulation (RC) drilling.
3. The Group undertakes a minimum expenditure commitment of A\$500,000 including 2,000m of diamond core and/or RC drilling by 1 August 2025 before it can withdraw from the agreement.

Scope is present in the agreement for the Group to earn an additional 29% interest in the Project through the completion of further exploration milestones.


