## Annual General Meeting Update and Accessing Share Registry Communication Update Centre

Bentley Capital Limited (ASX:BEL) (**Bentley**) advises that:

- (1) The Company's Annual General Meeting (AGM) is scheduled for Thursday, 16 November 2023, in Perth, Western Australia.
- (2) The closing date for the receipt of nominations of candidates for election as a Director of the Company at the AGM is 5:00pm (Perth time) on Tuesday, 10 October 2023.
- (3) In relation to communication of the Notice of AGM and Explanatory Statement (**Notice of AGM**) and Annual Report to shareholders:
  - (a) A hard-copy Notice of AGM and Annual Report will only be posted to those shareholders who have elected to receive a hard-copy by mail;
  - (b) Shareholders who have registered their email with the Share Registry will receive emails containing a link to an Advanced Share Registry portal where they can download a copy of the Annual Report and the Notice of AGM (and vote online);
  - (c) All other shareholders (ie. those who have not provided an email address or elected to receive a hard-copy) will receive only a personalised Proxy Form by mail, which will contain details to:
    - (i) access the Advanced Share Registry portal where they can download a copy of the Annual Report and Notice of AGM (and vote online); or
    - (ii) lodge their Proxy Form by mail, hand delivery or facsimile; and
  - (d) A copy of the Notice of AGM and Annual Report will also be released on ASX at this time and may be viewed and downloaded from the ASX website ([www.asx.com.au](http://www.asx.com.au)) under ASX code "BEL" or the Company's website: [www.bel.com.au](http://www.bel.com.au).
