### **SaaS Transport Management Contract Signed with Comlink**

**Orcoda Limited (ASX: ODA)** (**'Orcoda'** or **'the Company'**), the integrated smart technology company in transport logistics optimisation and transport infrastructure, is pleased to announce that its wholly-owned subsidiary Orcoda Healthcare and Transport Logistics Pty Ltd has signed a SaaS supply contract with Comlink Australia Ltd (**'Comlink'**).

Comlink, based on the Sunshine Coast, Queensland, has provided aged care and community services along the coastal region in South East Queensland for more than 30 years. It is one of the largest, most trusted and most experienced providers of community transport and operates a substantial vehicle fleet.
