An announcement was made to the ASX on 26 June 2023 with a planned entitlement issue of \$1.89m. In addition, an announcement was made to the ASX on 26 June 2023 confirming the sale of Ragnar Metals Sweden AB to BHP for A\$9.8m.</p>
