### CLEANSING STATEMENT

Dreadnought Resources Limited ("**Dreadnought**" or "**the Company**") advises that a total of 14,550,001 ordinary fully paid shares have been issued on the vesting and exercise of the Class B Performance Rights.

The Class B Performance Rights vested upon the Company announcing a Resource in accordance with the JORC Code of at least the inferred category of 20Mt @ >1% Total Rare Earth Oxide (TREO) by 31 December 2023. On 5 July 2023 the Company announced a 40% increase in Resource tonnage at its 100% owned Mangaroon project delivering 20.06Mt @ 1.03% TREO. For further details about the performance rights, please refer to the announcement dated 17 August 2022 and the Explanatory Statement in the Company's Notice of Annual General Meeting (released to ASX on 31 October 2022).

The Company relies on section 708A of the Corporations Act 2001 (Cth) (**the Act**) in relation to the Issue.
