

## Environmental Approvals Update

De Grey Mining Limited (ASX: DEG, "**De Grey**" or "**Company**") is pleased to advise that the Company has received notice from the Western Australian Environmental Protection Authority ("**EPA**") in relation to the Section 38 Referral (*Environmental Protection Act WA 1986*) assessment outcome for the Hemi Gold Project ("**Hemi**" or "**Project**").

Today the EPA has advised that Hemi will be assessed on referral information (with certain additional information), followed by a public review process. This approval pathway was incorporated into the timeline for the development of Hemi in the recently released Definitive Feasibility Study ("**DFS**").

This outcome allows for timely development of secondary approvals and De Grey will continue to work closely with regulators, including at a federal level, to satisfactorily conclude the approvals process in support of the future development of the Project.
