Answer: No. The Company anticipates a reduction in corporate and administration costs in the coming quarters following a streamlining of board and management.

Answer: The Company has recently completed a capital raise of \$2.55m before costs. The Company has historically demonstrated an ability to raise capital to further its exploration programs, and has a further \$0.6m available in liquid investments.
