Labour Cost = 4-6 minutes

Visibility = Full

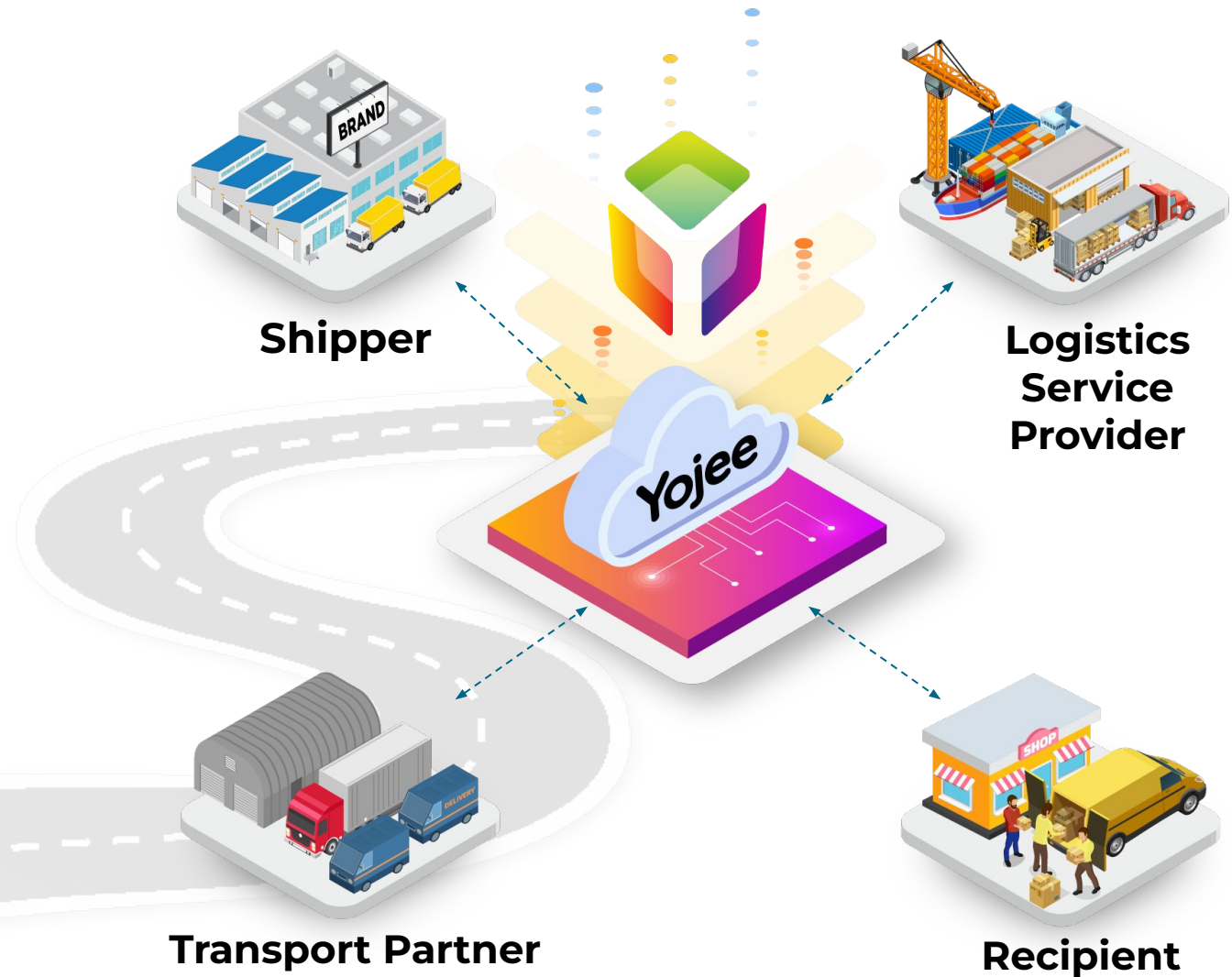
Time to Invoice = Immediate
