NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Norwood Systems Ltd (Norwood or the Company) (ASX: NOR) has completed an allotment in the Company of 4,150,887 fully paid ordinary shares in the capital of the Company (Shares). 4,150,887 shares were issued on 7th June 2023 on conversion of 4,150,887 options exercisable at 2.4 cents each with an expiry date of 31 December 2023. The options were exercised by Balmain Resources Pty Ltd, a company in which Director, Dr John Tarrant is a sole director and sole shareholder. These Shares are included in an Appendix 2A lodged on 7th June for 12,000,000 Shares.
