No. Until completion of the capital raising (announced 9 June 2023), exploration expenditure has and will reduce and as a result, the current level of net operating cash flows will reduce.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

Yes. As announced on 9 June 2023, the Company is undertaking a capital raising via a Share Purchase Plan to raise \$1.5 million (before costs). In the event less than \$1.5 million is raised via the Share Purchase Plan, Directors intend to place the balance via a shortfall offer.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, the Company believes that it is able to continue its current operations and business objectives for the reasons outlined in questions 8.8.1 and 8.8.2 above.
