CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT


As announced on 29 November 2022, W.A Kaolin Limited (Company) secured a \$7.5m funding package for further Stage 2 investment and working capital at its Wickepin Kaolin Project located in Wickepin, Western Australia.

The Company completed a placement of 33,333,333 fully paid ordinary shares in the capital of the Company as part of the overall funding package to raise \$5m. The related Appendix 2A was also lodged today.
