Update on Performance Rights

Nanoveu Limited ("Nanoveu" or the "Company") is pleased to advise that a production run of its antiviral products are being applied to Android phones by a mobile phone manufacturer based in South East Asia. This completes the vesting hurdle for the Tranche D Performance Rights, being "Completion of production of the first three Android models of at least 100,000 units", with 221,500 ordinary shares being issued.

The remaining 50% of Tranche D Performance Rights will vest 12 months after achievement of this performance hurdle as long as the respective participant remains with the Company 12 months after achievement of this performance hurdle.

Performance rights are used to incentivise the Nanoveu team and form part of their remuneration.

About Nanoveu:

Nanoveu is an ASX-listed technology company developing a range of products for mobile phones and other digital displays. The Company's wholly-owned, flagship product is its Nanoshield antiviral protection which is available in a variety of mobile phone screen covers, mobile phone cases and as a commercial film capable of being applied to a number of surfaces. The product is a clear plastic containing a layer of charged copper nanoparticles which have antiviral and antimicrobial properties. The product is commercially available and sold in a number of countries via Nanoveu's channel partners. Nanoveu also produces EyeFly3D™, which converts 2D digital



displays into 3D without the need for 3D glasses and is currently available for Apple iPhones and Google Pixel 3 phones.

In addition, the Company is also developing the following products:

- Customskins: vending machines capable of precisely applying screen covers to mobile phones in just over a minute and with an alignment accuracy of 150 microns;
- EyeFyx: a vision correction solution under development using hardware and software to manipulate screen output; and
- Anti-reflective coating technology capable of being applied to mobile phones, tablets, automotive displays and other digital displays.
