Termination	<p>Each Party may, by written notice to the other Party terminate the Agreement with immediate effect if:</p> <ul style="list-style-type: none">• The other Party has committed a material breach of the Agreement and has not rectified the same within 14 days of receipt of a written notice to that effect;• The other Party has committed a material breach of the Agreement which is not capable of cure; or• The other Party's assets become the subject of an insolvency proceeding, or the other Party goes into liquidation, suspends payment of its debts or can otherwise be deemed to be insolvent.
