Introduction

Australian Vanadium Ltd (ASX: AVL) (**AVL** or the **Company**) is pleased to provide Eligible Shareholders the opportunity to subscribe for up to \$30,000 of New Shares under a share purchase plan on the terms and conditions set out in this document (**SPP Offer**). Participation in the SPP Offer will not incur brokerage or transaction costs. This document has been issued by AVL and explains the features of the SPP Offer.

Australian Vanadium Ltd Share Purchase Plan Offer

On behalf of the Directors of Australian Vanadium Ltd (**AVL** or the **Company**), I am pleased to offer you the opportunity to participate in the Company's SPP Offer. Under the SPP Offer, you can acquire up to \$30,000 worth of New Shares without paying any brokerage or transaction costs.

The Offer Price represents a discount of 17.5% to AVL's closing Share price on the ASX on Tuesday, 17 May 2022 (being the last day on which AVL Shares traded before the SPP was announced) and a 17.4% discount to the volume weighted average price over the last five days on which AVL Shares traded immediately prior to announcement of the SPP Offer.

The Offer Price of New Shares offered under the SPP Offer is the same as the issue price of New Shares offered under the terms of the Company's placement to institutional and sophisticated investors announced on Friday, 20 May 2022, which received binding commitments for approximately \$20 million (before costs) (**Placement**).

AVL is seeking to raise up to a further \$7.5 million (before costs) under the SPP Offer, with the capacity to accept oversubscriptions. The Company reserves the right to close the SPP Offer early and/or to scale back applications on the basis set out in the Terms and Conditions accompanying this document. Any excess funds will be returned to applicants without interest.

As previously announced on Friday, 20 May 2022, the funds raised under the Placement and SPP will be used to fund ongoing work at the Company's Australian Vanadium Project and to develop key downstream markets ahead of finalising debt financing and a Final Investment Decision, and for working capital (including costs). Further details of the proposed use of funds are set out in the Company's announcement and investor presentation released to the ASX on Friday, 20 May 2022.

Do I have to participate in the SPP Offer?	<p>No. Participation is voluntary.</p> <p>Before making a decision whether or not to accept the SPP Offer, you should consult your financial or other professional adviser.</p> <p>If you do not wish to participate in the SPP Offer, you do not need to do anything, and the SPP Offer will lapse at 5.00pm (Perth time) on Thursday, 16 June 2022 (unless varied or extended).</p>

Can a third party participate in the SPP Offer in my place?	<p>No. The SPP Offer is non-renounceable and cannot be transferred.</p>

How much can I invest under the SPP Offer?

The maximum investment under the SPP Offer is \$30,000. You may apply to purchase a parcel of \$1,000, \$2,500, \$5,000, \$7,500, \$10,000, \$15,000, \$20,000, \$25,000 or \$30,000 worth of New Shares.

If AVL receives an application for an amount of New Shares that is not equal to one of the above parcels, or a subscription of over \$30,000 worth of New Shares, by an Eligible Shareholder through multiple or joint holdings, AVL may either:

- reject the application and refund, in full, any application monies (without interest); or
- round down the dollar amount of New Shares that are applied for to the next lowest parcel, and refund the balance of any monies (without interest).

Is there an oversubscription or scale back policy?

AVL is seeking to raise up to \$7.5 million under the SPP Offer. However, AVL may decide to accept applications (in whole or in part) that result in the SPP Offer raising more than that target amount at its absolute discretion, subject to the limits prescribed in the ASX Listing Rules.

In the event that AVL receives valid applications under the SPP Offer in excess of \$7.5 million, AVL reserves the right to:

- accept applications that raise more than this amount; or
- scale back the number of New Shares issued under the SPP Offer,

each in its absolute discretion.

To the extent AVL determines to scale back the number of New Shares that will be issued under the SPP Offer, it is AVL's intention that each applicant will be treated equally and will be scaled back pro rata based on the number of New Shares for which they have applied (subject to any minimum dollar allocation determined by AVL in its absolute discretion).

How will refunds be made?

What is the issue price of New Shares under the SPP Offer?

The Offer Price is \$0.047 per New Share, representing a discount of 17.5% to AVL's closing Share price on the ASX on Tuesday, 17 May 2022 (being the last day on which AVL Shares traded before the SPP Offer was announced).

The Offer Price also represents a 17.4% discount to the volume weighted average price of Shares traded over the last five days on which AVL Shares traded immediately prior to announcement of the SPP Offer, being \$0.0569.

The Offer Price was determined by the Company in consultation with the lead manager in connection with the placement to institutional and sophisticated investors announced on Friday, 20 May 2022 (**Placement**).

There is a risk that the market price of Shares may rise or fall between the date of this document and the time of issue of the New Shares under the SPP Offer. This means that the price you pay for the New Shares issued to you under the SPP Offer may be less than or exceed the market price of Shares on the Allotment Date.

Consequently, it is possible that, between the time you make your application and up to or after the Allotment Date, you may be able to buy Shares on market at a lower price than the Offer Price.

What are the risks associated with the Company?

There are a number of factors which may affect the development, future operation and financial performance and/or financial position of the Company, its prospects, and/or the value of the New Shares. Terms and Conditions

1. SPP Offer

The SPP Offer entitles Eligible Shareholders of AVL to apply to purchase up to \$30,000 worth of Shares through this share purchase plan.

2. Eligibility to participate

- 2.1. You are eligible to participate in the SPP Offer if you were a registered holder of Shares at 5.00pm (Perth time) on Thursday, 19 May 2022 (**Record Date**) with a registered address in Australia (and its external territories) or New Zealand, unless:
 - 2.1.1. you hold Shares on behalf of another person who resides outside Australia (and its external territories) or New Zealand; or
 - 2.1.2. you are, or are acting for the account or benefit of, a person in the United States.
- 2.2. For shareholders with a registered address in New Zealand, you must still be a shareholder at the date of the SPP Offer, that is, Thursday, 26 May 2022.
- 2.3. AVL has determined that it is either unlawful or impracticable for holders of Shares with registered addresses in jurisdictions outside Australia (and its external territories) and New Zealand to participate in the SPP Offer.
- 2.4. If you are the only registered holder of a holding of Shares, but you receive more than one offer (for example, due to multiple registered holdings), you may only apply for a parcel of New Shares with an aggregate value of \$30,000 across those holdings.
- 2.5. Joint holders of Shares will be taken to be a single registered holder of Shares for the purposes of determining whether they are an Eligible Shareholder and a certification under **clause 7.1(I)** by one joint holder will be effective in respect of the other joint holder(s).
- 2.6. If you are a Custodian for a beneficiary or beneficiaries, you may apply for one maximum parcel of New Shares for each beneficiary (or if you are a Custodian for two or more joint beneficiaries, for each such holding as if it was held by a single person). - 2.7. Directors and employees of AVL who hold Shares may be Eligible Shareholders.

3. Rights to apply for New Shares are non-renounceable

If you are an Eligible Shareholder, your rights under the SPP Offer are personal to you and are non-renounceable, which means that you cannot transfer your rights to another person.

4. Offer Price

- 4.1. The Offer Price for each New Share under the SPP Offer is \$0.047.
- 4.2. The Offer Price is fixed, regardless of any changes in the market price of Shares during the SPP Offer period.
- 4.3. You should be aware that the future market price of Shares is uncertain and may rise or fall. This means the price you pay for New Shares under the SPP Offer may be either higher or lower than the Share price trading on the ASX at the time New Shares are issued to you under the SPP Offer.

5. Timing

- 5.1. The SPP Offer opens on Thursday, 26 May 2022 and closes at 5.00pm (Perth time) on Thursday, 16 June 2022, unless varied or extended. Unless the closing date is varied or extended, AVL proposes to allot New Shares on Thursday, 23 June 2022 and send confirmations to shareholders on Friday, 24 June 2022.
- 5.2. AVL reserves the right to vary or extend the SPP Offer or the proposed Allotment Date at any time by making an announcement to ASX.

6. Applying for New Shares

- 6.1. Eligible Shareholders may apply for New Shares in parcels valued at \$1,000, \$2,500, \$5,000, \$7,500, \$10,000, \$15,000, \$20,000, \$25,000 or \$30,000.
- 6.2. The number of New Shares you will receive, at each of the available levels, is set out below. Where applicable, the number of New Shares for each parcel has been rounded down to the nearest whole number of New Shares.

- 6.3. You may not apply for more than \$30,000 of New Shares in aggregate under the SPP Offer, even though you may receive more than one offer, or offers in more than one capacity (eg. due to multiple registered holdings), under the SPP Offer.
- 6.4. If AVL receives an application for an amount of New Shares that is not equal to one of the above parcels, or a subscription of over \$30,000 worth of New Shares, by an Eligible Shareholder through multiple or joint holdings, AVL may (in its absolute discretion) either:
 - (a) reject the application and refund, in full, any application monies (without interest); or
 - (b) round down the dollar amount of New Shares that are applied for to the next lowest parcel, and refund the balance of any monies (without interest).
- 6.5. If you wish to apply for New Shares under the SPP Offer you should either:

- 6.6. Do not forward cash. Receipts for payment will not be issued.

7. Effect of making an application

- 7.1. If you submit a BPAY® payment or make an EFT:
