

Critical Metal Drilling to commence at Wyemandoo

Highlights

- Three Rivers Drilling engaged to complete initial 3,500m at Wyemandoo
- Initial program comprises 48 holes
- Multiple targets exist delineated by the extensive sampling program conducted 2H 2021 showing very high Rubidium grades and anomalous Lithium grades
- Drilling aims to confirm thickness, depth and orientation of surface exposed pegmatites in addition to potential mineralisation content at depth

Aldoro Resources Limited (**Aldoro, the Company**) (**ASX: ARN**) is pleased to provide an update on its upcoming maiden drilling campaign at their Wyemandoo critical metal pegmatite Project.

The Company has recently engaged experienced drilling contractor, Three Rivers Drilling to provide a reverse circulation (**RC**) rig to complete the initial 3,500m at the Wyemandoo Project.

Commencement of drilling at Wyemandoo is expected to occur in the next 5 days, weather permitting.

The initial 48 holes will range from 80m to 150m depth on azimuths of 145 degrees and dips of -60 degrees based on mapping, however pegmatite intercepts may dictate changes.

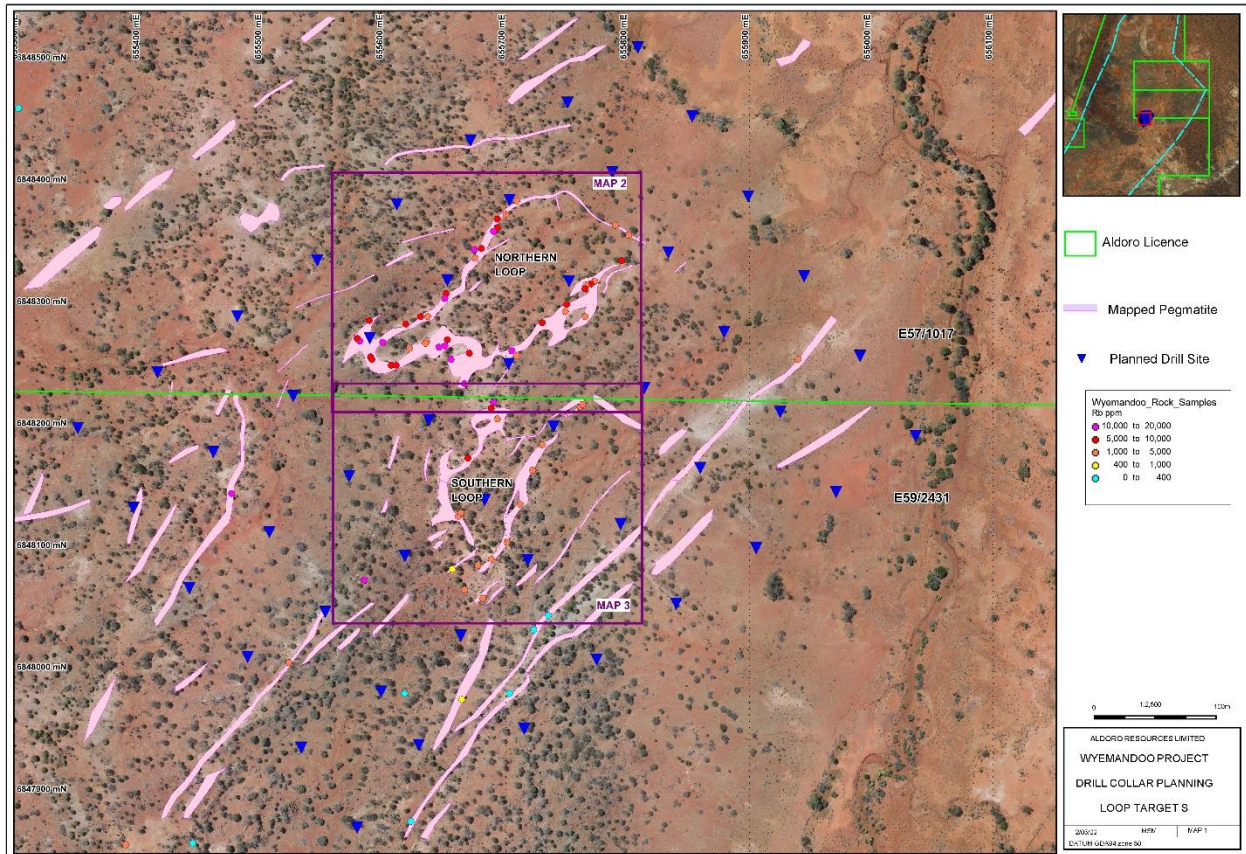


Figure 1. Northern and southern Loop Structures where drilling will commence.

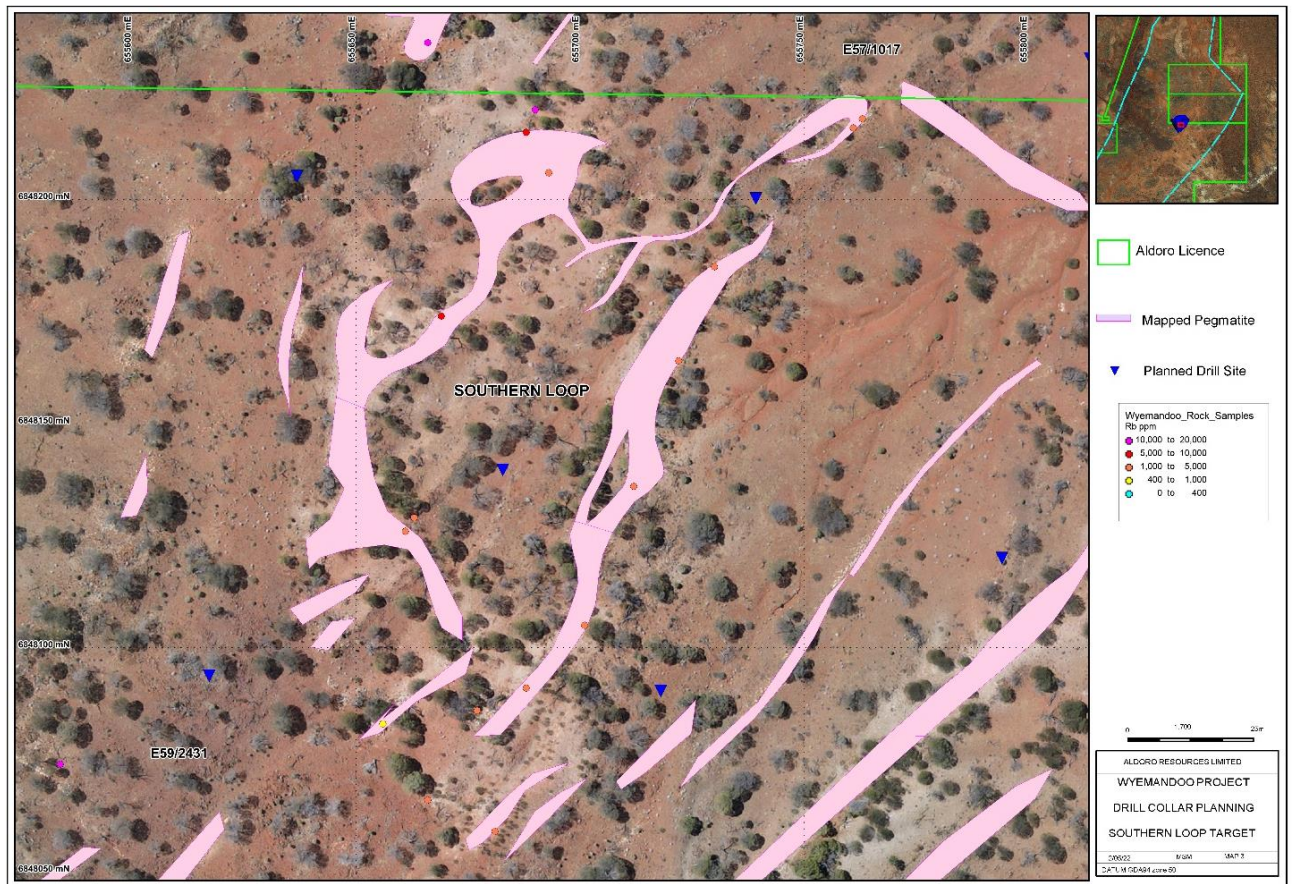


Figure 3. Displaying the South Loop (Map 3), thematic Rb (ppm) and drill collar plan.

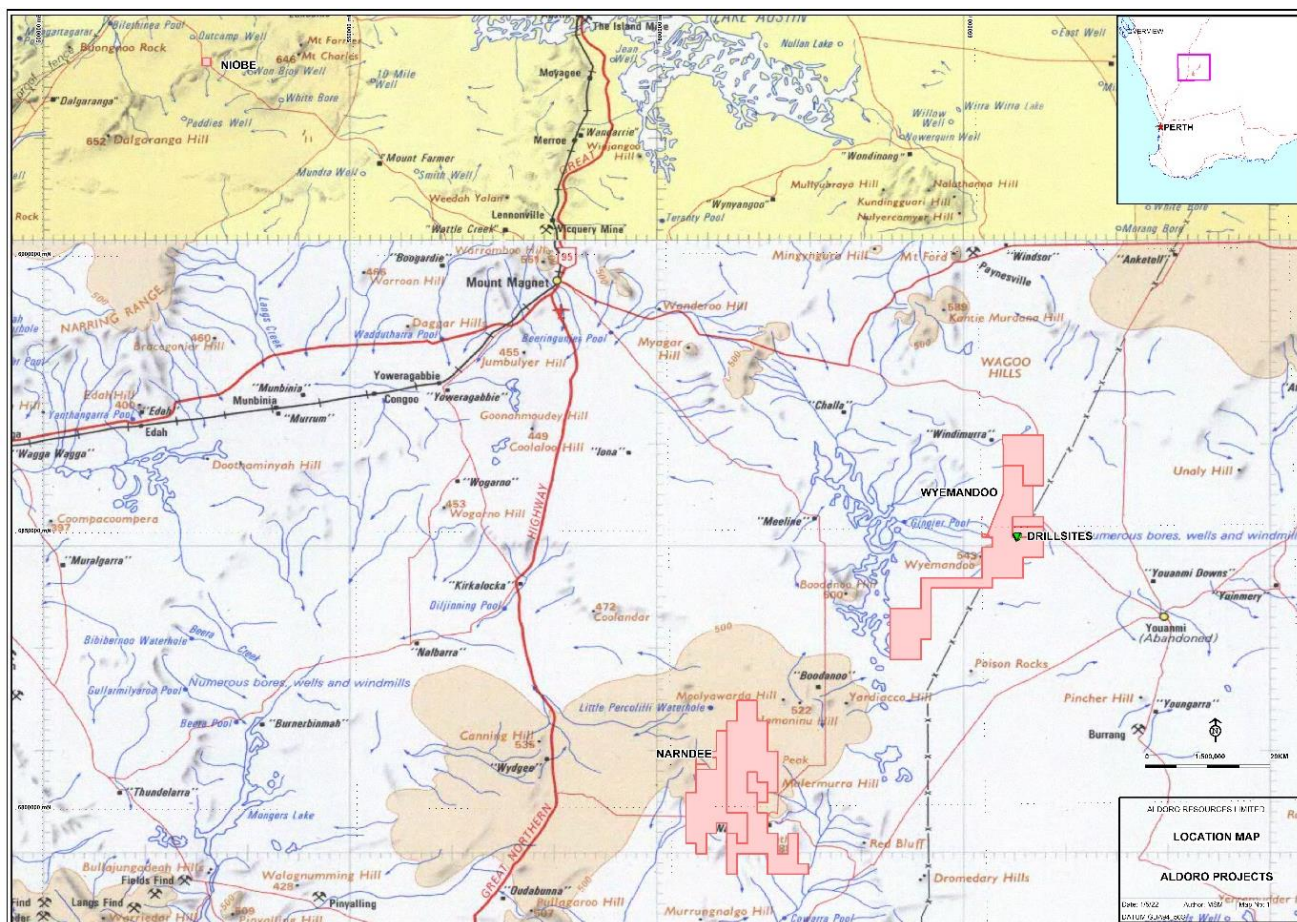


Figure 4. Location of the ARN landholding over the Murchison Terrane.
