SRJ's securities will remain suspended until it has either complied with Chapters 1 and 2 of the Listing Rules under Listing Rule 11.1.3, or provided ASX with sufficient information to satisfy ASX that it should not exercise its discretion under Listing Rule 11.1.2 to require the transaction to be conditional on approval by SRJ's ordinary security holders, and under Listing Rule 11.1.3 to require SRJ to re comply with Chapters 1 and 2 of the Listing Rules.
