## Notice of Annual General Meeting and Proxy Form

Meteoric Resources NL (**ASX: MEI**) (the **Company**) advises that its Annual General Meeting of shareholders to be held on Tuesday, 30 November 2021 at 2:00pm (WST) at Level 1, 33 Ord St, West Perth, WA 6005.

The Board is aware that at present there are significant delays in the Australian postal system due to COVID-19 which may adversely affect both the receipt and return of voting forms by Shareholders. In accordance with the Treasury Laws Amendment (2021 Measures No. 1) Act 2021, the Company will not dispatch physical copies of the Notice of Annual General Meeting and Explanatory Statement. Instead, these documents will be emailed to all Shareholders who have provided an email address to the Company's share registrar and are otherwise available on the ASX company announcements platform at <https://www2.asx.com.au/markets/trade-our-cash-market/historical-announcements> under the ASX code of "MEI".

If you have not elected to receive your notices by email, a copy of your personalized proxy form is enclosed for your convenience. Your proxy voting instructions must be received by no later than by 2:00pm (WST) on 28 November 2021, being not less than 48 hours before commencement of the Meeting. Any proxy instructions received after that time will not be valid for the Meeting.

You may vote by attending the Meeting in person, by proxy or by appointing an authorised representative. All resolutions at the Meeting will be voted on by poll and Shareholders who are entitled to vote may vote either at the Meeting by poll or prior to the Meeting by appointing a proxy.

**Shareholders are strongly encouraged to either vote prior to the Meeting  
or to appoint the Chair as their proxy.**
