

## **Cleansing Notice – Section 708A(5)(e) and 708A(6)**

This notice is given by Forrestania Resources Limited ((ASX: FRS) (**Company**) under section 708A(5)(e) and 708A(6) of the Corporations Act 2001 (Cth) (**Act**).
