Results of General Meeting

White Cliff Minerals Limited (**White Cliff** or the **Company**) wishes to advise shareholders that in accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act, the following information is provided in respect of each resolution considered and voted upon at the General Meeting held today.

The total number of proxy votes exercisable by proxies validly appointed was 112,944,131 shares from the validly appointed proxies of 93 shareholders. All resolutions were decided by way of a Poll.

Commenting on the overwhelming support from shareholders, White Cliff Technical Director Ed Mead said:

"Shareholder approval was the remaining condition precedent for the acquisition of 100% of Magnet Resource and Preston River, so we will shortly move to completion of the transactions. We firmly believe in the prospectivity of both the Company's new tenement applications and those we are acquiring through the transaction with Magnet and Preston.

"We will shortly announce a systematic exploration plan for the Company's wholly-owned Lithium and REE projects. we are also looking forward to the results from the recent RC drilling program at Reedy South, which will guide follow-up exploration across the wider project area."

This announcement has been approved by the Board of White Cliff Minerals Limited.
