



First Tranche of Placement to Raise \$11 Million Completes

Eagle Mountain Mining Limited (ASX:EM2) ("Eagle Mountain" or "the Company") is pleased to confirm that the first tranche of its recently announced placement (ASX 22 February 2021) raising \$11 million before costs has settled.

The first tranche of the Placement to institutional and sophisticated investors **which raised \$9 million before costs through the allotment of 25,714,286 shares at 35 cents** has been completed.

As previously advised an entity associated with Mr Charles Bass the Company's Managing Director and major shareholder will be taking the balance of the placement, subject to shareholder approval. The Company will be circulating a Notice of Meeting for Shareholders in due course.

The first tranche of the Placement was completed pursuant to the Company's security issue capacities under Listing Rule 7.1 and 7.1A. A total of 10,251,998 Shares were issued pursuant to Listing Rule 7.1 and 15,462,288 Shares issued pursuant to Listing Rule 7.1A. Further details of the Placement are included in the Appendix 3B lodged with ASX on 22 February 2021.

PAC Partners and Taylor Collison acted as Joint Lead Managers ("JLM") to the placement and Canaccord Genuity acted as Co-Manager.

Eagle Mountain's Chief Executive Officer, Tim Mason said:

"Eagle Mountain is extremely pleased with the strong interest in the Placement, we would like to thank existing shareholders for their continued support and welcome several prominent institutional and sophisticated investors to the Eagle Mountain share register for the first time. As previously advised, the Company plans to use these funds to continue its diamond drilling at Oracle Ridge; build on the sound technical and administrative skill within the Company; and potentially expand its prospective landholdings in Arizona."

In addition to the completion of the first tranche of the Placement, the Company has issued 160,000 ordinary shares to staff incorporating an incentive share issue and shares issued pursuant to vested performance rights in accordance with their terms.
