## Health House International Limited – (ASX: HHI) – Formerly VPCL Ltd – Anticipated Reinstatement to Official Quotation

### Description

The securities of Health House International Limited ('HHI') are expected to be reinstated to Official Quotation at the commencement of trading at 10:04:30am AEST on Friday, 16 April 2021, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. HHI raised \$3,500,000 pursuant to the offer under its prospectus dated 21 January 2021 ('Prospectus') by the issue of 17,500,000 shares at an issue price of \$0.20 per share.
