## ASX ANNOUNCEMENT

### **Extension of Offer Period**

Odin Energy Ltd ("Odin" or "Company") lodged a Replacement Prospectus with ASIC on 12<sup>th</sup> October 2016 ("Replacement Prospectus"), to raise up to \$8,000,000 (before costs) through the issue of up to 40,000,000 shares at \$0.20 each ("Public Offer"). This replaced the Prospectus lodged with ASIC on 12<sup>th</sup> September 2016. The public offer is subject to a minimum subscription of 30,000,000 shares to raise \$6,000,000 (before costs) ("Minimum Subscription").

The Company is extending the Public Offer to provide sufficient time for all funds to be transferred into the Offer Account and to enable reconciliation of all subscriptions. The Company is also engaged in negotiating a cornerstone investment with several institutions.

The Replacement Prospectus outlined an indicative timetable for the Public Offer which was subject to the Company's right to vary the closing date of the Public Offer, initially proposed to be 21<sup>st</sup> November 2016. The Company wishes to advise that the closing date for the Public Offer has now been extended to 5.00pm (WST) on 2<sup>nd</sup> December, subject to the right of the Company to close the Public Offer early or to further extend the closing date.

The Company anticipates that the Public Offer will be completed in accordance with the revised indicative timetable attached on Annexure 1. Odin will also shortly make application for a waiver from the requirements of Listing Rule 14.7, to enable the issue of all the securities, as approved at the extraordinary general meeting of the Company on 30 August 2016 ("EGM"), outside of the 3 month period stated in the notice of meeting for that EGM.
