## Pioneer's Capital Raising Tops \$1 million

Pioneer Resources Limited ("**Company**" or "**Pioneer**") (ASX:PIO) herewith provides an Appendix 3B for today's issue of 58,237,500 fully paid ordinary shares ("Shares") at the issue price of 1.6 cents per Share, raising an initial total of \$931,800 (before costs). In addition, the Directors of the Company provided the initial order for 4,875,000 Shares<sup>1</sup> which will raise a further \$78,000, bringing the total funds raised to \$1,009,800 (before costs).

The issue included 42,050,000 Shares to clients of Bell Potter Securities Limited, and 16,187,500 Shares to professional and sophisticated investors.

The funds raised from today's placement of Shares will be used to further the Company's targeted exploration initiatives and provide additional working capital. The programs being initialised immediately include:

- An EM survey and the inaugural RC drilling program at the very recently identified Dingo Dam copper-gold gossan located 50km southeast of Kalgoorlie WA;
- An EM survey at the Fairwater FWNi003 nickel target as a pre-cursor to a drilling program later this year. Progress towards the grant of key tenements is continuing satisfactorily; and
- Aircore drilling at the Acra gold project.

Drilling will commence in mid-September, with results expected before the end of October 2014.
