Dear Sandra,

I refer to the attached Appendix 3B. As required under Listing Rule 7.1A 4, I provide the following information.

- a) the issue of 16,961,620 FPO shares results in a 3.93% dilution to the existing holders of ordinary securities.
- b) the issue was made to institutional and professional investors whom the directors believe are strategic and influential investors to be involved with QBL for the long term benefit of QBL, especially as the company undertakes the feasibility studies on its South Johnstone Bauxite Project. In addition, due to the relatively small dilution factor, the Directors did not believe that the cost and time involved in managing a pro rata rights issue of this quantity was warranted for the amount raised.
- c) there were no underwriting arrangements in place in association with the issue.
- d) A total of \$10,000 in brokerage fees was paid in association with the issue.
