Acquisition of Additional Royalties / Disposal of Exploration Interests in the Amadeus Basin

High Peak Royalties Limited (**HPR** or **Company**) is pleased to announce that it has signed a legally binding Share Sale and Purchase Deed with Mosman Oil and Gas Limited (AIM: MSMN) (**Mosman**) for the sale of OilCo Pty Ltd (**OilCo**), a 100% owned subsidiary of HPR.

Oilco is the holder of one exploration permit (EP156) and the applicant of exploration permit (EP(A)155) in the Amadeus Basin in the Northern Territory.

Under the Share Sale and Purchase Deed, Mosman will assume the minimum work obligations in respect of EP156 and EP(A)155 if granted. The consideration for Oilco is that HPR will be granted a 2% gross overriding royalty on all recovered marketable production, including petroleum and other gas from EP156 and EP(A)155.

This transaction is consistent with the company's business strategy of royalty creation and acquisition.
