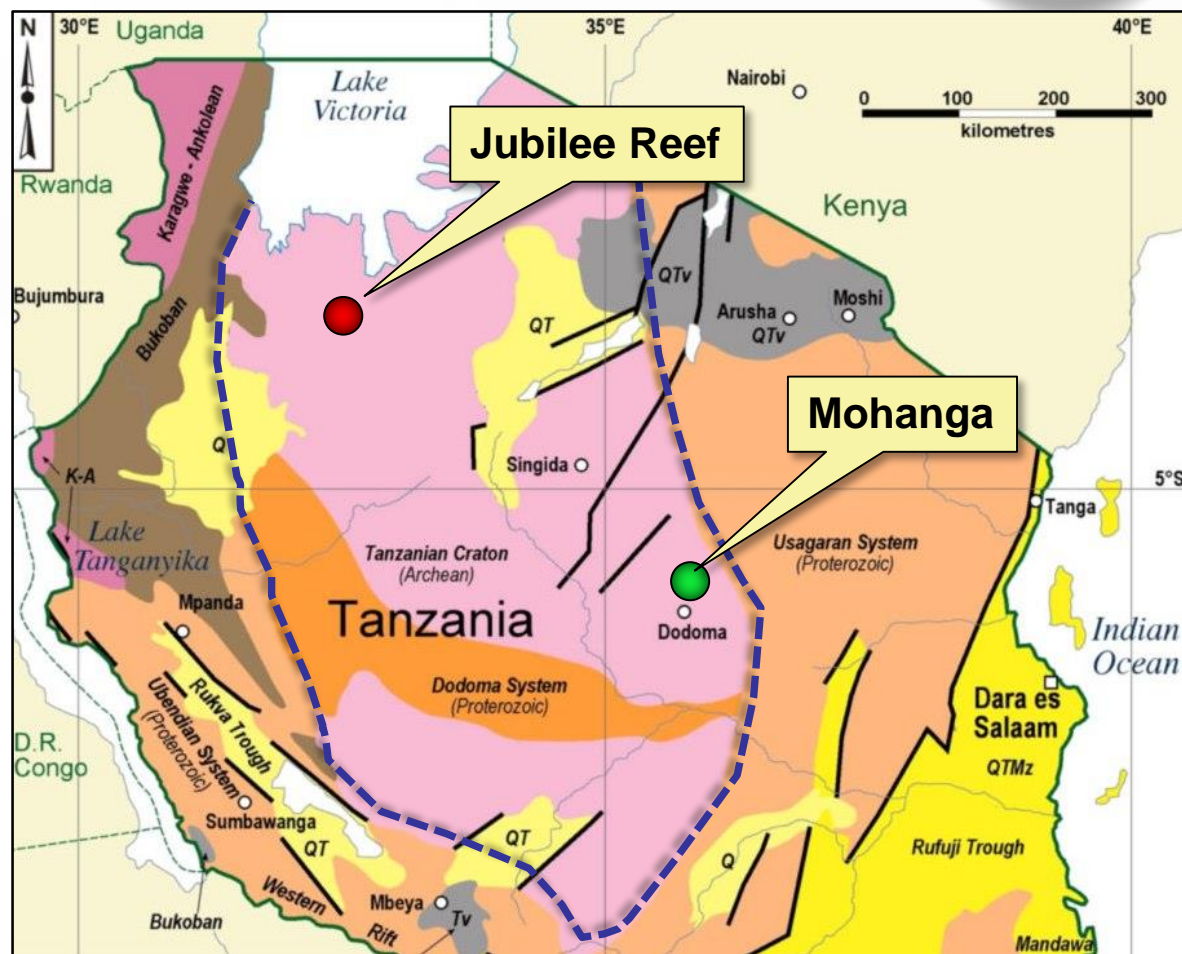


# Mohanga Lithium/Tantalum Project – The Right Place



## Tanzanian Craton

- **Archaean age**
- High gold endowment in the north – analogous to Eastern Goldfields of Western Australia
- **Virtually unexplored for other commodities**
- Located 500km SE of main goldfields – similar setting to giant Greenbushes **Lithium-Tantalum** deposit
- **Good access and infrastructure**

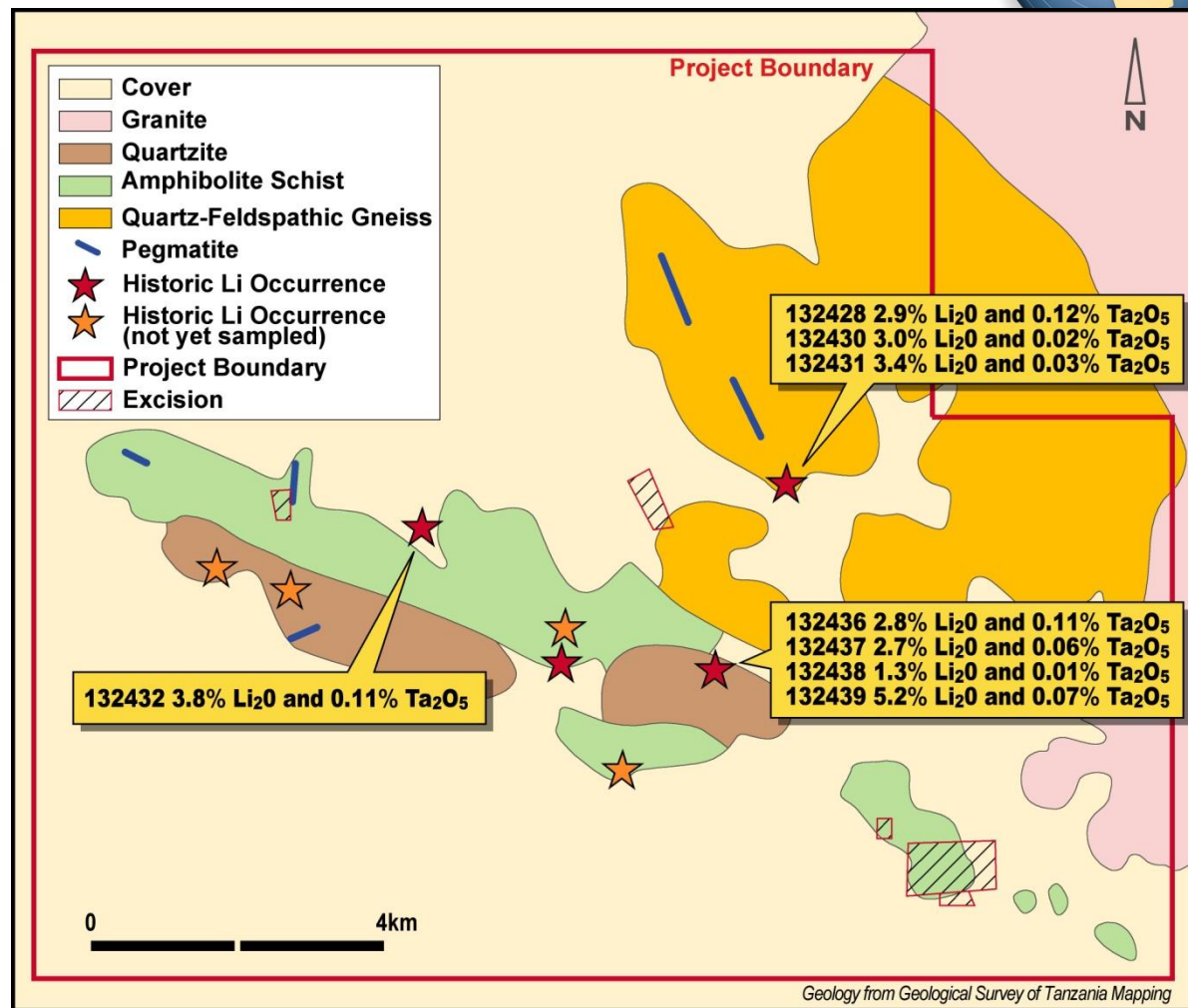


Mohanga is located in the Archaean Tanzanian craton, a geological setting identical to those that host most hard rock lithium deposits.

# Mohanga – High Grade Potential



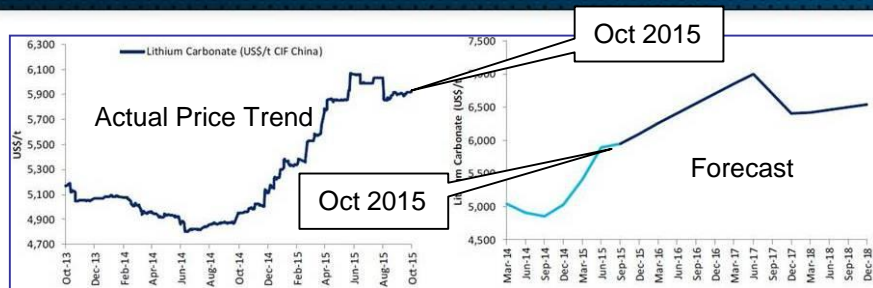
- **Historical lithium occurrences (the only ones recorded in Tanzania)**
- High grade Li and Ta values recorded in early rock chip sampling
- **Multiple targets**
- 177km<sup>2</sup> area (3 PLs)
  - 2 LTR PLs
  - 1 PL covered by option agreement (right to acquire 100%)
- **No modern exploration**
- **Fieldwork in progress**



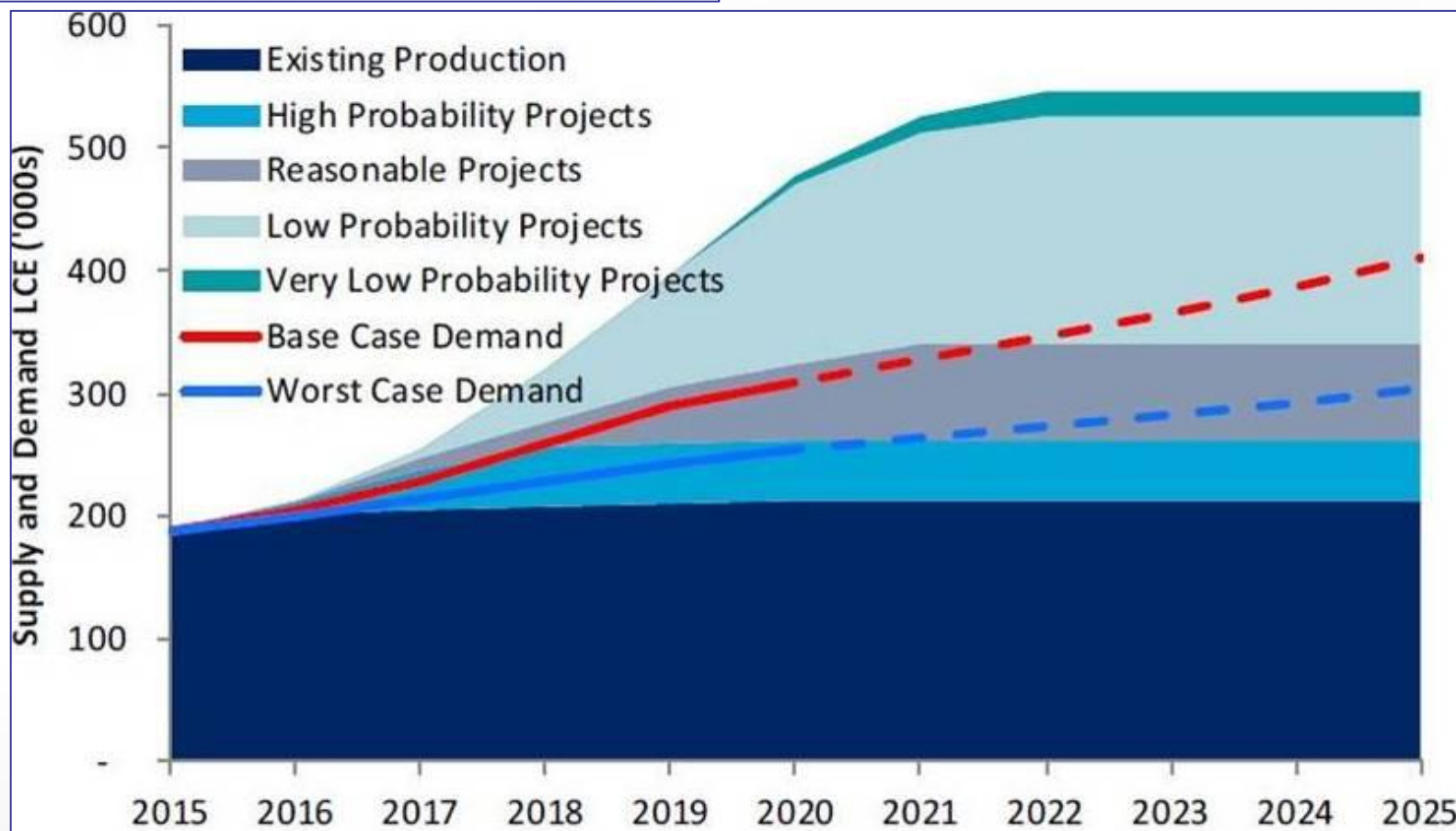
Multiple lithium and pegmatite occurrences recorded by government mapping



# Why Lithium? – Fundamentals Aligned

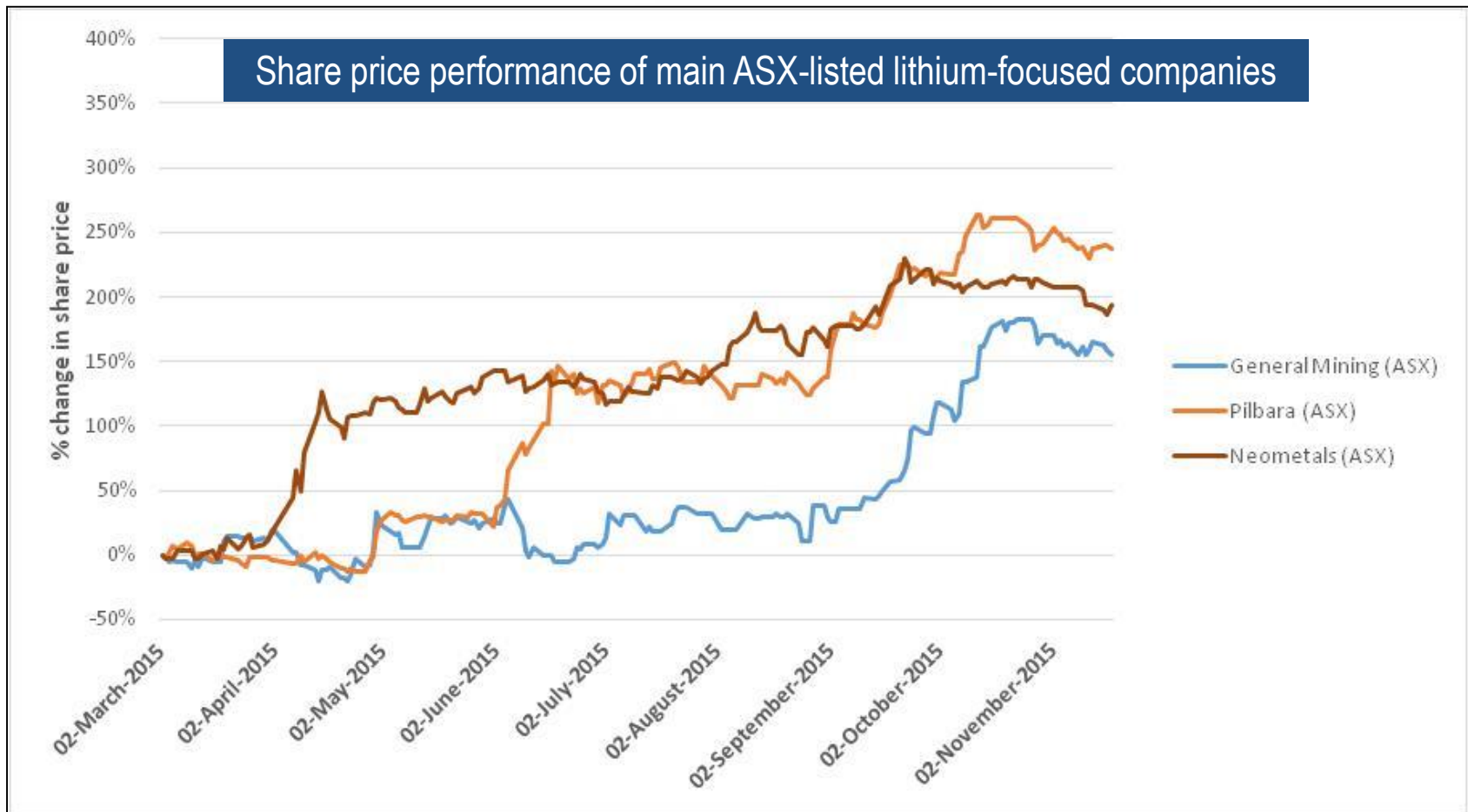


- Supply shortfall due to lithium batteries

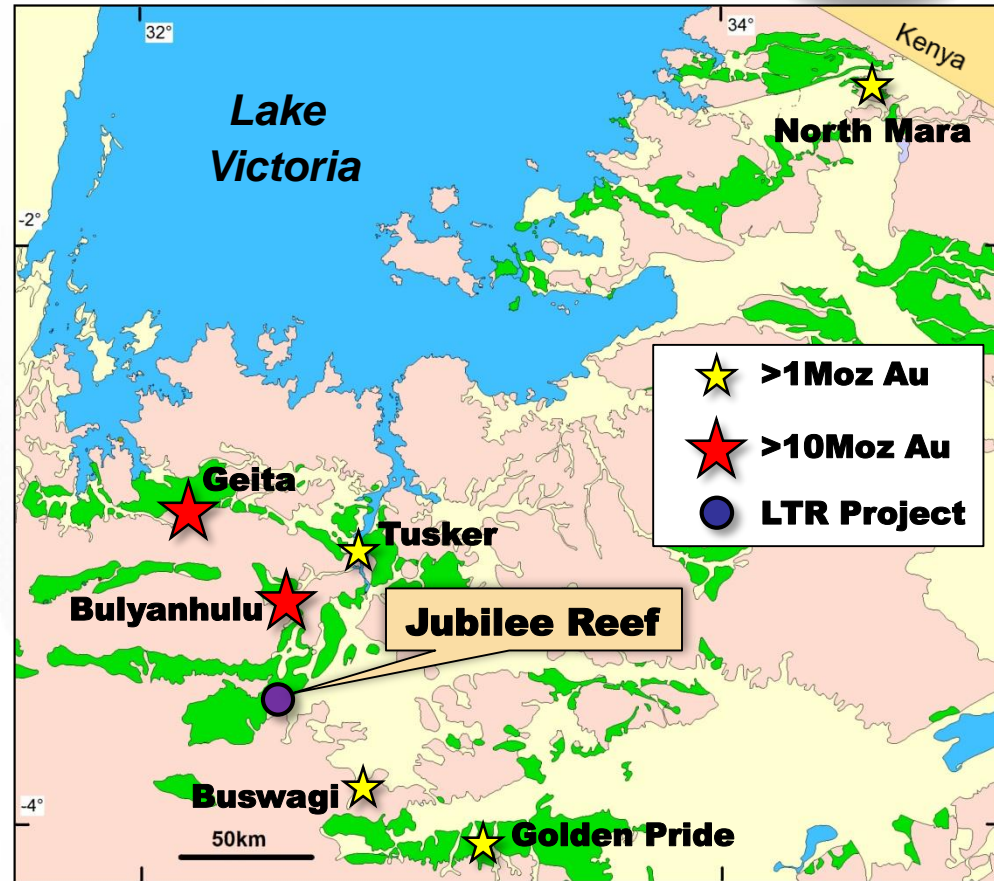
# Jubilee Reef – Surrounded by “Head Frames”



## Lake Victoria Goldfield

- **+50Moz gold endowment** – home to several world-scale deposits
- Multiple **+10Moz deposits\***:
  - *Bulyanhulu* (~17Moz)
  - *Geita* (~12.5Moz)
- **Four operating mines**
- **Fourth biggest gold producer in Africa** after S. Africa, Ghana, Mali
- **Granite/greenstone terrains** similar to those in Western Australia and Canada
- **Underexplored** compared with WA and Canada
- Established **infrastructure**

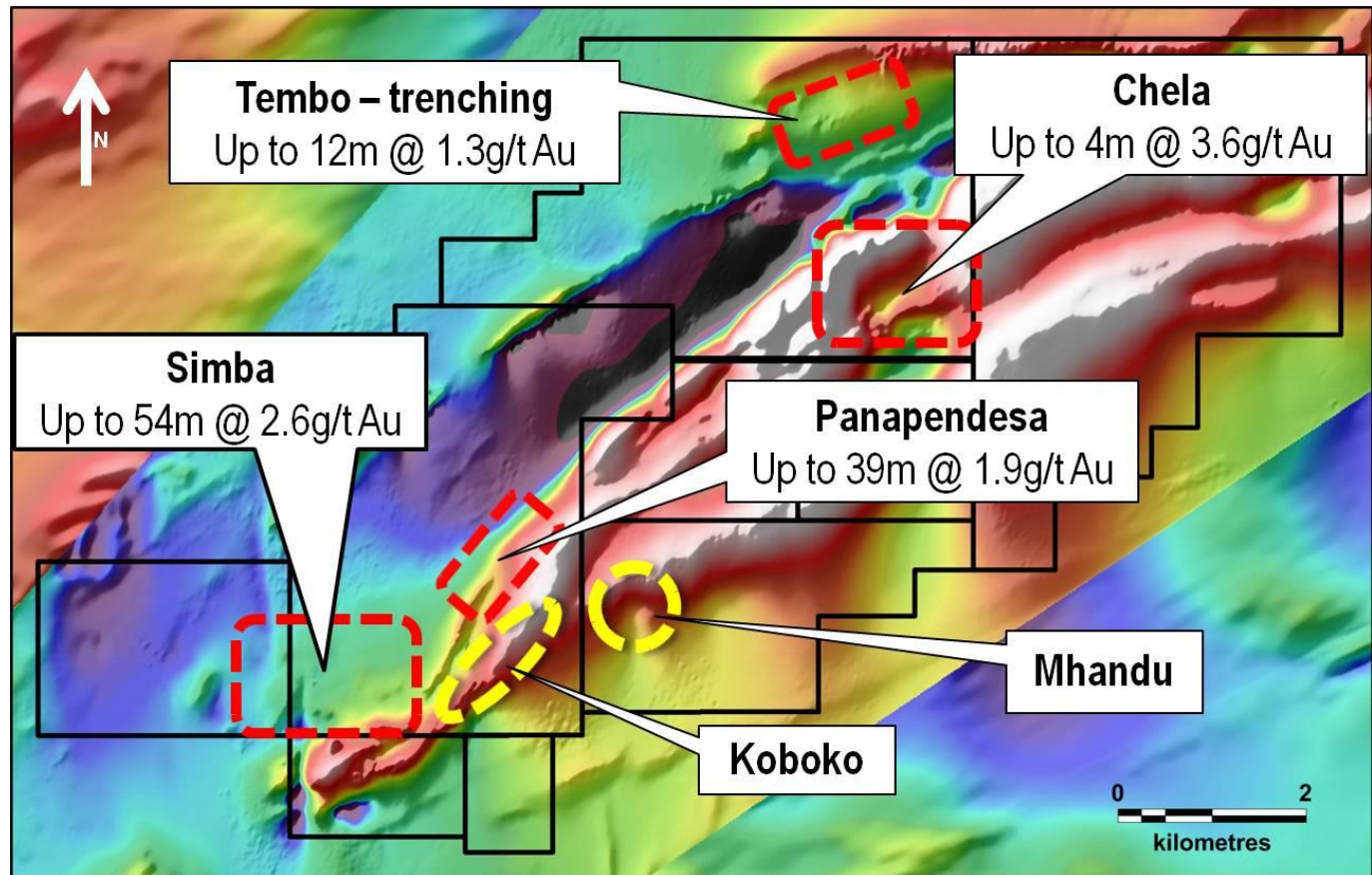

Jubilee Reef is located in the Lake Victoria Goldfields, one of the world's premier gold provinces

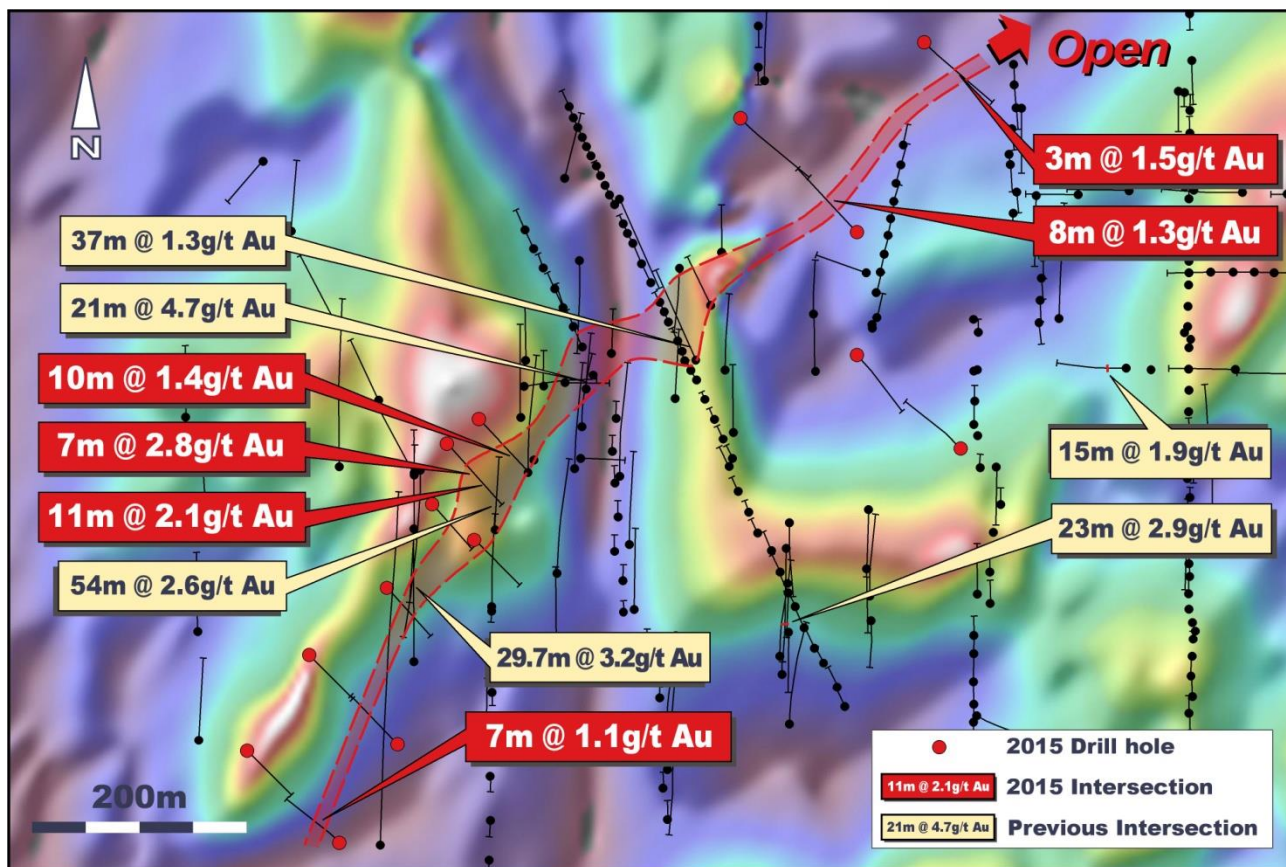
# Jubilee Reef – Resources Plus Exploration Upside

- Resource estimates pending for Simba and Panapendesa
- Mineralisation starts at or near surface
- Exploration upside
- Potential for large-scale gold systems



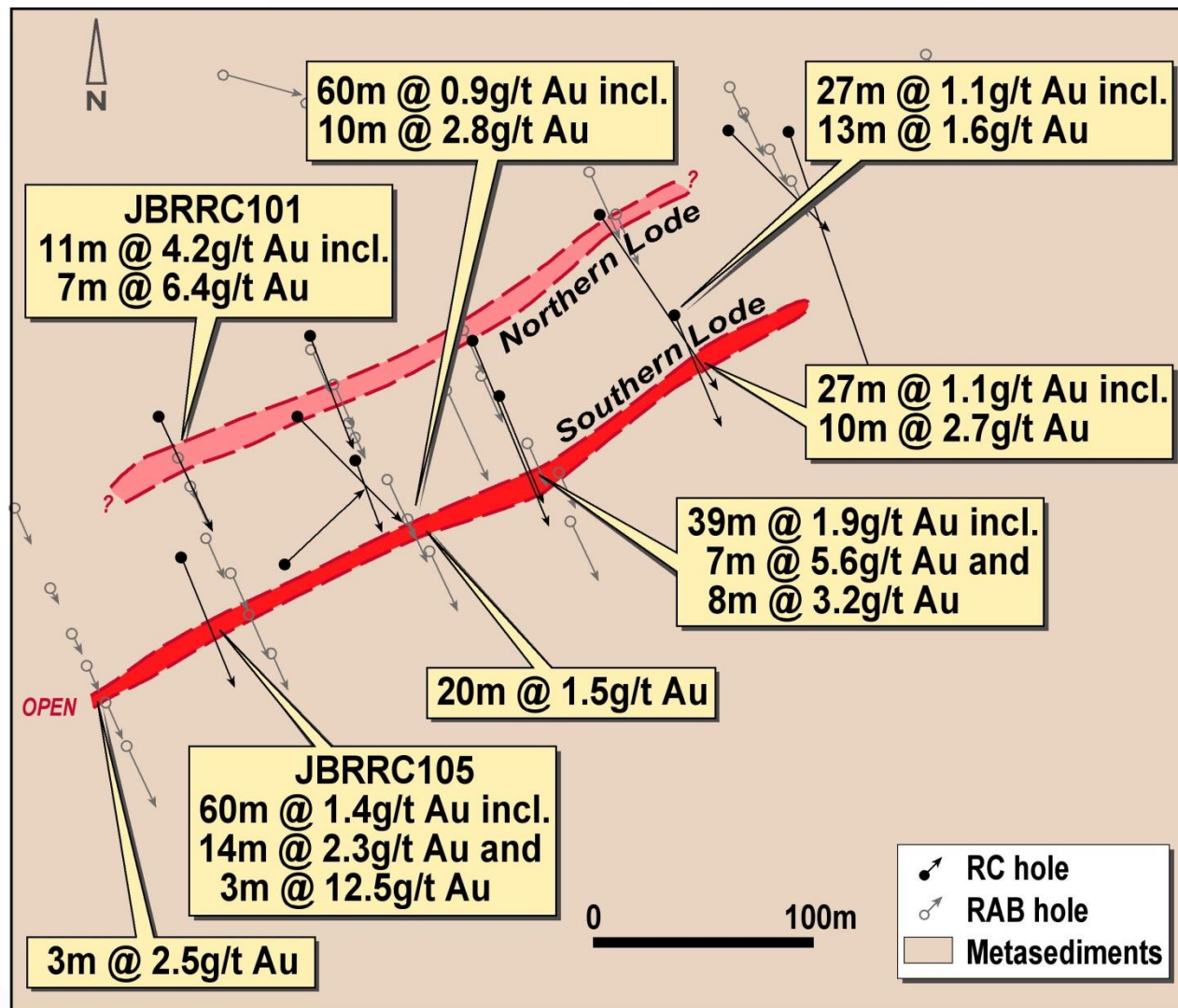


# Simba – Large Granite-hosted Gold System



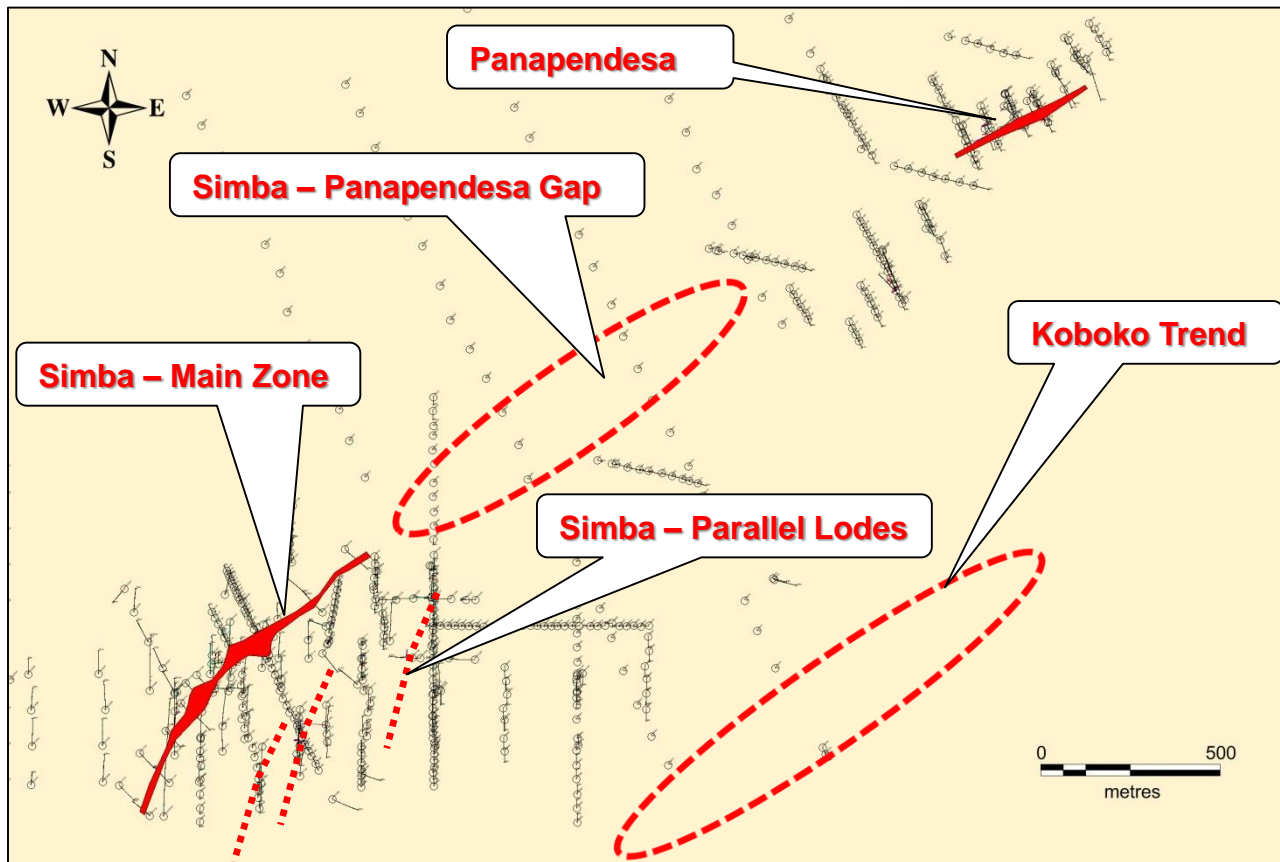
- Resource pending
- Previous results include:
  - 21m @ 4.7g/t Au
  - 23m @ 2.9g/t Au
  - 54m @ 2.6g/t Au
  - 29.7m @ 3.2g/t Au
- Latest drilling confirms continuity
- Multiple mineralised zones
- Large scale, shallow system
- Exploration upside
  - ✓ *along strike and*
  - ✓ *parallel lodes*

# Simba and Beyond – Exploration upside



**Drill hole plan showing target zones**

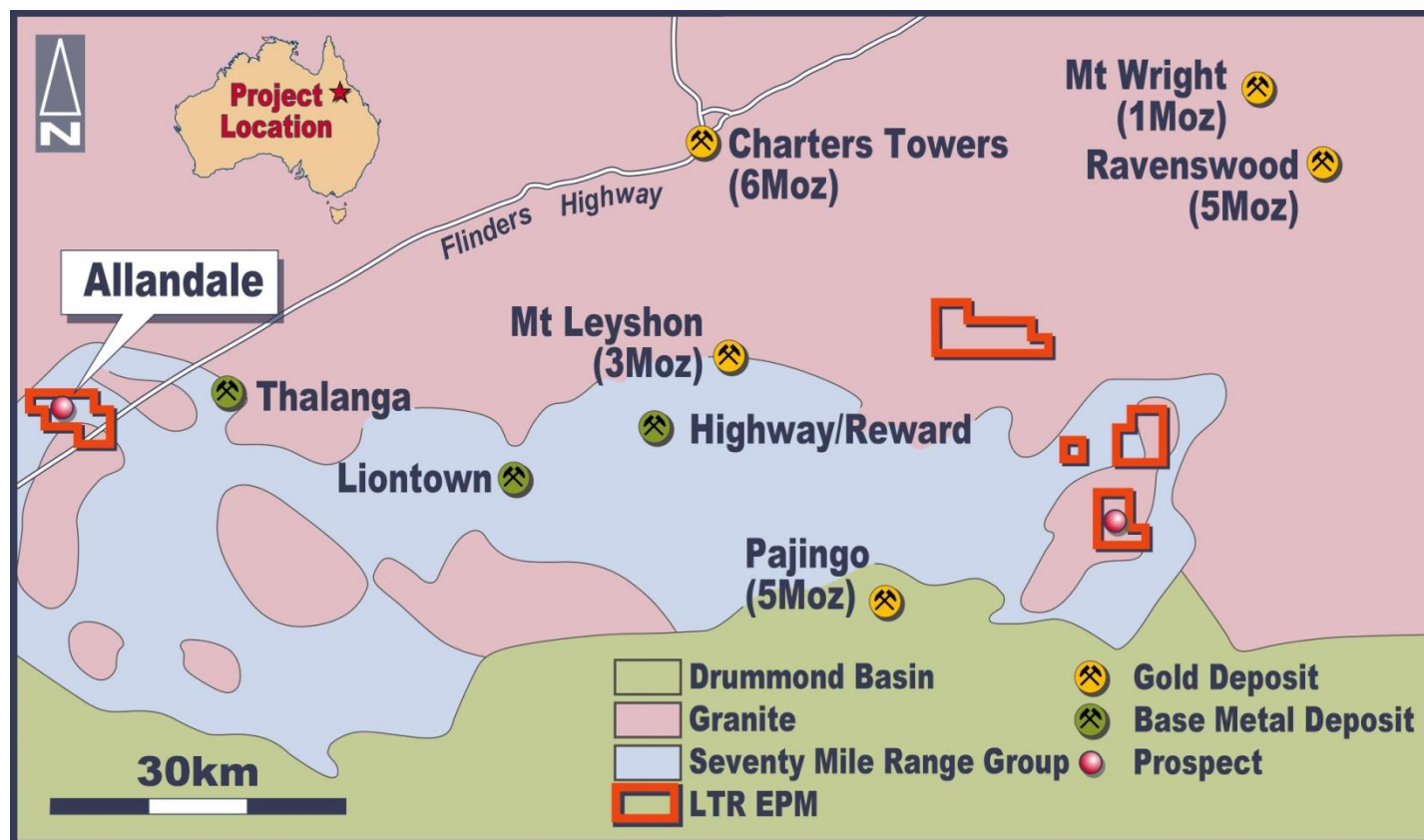
Mineralised system open along strike – multiple trends to be drill tested

- **Simba – Panapendesa Gap**
  - *Immediate extension (~1.5km) of main Simba zone*
  - *Western extension of Panapendesa*
  - *Soil covered*
  - *Previous drilling ineffective*
- **Simba – Parallel Lodes**
  - *Strike extensions of*
    - 15m @ 1.9g/t Au*
    - 23m @ 2.9g/t Au*
    - 17m @ 1.2g/t Au*
- **Koboko Trend**
  - *2km soil anomaly*
  - *Structurally modified BIF?*

- North Queensland
- **100%-owned**
- ~75km WSW of Charters Towers
- ~90km WNW of Pajingo
- Metal endowment (~25 Moz\*)

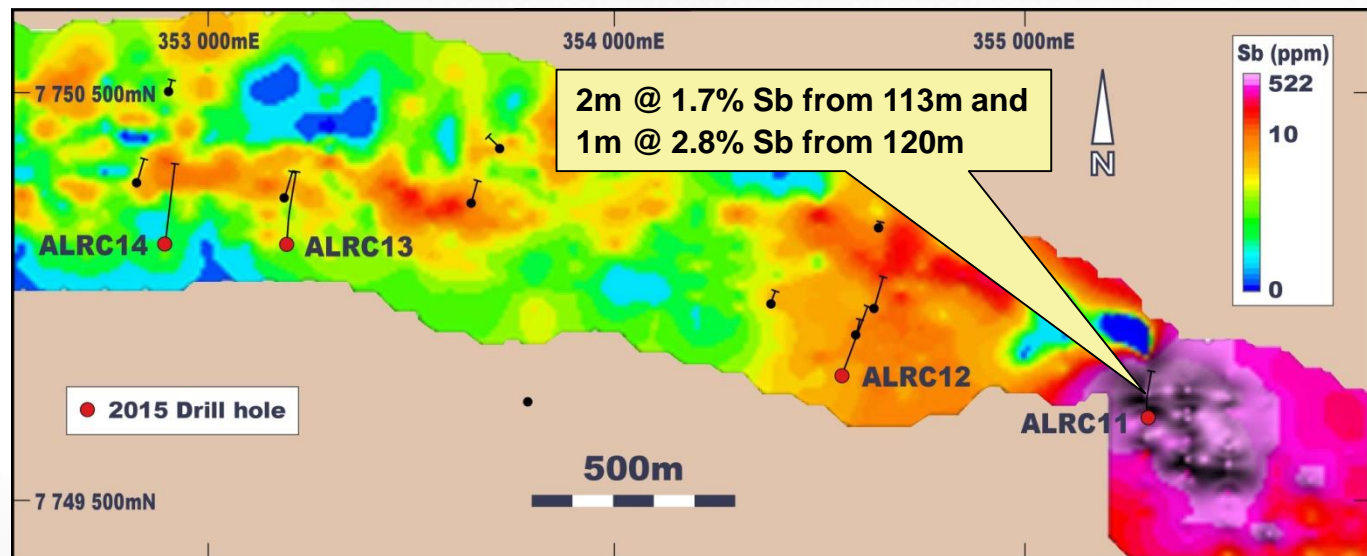
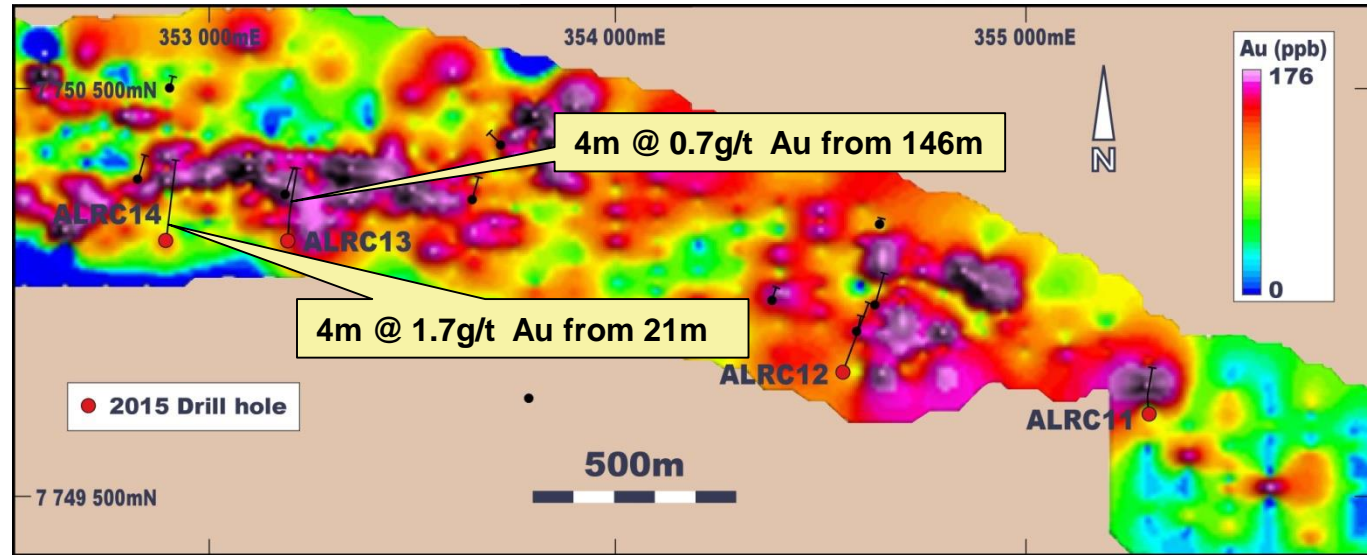
# Allandale – Recent Drilling (July 2015)

- Significant gold and antimony values intersected in drilling

✓ 4m @ 1.7g/t Au

✓ 2m @ 1.7% Sb  
and 1m @ 2.8% Sb

- Mineralisation open
- Potential for significant antimony resource beneath historical workings?

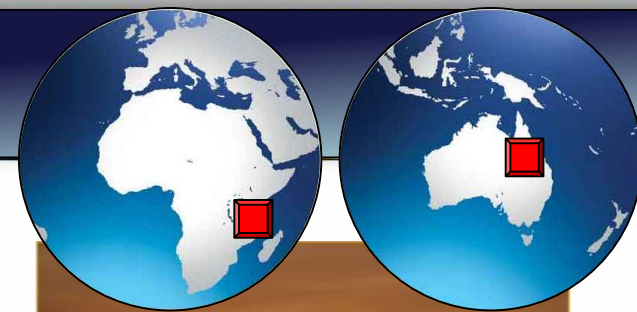
