### RESULTS OF ANNUAL GENERAL MEETING (AGM)

Further to the Company's announcement of 2 December 2015 the Company is pleased to confirm the results of its AGM on 30 November 2015.

All resolutions put to the meeting were passed on a poll except as set out below.

As more than 25% of the votes cast on Resolution 1 were against the Resolution the Company received a "second strike" and was required to submit a further "spill" Resolution at the AGM. The "spill" Resolution was defeated on a poll.

Resolution 2 was not put to the meeting as Mr. Procak decided not to seek re-election at the AGM for the reasons set out in the Company's announcement of 2 December 2015.

As a result of questions raised at the AGM in relation to the Notice of AGM the Company has decided not to proceed with Resolutions 4, 11 and 13 due to inadequate disclosure in the Notice of AGM in relation to those Resolutions.
