Adjournment of Second Court Date

Amcom Telecommunications Limited (“Amcom”) (ASX:AMM) announces that, following the previously announced adjournment of the Scheme Meeting to 18 May 2015, the Federal Court of Australia (“Court”) has today made orders adjourning the hearing for the Court to consider an application to approve the scheme of arrangement under which Vocus Communications Limited (“Vocus”) (ASX:VOC) would acquire any shares that it does not own in Amcom (“Scheme”) to Tuesday, 26 May 2015 (“Second Court Date”).
