CHAIRMAN'S REPORT

Dear Shareholders

On behalf of the Directors I enclose the company results for the year ending 30 June 2014 within this annual report.

The Company's full year revenue increased by 7.9% to \$25.8 million. On a consolidated basis we reported a net loss after tax of \$0.8 million for the year ended 30 June 2014. Normalised results for the year resulted in a small profit of \$0.16 million before tax compared to \$1.3 million for comparative normalised period in 2013. Our trading in the first half recorded a small profit with the result and margins in the second half impaired by the exit of our relationship with Samsung. As a company we need to provide better and more robust performance though changes in both the business cycle and product evolution to meet market requirements.

Q Security Systems reported a loss in earnings before interest and tax and depreciation (EBITDA) of \$0.38 million. On a normalised basis the QSS EBITDA was positive at \$0.508 million.

QRSciences Security Pty Ltd (QSS)

Our QRSciences Security Pty Ltd business trading as Q Security Systems ("QSS") is focused on the importation and distribution of CCTV cameras, digital video recorders, security video management systems and access controls with offices located in Melbourne, Sydney, Brisbane, Adelaide and Perth. The company has a strong reputation for service excellence, high stock availability, fast and reliable delivery, expert technical support and end-to-end turn-key solutions.

The Company is a leader in the supply of all video and camera security needs, analytics, embedded video encoders and wireless transmitters, megapixel and IP cameras, robust video management software, integrated video analytics, comprehensive access control technology and world class alarms and security systems.

Revenues within the business were \$25.8 million. During the year we invested in the appointment of key staff with appointment of Chief Operating Officer, Rob Rosa and new key sales and procurement staff to target growth sectors of our market.

In early 2014 the board directed management to review our product and technology strategies to improve our business and improve margins in the business. As a result of the exit by QSS of our Samsung relationship our margins were lower than our historic trading for those products and I am pleased to advise that our margins have recovered into the new financial year due to new arrangements with leading suppliers.

In FY14 Q4 we negotiated and commenced marketing several new supply arrangements that are at the forefront of video security solutions and maintain our leadership as a wholesale solutions provider. QSS now offers Tyco Security products, with product brands, DSC, American Dynamics, ExacQ, Kantech and Software House and in addition QSS has re-launched our OEM brand to the Australian market with the newly developed QVS Alumia cameras, which offer world leading technology. Other new supply arrangements include distribution of Allied Telesis, BPT Intercoms, Bosch CCTV & detectors, DVTEL, FLIR and the exclusivity of NUUO which further provide QSS an improved product mix for profitable growth.

Corporate

During the year we worked to reduce corporate costs. Our corporate salaries and directors fees were down 47.6% from \$ 0.924 million in 2013 to \$ 0.484 million in 2014. Our Managing Director & Group CEO, Rick Stokes undertakes his duties in a part time role to reduce corporate costs.

Corporate governance

Our compliance with corporate governance practices at Q Technology Group Limited is included within this report. The Board is confident that our governance structure is in place and is properly administered.

Management has continued to refine our risk management procedures and to implement our business strategies to leverage the capabilities of the company.

Outlook

Q Technology Group Limited has delivered a result that has underperformed on our expectations for the group in the 2014 financial year. The review and new strategy surrounding our products has been targeted to higher margin growth markets are expected to improve our ability to assemble and deliver a wide mix of optimum wholesale security product solutions to complement the functionality of each sensor, controller or network components.

Our QSS business is in a much stronger market position to take advantage of growth prospects in the market and management are excited by the market opportunities going forward.

As a listed company we lack the required scale to carry the ASX listing costs and related overheads and deliver satisfactory earnings per share. We will continue to seek opportunities in the coming year to unlock value to shareholders either through merger with similar synergistic businesses or divestment. I look forward to discussing this report with shareholders at the Annual General Meeting.

On behalf of the Directors we wish to thank the senior management teams and all employees for their hard work, commitment and customer service focus across all segments during the year and also thank our customers and shareholders for their continuing support of Q Technology Group Limited.

Your directors present their report, together with the financial statements for the Group, being the Company and its controlled entities for the financial year ended 30 June 2014.

Q Technology Group Limited ("QTG") is based in Melbourne, Victoria. It's wholly owned distribution business, QRSciences Security Pty Ltd trading as Q Security Systems ("QSS"). The business has 6 offices located throughout Australia with a presence in all state capital cities except Tasmania (served by Victorian office) and Northern Territory, (served by Queensland office).

Directors

The following persons were directors of Q Technology Group Limited during the whole of the financial year and up to the date of this report:

Principal Activities and Significant Changes in Nature of Activities

The principal activities of the consolidated group during the financial year were:

- The importation and distribution of CCTV cameras, digital video recorders and security video management systems through QSS.

There were no changes to in the nature of the consolidated group's principal activities during the financial year.

Dividends

No dividends have been paid or recommended for the financial year ended 30 June 2014 (2013:None).

Consolidated Result

For the full year the Group reported a \$ 0.732 million net loss before tax. Earnings before Interest, Tax and Depreciation (EBITDA) were a \$ 0.383 million loss. Revenues were up 7.9% to \$ 25.827 million and gross profit was down 5.6% to \$5.865 million primarily due to product rationalization and one off end of year provisions relating to the exit of Samsung products.

Tight working capital management and low corporate overheads had contributed \$0.402 million positive cash flow from operations for the Group for the full year 2014.

QTG undertakes all operating business through QSS where all revenue and the majority of operating costs reside. During the year QSS invested in growth initiatives with appointments of Chief Operating Officer, National Procurement Manger and National Product Manager along with relocating some branch offices to more suitable locations. Managing Director & Group CEO, Rick Stokes undertakes his duties in a part time role to reduce corporate costs. For the full year, QTG's corporate salaries and directors fees were down 47.6% from \$ 0.924 million in 2013 to \$ 0.484 million in 2014.

Review of Operations

QSS has two product groups namely Q Video Systems and Q Alarm Supplies with offices in Brisbane, Sydney, Melbourne, Adelaide and Perth for complete coverage of all state capital cities except Tasmania (serviced by Victorian office) and Northern Territory, (serviced by Queensland office). QSS differentiates itself from competitors with a strong team of technical support personnel providing before and after sales service for our customers, which is particularly important with the industry migrating to IP network video solutions.

QSS has built a strong reputation for service excellence, high stock availability; fast and reliable delivery and expert technical support with a total end-to-end turn-key solution and is the second largest CCTV distributor in Australia. The business has achieved a strong revenue growth record over the last five years and further opportunities are expected for growth as a specialist supplier of analytics-embedded video encoders and wireless transmitters, megapixel and networked cameras, robust video management software, comprehensive access control technology, and world class alarm systems.

QSS had a strong start in the financial year in the first half in contrast to the second half of the financial year which produced slower trading conditions coupled with the exit of Samsung supply arrangements affecting both sales and gross profit in the period. Sales in the second half of the year were \$ 12.6 million a decline of 4.5% over the first half; gross margin declined 15.4% in the second half to \$ 2.688 million reflecting the loss of margin in Samsung sales and the exit strategy taken by QSS in relation to Samsung.

The Company also incurred a one off provision of a bad debt of \$ 0.223 million associated with a Brisbane based customer who operated in a rental environment which has resulted in an insolvent business. QSS has now discontinued operations servicing customers operating rental based business models resulting in the one off provision.

In May we announced due to new master distribution arrangements by Samsung being adverse to QSS that the Company would launch new products and exit excess stock to reflect the new business product mix. The impact of this stock transition was loss of margin in Samsung products discounted at margins of less than 20%. These trading actions which were outside our normal course of trading impacted our margins in the second half with Samsung margin sacrifice of net \$0.405 million and stock provisions of \$ 0.200 million.

The Company incurred costs associated with reaching a final agreement in July 2014 with Samsung Techwin Korea to settle an outstanding account, which had been in dispute since February 2014. Pursuant to the terms of the settlement agreement the Samsung account of \$1.2 million was paid in full during the first quarter of FY15.

The Company has negotiated and commenced marketing several new supply arrangements that are at the forefront of video security solutions and maintain our position as a leading wholesale solutions provider. QSS has re-launched an in-house brand to the Australian market with the newly developed QVS Alumia network cameras as a dynamic and profitable part of repositioning strategy of the QSS business. The changed relationship with Samsung resulted in one off provisions and reduced margins from selling down Samsung products, the one off non-recurring costs associated with this strategy was \$ 0.405 million.

QSS continues to offer the world leading solution Tyco Security products, with product brands, DSC, American Dynamics, ExacQ, Hatrix, Kantech and Software House. During the year we announced distribution agreements as follows;

- NUUO, based in Taiwan to provide low to medium end network video management solutions
- Supply relationships and distribution of DVTEL, one of the world's leading IP and network video management platforms
- FLIR in the USA, a leader in thermal imaging camera technology
- Distribution of BOSCH brand CCTV and alarm detectors
- Distribution agreement with BPT Asia Pacific Intercoms who have around 30% of the market share in Australia in multi-tenant, multi block apartment complexes

All these new and optimized product ranges will provide an opportunity for the QSS business to compete more effectively in the major project market.

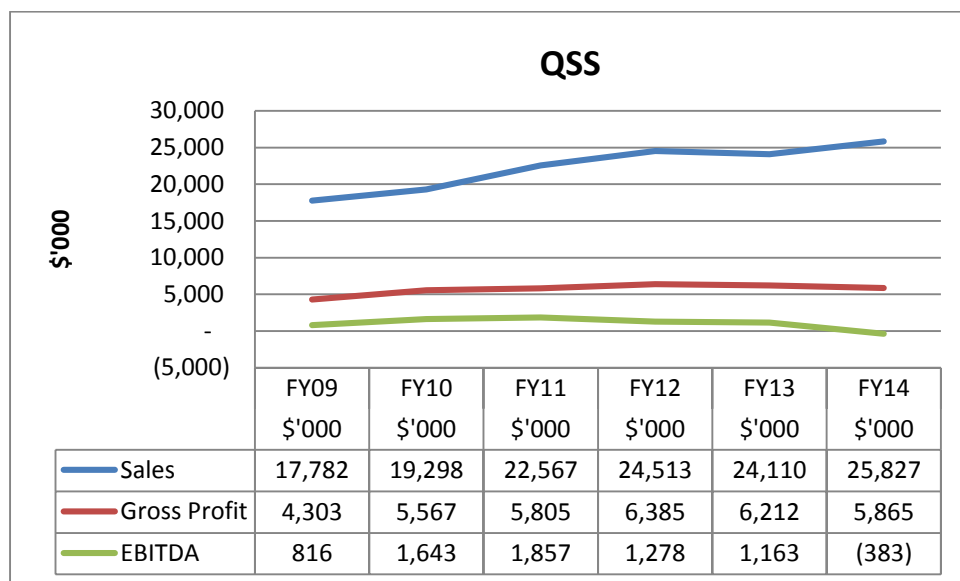
All of the recently acquired and current products distributed and supported by QSS are expected to improve our ability to assemble and deliver a wide mix of optimum wholesale security product solutions to complement the functionality of each sensor, controller or network component.

Currency exchange movement, particularly USD which QSS transacts for imported product purchases showed some volatility throughout the year. This movement required careful monitoring and price list management on a timely basis. The Company continued to experience some time lag in passing on price increases to the market and this coupled with creditors revaluation in December and June periods had contributed to the lower than expected profitability.

For the year, QSS achieved an EBITDA loss of \$0.38 million (\$0.094 million last year) on revenue of \$25.8 million (\$24.1 million last year). On a normalized basis the QSS EBITDA was positive at \$0.508 million.



Finance Facilities and Lending Covenants

The Company funds its working capital requirements through Bank of Melbourne. On 30 June 2014, the Company entered into a revised Bank Facility Agreement with Bank of Melbourne, providing the Company more flexibility in the funding available for working capital. The revised facility is a combination of debtor funding, trade financing and bank guarantee funding with a maximum drawdown of \$ 4.5 million.

The impact of the one off provisions and adjustments noted above has resulted in a breach of the interest cover covenant set for the Bank facilities to 30 June 2014. As a consequence, Bank of Melbourne issued a breach notice noting interest cover breach and that no action is to be taken as at this point in time. Under the agreement, interest cover resets on 1st July 2014 with next compliance measurement due on 30th September 2014. The Group expect to be in compliance with all future financial covenants.

Future developments, prospects, and business strategies

The Company has refined our product and suppliers relationships as set out above and we considered that these changes will improve our business. . The Company will continue to service its current customer base and in addition, will target sales in major projects. To enable this strategy, the Company has invested in our sales and technical resources.

Environmental Issues

The Group is not involved in any activities that have a marked influence on the environment within its area of operation. As such, the directors are not aware of any material issues affecting the Group or its compliance with the relevant environmental agencies or regulatory authorities.

Significant Changes in State of Affairs

No significant changes in the company's state of affairs occurred during the financial year.

Matters subsequent to the end of the financial year

Since the end of the financial year the Company had reached a settlement agreement with Samsung Techwin, Korea to settle an outstanding account, which had been in dispute since February 2014. Pursuant the terms of the settlement agreement the Samsung account will be paid in full during the first quarter of FY15. The matter is now closed after full settlements made on 21 August 2014.

The Company received a breach notice from the Bank of Melbourne on 19 August 2014 noting that the Company had failed to meet the interest cover of 1.5 times as at 30 June 2014. The same notice confirmed that no action is to be taken at this point in time. As interest cover resets with the new financial year, the Board believes current business plan is able to comply with bank covenants.

The company is an entity to which ASIC Class Order 98/100 applies and, accordingly, amounts in the financial statements and directors' report have been rounded to the nearest thousand dollars.

Remuneration Policy

The remuneration policy of Q Technology Group Limited has been designed to align key management personnel (“KMP”) objectives with shareholder and business objectives by providing a fixed remuneration component and offering specific long-term incentives based on key performance areas affecting the consolidated Group’s financial results.

The Board of Q Technology Group Limited believes the remuneration policy to be appropriate and effective in its ability to attract and retain the best key management personnel to run and manage the consolidated group, as well as create goal congruence between directors, executives and shareholders.

The Board’s policy for determining the nature and amount of remuneration for KMP of the consolidated group is as follows:

- The remuneration policy is to be developed by the remuneration committee and approved by the Board after professional advice is sought from independent external consultants.
- KMP receive a combination of base salary (which is based on factors such as length of service and experience), superannuation, fringe benefits, options and performance incentives.
- Performance incentives are generally only paid once predetermined key performance indicators have been met.
- Incentives paid in the form of options or rights are intended to align the interests of the directors and company with those of the shareholders. In this regard, KMP are prohibited from limiting risk attached to those instruments by use of derivatives or other means.
- The remuneration committee reviews KMP packages annually by reference to the consolidated group’s performance, executive performance and comparable information from industry sectors.

The performance of KMP is measured against criteria agreed bi-annually with each executive and is based predominantly on the forecast growth of the consolidated group’s profits and shareholders’ value. All bonuses and incentives must be linked to predetermined performance criteria. The Board may, however, exercise its discretion in relation to approving incentives, bonuses and options, and can recommend changes to the committee’s recommendations. Any changes must be justified by reference to measurable performance criteria. The policy is designed to attract the highest calibre of executives and reward them for performance results leading to long-term growth in shareholder wealth.

KMP receive a superannuation guarantee contribution required by the government, which for the FY2014 financial year was 9.25% of the individual’s average weekly ordinary time earnings (AWOTE), and do not receive any other retirement benefits. Some individuals, however, have chosen to sacrifice part of their salary to increase payments towards superannuation.

All remuneration paid to KMP is valued at the cost to the company and expensed.

The Board’s policy is to remunerate Non-Executive Directors at market rates for time, commitment and responsibilities. The remuneration committee determines payments to the Non-Executive Directors and reviews their remuneration annually, based on market practice, duties and accountability. Independent external advice is sought when required. The maximum aggregate amount of fees that can be paid to Non-Executive Directors is subject to approval by shareholders at the Annual General Meeting.

KMP are also entitled and encouraged to participate in the employee share and option arrangements to align directors' interests with shareholders' interests.

Options granted under the arrangement do not carry dividend or voting rights. Each option is entitled to be converted into one ordinary share once the interim or final financial report has been disclosed to the public and is valued using the Black-Scholes methodology.

KMP or closely related parties of KMP are prohibited from entering into hedge arrangements that would have the effect of limiting the risk exposure relating to their remuneration.

In addition, the Board's remuneration policy prohibits directors and KMP from using Q Technology Group Limited shares as collateral in any financial transaction, including margin loan arrangements.

Engagement of Remuneration Consultants

No remuneration consultant was engaged during the year.

Performance-based Remuneration

The key performance indicators (KPIs) are set annually, with a certain level of consultation with KMP. The measures are specifically tailored to the area each individual is involved in and has a level of control over. The KPIs target areas the Board believes hold greater potential for group expansion and profit, covering financial and non-financial as well as short and long-term goals. The level set for each KPI is based on budgeted figures for the Group and respective industry standards.

Performance in relation to the KPIs is assessed annually, with bonuses being awarded depending on the number and deemed difficulty of the KPIs achieved. Following the assessment, the KPIs are reviewed by the remuneration committee in light of the desired and actual outcomes, and their efficiency is assessed in relation to the Group's goals and shareholder wealth, before the KPIs are set for the following year.

In determining whether or not a KPI has been achieved, Q Technology Group Limited bases the assessment on audited figures; however, where the KPI involves comparison of the Group, or a division within the Group, to the market, independent reports are obtained from organisations such as Standard & Poor's.

Relationship between Remuneration Policy and Company Performance

The remuneration policy has been tailored to increase goal congruence between shareholders, directors and executives. Two methods have been applied to achieve this aim, the first being a performance-based bonus based on key performance indicators, and the second being the issue of options to executives to encourage the alignment of personal and shareholder interests when considered appropriate.

Net loss in 2014 included one off costs associated with change in distribution arrangement with Samsung, being a loss of margin and incentive payments associated in low margin sales of \$ 405k and a one off increase to the obsolete stock provision of \$ 200k. A further \$ 233k provision for a bad debt relating to a customer who went into liquidation and operated in an equipment rental business environment.

In 2013 the result was affected by a positive gain of \$ 2.320 million on disposal of the API Locksmith business this gain helped offset the once off legal expenses and finance break fee of \$942k payable on the exit of the API business. The net debt of the group decreased from \$ 13 million to \$ 3.4 million post the API transaction.

The 2012 result of a net loss of \$ 2.168 million was adversely affected by \$1.12 million in costs associated with the termination of the scheme of arrangement with GWA Limited, relocation costs associated with the relocation of the national warehouse from Sydney to Melbourne and inventory impairments in the Q Video Systems business.

The 2011 result of a loss of \$ 4.998 million was adversely affected by the one off integration costs associated with the API business of \$ 1.3 million for the period and the write down of the value of the goodwill of the API business of \$ 4 million.

The 2010 result of a profit of \$ 4.615 million was driven by the strong results in Q Video Systems and Q Alarm supplies with a NPAT of \$ 1.257 million and a gain on the disposal of the investment in Spectrum San Diego of \$ 3.341 million. The Company also exited the asset DVOP-OB in the USA for US\$ 215k and QR Sciences Pty Ltd in Perth for US\$ 150k.

The directors note that the share price during the year traded at a discount to the value of the assets of the group.

Performance Conditions Linked to Remuneration

The Group seeks to emphasise reward incentives for results and continued commitment to the Group through the provision of various cash bonus reward schemes, specifically the incorporation of incentive payments based on the achievement of revenue and profit targets, return on equity ratios, and continued employment with the Group. This condition provides management with a performance target which focuses upon organic sales growth utilising existing group resources.

The performance related proportions of remuneration based on these targets are included in the following table. The objective of the reward schemes is to both reinforce the short and long-term goals of the Group and provide a common interest between management and shareholders. There has been no alteration to the terms of the bonuses paid since grant date.

The satisfaction of the performance conditions are based on a review of the audited financial statements of the Group, as such figures reduce any risk of contention relating to payment eligibility. The Board does not believe that performance conditions should include a comparison with factors external to the Group at this time.

Q Technology Group Limited's Corporate Governance Arrangements

The Board is responsible for ensuring the existence of an effective corporate governance environment to safeguard the interests of the Company and its shareholders. This statement outlines the main corporate governance practices that were in place during the year ended 30 June 2014.

The Board considers there to be an unambiguous and positive relationship between the creation and delivery of long-term shareholder value and high-quality corporate governance. Accordingly, in pursuing its objective, the Board has committed to corporate governance arrangements that strive to foster the values of integrity, respect, trust and openness among and between board members, management, employees, customers and suppliers.

Q Technology Group Limited ("QTG") and its subsidiaries operate as a single economic entity with a unified Board and management. As such, the Board's corporate governance arrangements apply to all entities within the economic group

QTG is listed on the Australian Securities Exchange ("ASX"). Accordingly, unless stated otherwise in this document, the Board's corporate governance arrangements comply with the recommendations of the ASX Corporate Governance Council (including the 2010 amendments) as well as current standards of best practice for the entire financial year ended 30 June 2014.

Board Composition

The Board comprises one executive Director and two non-executive Directors. The Board meets regularly and is responsible for providing strategic direction, identifying significant business risks, approving major investment proposals and acquisitions, establishing goals and monitoring the achievement of these goals.

Day to day management of the Group's affairs and the implementation of corporate strategy and policy initiatives are formally delegated by the Board to the Chief Executive Officer and senior executives.

The determination of materiality requires consideration of both quantitative and qualitative elements. An item is presumed to be quantitatively immaterial if it is equal or less than 10% of the appropriate base amount.

It is presumed to be material (unless there is qualitative evidence to the contrary) if it is equal to or greater than 10% of the appropriate base amount. Qualitative factors considered include whether a relationship is strategically important, the competitive landscape, the nature of the relationship and the contractual or other arrangement governing it and other factors that point to the actual ability of the director in question to shape the direction of the Company's loyalty.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements and notes represent those of Q Technology Group Limited and controlled entities ('Consolidated Group' or 'Group').

The separate financial statements and notes of Q Technology Group Limited have not been presented within this financial report as permitted by amendments made to the *Corporations Act 2001*.

The financial information for the parent entity as disclosed in Note 2 to the financial statements has been prepared on the same basis as the consolidated financial statements.

The financial statements are authorised for issue on 29 September 2014 by the directors of the company.

Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board (AASB), and the Corporations Act 2001. The Group is a for-profit entity for financial reporting purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Compliance with Australian Accounting Standards ensures that the financial statements and notes also comply with International Financial Reporting Standards as issued by the IASB. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise

Except for the cash flow information, the financial statements have been prepared on an accruals basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

A. Principles of Consolidation

The consolidated financial statements incorporate the assets, liabilities and results of entities controlled by Q Technology Group Limited at the end of the reporting period. A controlled entity ('subsidiary') is any entity over which Q Technology Group Limited has the power to govern the financial and operating policies so as to obtain benefits from the entity's activities. Control will generally exist when the parent owns, directly or indirectly through subsidiaries, more than half of the voting power of an entity. In assessing the power to govern, the existence and effect of holdings of actual and potential voting rights are also considered.

Where controlled entities have entered or left the Group during the year, the financial performance of those entities are included only for the period of the year that they were controlled. A list of controlled entities is contained in Note 14 to the financial statements.

In preparing the consolidated financial statements, all inter-group balances and transactions between entities in the consolidated group have been eliminated on consolidation. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with those adopted by the parent entity.

Non-controlling interests, being the equity in a subsidiary not attributable, directly or indirectly, to a parent, are shown separately within the Equity section of the consolidated Statement of Financial Position and Statement of Comprehensive Income. The non-controlling interests in the net assets comprise their interests at the date of the original business combination and their share of changes in equity since that date.

Business Combinations

Business combinations occur where an acquirer obtains control over one or more businesses.

A business combination is accounted for by applying the acquisition method unless it is a combination involving entities or businesses under common control.

The business combination will be accounted for from the date that control is attained, whereby the fair value of the identifiable assets acquired and liabilities (including contingent liabilities) assumed recognised (subject to certain limited exemptions).

When measuring the consideration transferred in the business combination, any asset or liability resulting from a contingent consideration arrangement is also included. Subsequent to initial recognition, contingent consideration classified as equity is not measurable and its subsequent settlement is accounted for with equity. Contingent consideration classified as an asset or liability is remeasured each reporting period to fair value, recognising any change to fair value in profit or loss, unless the change in value can be identified as existing at acquisition date.

All transaction costs incurred in relation to the business combination are expensed to the statement of comprehensive income. The acquisition of a business may result in the recognition of goodwill or a gain from a bargain purchase.

B. Income tax

The income tax expense/(income) for the year comprises current income tax expense (income) and deferred tax expense (income).

Current income tax expense charged to profit or loss is the tax payable on taxable income. Current tax liabilities/(assets) are measured at the amounts expected to be paid to/(recovered from) the relevant taxation authority.

Deferred income tax expense reflects movements in deferred tax asset and deferred tax liability balances during the year as well unused tax losses.

Current and deferred income tax expense/(income) is charged or credited outside profit or loss when the tax relates to items that are recognised outside profit or loss.

Deferred tax assets and liabilities are calculated at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled and their measurement also reflects the manner in which management expects to recover or settle the carrying amount of the related asset or liability. With respect to non-depreciable items of property, plant and equipment measured at fair value and items of investment property measured at fair value, the related deferred tax liability or deferred tax asset is measured on the basis that the carrying amount of the asset will be recovered entirely through sale.

Deferred tax assets and liabilities are calculated at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates enacted or substantively enacted at the end of the reporting period. Their measurement also reflects the manner in which management expects to recover or settle the carrying amount of the related asset or liability.

Deferred tax assets relating to temporary differences and unused tax losses are recognised only to the extent that it is probable that future taxable profit will be available against which the benefits of the deferred tax asset can be utilised.

Where temporary differences exist in relation to investments in subsidiaries, branches, associates and joint ventures, deferred tax assets and liabilities are not recognised where the timing of the reversal of the temporary difference can be controlled and it is not probable that the reversal will occur in the foreseeable future.

Current tax assets and liabilities are offset where a legally enforceable right of set-off exists and it is intended that net settlement or simultaneous realisation and settlement of the respective asset and liability will occur. Deferred tax assets and liabilities are offset where: (a) a legally enforceable right of set-off exists; and (b) the deferred tax assets and liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities where it is intended that net settlement or simultaneous realisation and settlement of the respective asset and liability will occur in future periods in which significant amounts of deferred tax assets or liabilities are expected to be recovered or settled.

Tax Consolidation

Q Technology Group Limited and its wholly-owned Australian subsidiaries have formed an income tax consolidated group under tax consolidation legislation. Each entity in the Group recognises its own current and deferred tax assets and liabilities. Such taxes are measured using the 'stand-alone taxpayer' approach to allocation. Current tax liabilities (assets) and deferred tax assets arising from unused tax losses and tax credits in the subsidiaries are immediately transferred to the head entity.

The Group formed an income tax consolidated group to apply from 1 July 2010. The tax consolidated group has entered a tax funding arrangement whereby each company in the Group contributes to the income tax payable by the Group in proportion to their contribution to the Group's taxable income. Differences between the amounts of net tax assets and liabilities derecognised and the net amounts recognised pursuant to the funding arrangement are recognised as either a contribution by, or distribution to the head entity.

C. Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned to individual items of inventory on the basis of weighted average costs. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

D. Property, plant and equipment

Each class of property, plant and equipment is carried at cost as indicated less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment

Plant and equipment are measured on the cost basis and therefore carried at cost less accumulated depreciation and any accumulated impairment. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to be estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a re-valued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the asset's employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Depreciation

The depreciable amount of all fixed assets is depreciated on straight line basis over the asset's useful life to the consolidated group commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the consolidated income statement.

E. Leases

Leases of fixed assets where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership that is transferred to entities in the consolidated group, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

Lease incentives under operating leases are recognised as a liability and amortised on a straight-line basis over the life of the lease term.

F. Financial instruments

Recognition and initial measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the company commits itself to either the purchase or sale of the asset (i.e. trade date accounting is adopted).

Financial instruments are initially measured at fair value plus transaction costs, except where the instrument is classified 'at fair value through profit or loss', in which case transaction costs are expensed to profit or loss immediately.

Classification and subsequent measurement

Financial instruments are subsequently measured at either of fair value, amortised cost using the effective interest rate method, or cost.

Amortised cost is calculated as the amount at which the financial asset or financial liability is measured at initial recognition less principal repayments and any reduction for impairment, and adjusted for any cumulative amortisation of the difference between that initial amount and the maturity amount calculated using the effective interest method.

The effective interest method is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying value with a consequential recognition of an income or expense in profit or loss.

The Group does not designate any interests in subsidiaries, associates or joint venture entities as being subject to the requirements of accounting standards specifically applicable to financial instruments.

i. Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost.

Loans and receivables are included in current assets, except for those which are not expected to mature within 12 months after the end of the reporting period. (All other loans and receivables are classified as non-current assets.)

ii. Financial liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost.

Impairment

At the end of each reporting period, the Group assesses whether there is objective evidence that a financial instrument has been impaired.

De-recognition

Financial assets are de-recognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are de-recognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

G. Fair value of Assets and Liabilities

Fair value is the price the Group would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

The Group did not measure any of its assets and liabilities at fair value on either a recurring or non-recurring basis, during the financial year.

H. Impairment of Assets

At the end of each reporting period, the Group assesses whether there is any indication that an asset may be impaired. The assessment will include the consideration of external and internal sources of information, including dividends received from subsidiaries, associates or jointly controlled entities deemed to be out of pre-acquisition profits. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount in accordance with another Standard (e.g. in accordance with the revaluation model in AASB 116: Property, Plant and Equipment). Any impairment loss of a revalued asset is treated as a revaluation decrease in accordance with that other Standard.

Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

I. Foreign Currency Transactions and Balances

Functional and presentation currency

The functional currency of each of the Group's entities is determined using the currency of the primary economic environment in which that entity operates. The consolidated financial statements are presented in Australian dollars which is the parent entity's functional and presentation currency.

Transactions and balances

Foreign currency transactions are translated into functional currency using the exchange rates prevailing at the date of the transaction. Foreign currency monetary items are translated at the year-end exchange rate. Non-monetary items measured at historical cost continue to be carried at the exchange rate at the date of the transaction. Non-monetary items measured at fair value are reported at the exchange rate at the date when fair values were determined.

Exchange differences arising on the translation of monetary items are recognised in profit or loss, except where deferred in equity as a qualifying cash flow or net investment hedge.

Exchange differences arising on the translation of non-monetary items are recognised directly in the comprehensive income to the extent that the underlying gain or loss is recognised in other comprehensive income; otherwise the exchange difference is recognised in profit or loss.

J. Employee Benefits

Short-term employee benefits

Provision is made for the Group's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The Group's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as part of current trade and other payables in the statement of financial position. The Group's obligations for employees' annual leave and long service leave entitlements are recognised as provisions in the statement of financial position.

Other long-term employee benefits

Provision is made for employees' long service leave and annual entitlements not expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service. Other long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departure and are discounted at rates determined by reference to market yields and the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the charges occur.

The Group's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the Group does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

Equity-settled compensation

The Group operates equity-settled share-based payment employee share and option schemes. The fair value of the equity to which employees become entitled is measured at grant date and recognised as an expense over the vesting period, with a corresponding increase to an equity account. The fair value of shares is ascertained as the market bid price. The fair value of options is ascertained using a Black–Scholes pricing model which incorporates all market vesting conditions. The number of shares and options expected to vest is reviewed and adjusted at the end of each reporting date such that the amount recognised for services received as consideration for the equity instruments granted shall be based on the number of equity instruments that eventually vest.

K. Provisions

Provisions are recognised when the Group has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measurable using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

L. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

M. Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest revenue is recognised using the effective interest rate method, which, for floating rate financial assets, is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

N. Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Group during the reporting period which remains unpaid. The balance is recognised as a current liability.

O. Borrowing Costs

Borrowing costs directly attributable to the acquisition, construction or production of assets that necessarily take a substantial period of time to prepare for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. All other borrowing costs are recognised in income in the period in which they are incurred.

P. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

Q. Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

When the Group applies an accounting policy retrospectively, makes a retrospective restatement or reclassifies items in its financial statements, a statement of financial position as at the beginning of the earliest comparative period will be disclosed.

R. Rounding of Amounts

The parent entity has applied the relief available to it under ASIC Class Order 98/100 and accordingly, amounts in the financial report and directors' report have been rounded off to the nearest \$1,000.

S. Critical Accounting Estimates and Judgments

The directors evaluate estimates and judgments incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Group.

T. Going Concern

The financial statements have been prepared on the going concern basis, which contemplates continuity of normal business activities and the realisation of assets and discharge of liabilities in the normal course of business.

As disclosed in Note 18 of the financial statements, the Group failed to comply with the interest cover ratio financial covenant as at 30 June 2014. A breach notice was received subsequent to year end from the Bank of Melbourne ("BoM") which advised that no action was to be taken at this point in time.

The Directors believe that it is reasonably foreseeable that the Group will continue as a going concern and that it is appropriate to adopt the going concern basis in the preparation of the financial report after consideration of the following factors:

- Under the finance agreement, the interest cover ratio resets on 1 July 2014 with the next compliance measurement due on 30 September 2014. As at the date of this report, the results of the Group indicate the interest cover ratio, and the other financial covenants, will be met for the quarter ending 30 September 2014;
- The Group has received no further correspondence from the Bank of Melbourne; there have been no communications indicating the finance facility will not continue to be provided;
- At 30 June 2014, the Group's current assets were \$4.8 million in excess of its current liabilities; and
- The Directors are confident the Group will remain in compliance with all financial covenants for a period of no less than 12 months from the date of this report.

U. New and Amended Accounting Policies Adopted by the Group

The Group adopted AASB 119: Employee Benefits and AASB 2011-10: Amendments to Australian Accounting Standards arising from AASB 119 from the mandatory application date of 1 January 2013.

For the purpose of measurement, AASB 119 defines obligations for short-term employee benefits as obligations expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related services. Previously, annual leave satisfied the definition of short-term employee benefits and therefore the leave liability was measured on an undiscounted basis at the amounts expected to be paid when the liability is settled. However, under AASB 119, as the Group expects that most employees will not use all of their annual leave entitlements in the same year in which they are earned or during the following 12-month period, obligations for annual leave entitlements meet the definition of other long-term employee benefits and, therefore, are required to be measured at the present value of the expected future payments to be made to employees.

These changes do not impact the classification of leave entitlements between current and non-current liabilities in the statement of financial position.

The change in accounting policy had no material impact on the Group's financial statements, and as such was not applied retrospectively.

As at 30 June 2014, the Group had a Multi Option Facility with Bank of Melbourne comprising Invoice Discounting, Trade financing, Bank Guarantee and Finance Lease up to \$4.5 million. The facility has a yearly review and renewal process with next review set on 30 June 2015. Interest is charged at an effective rate of 6.25% along with an unused line fee on the debtor finance facility of 0.6%. The Group at year end owed \$1.4 million to Bank of Melbourne.

Since the end of the financial year QRSciences Security Pty Ltd had reached a settlement agreement with Samsung Techwin, Korea to settle an outstanding account, which had been in dispute since February 2014. Pursuant the terms of the settlement agreement the Samsung account will be paid in full during the first quarter of FY2015. The matter is now closed after full settlements made on 21st August 2014.

The Company received a breach notice from the Bank of Melbourne on 19 August 2014 noting that the Company had failed to meet the interest cover of 1.5 times as at 30 June 2014. The same notice confirmed that no action is to be taken at this point in time. As interest cover resets with the new financial year, the Board believes that attainment of the current business plan targets demonstrates ability to comply with bank covenants.

Financial Risk Management Policies

The Risk and Audit Committee (RAC) has been delegated with responsibility by the Board of Directors for, amongst other issues, monitoring and managing financial risk exposures of the Group. The RAC monitors the Group's financial risk management policies and exposures and approves financial transactions within the scope of its authority. It also reviews the effectiveness of internal controls relating to commodity price risk, counterparty credit risk, currency risk, financing risk and interest rate risk

The RAC's overall risk management strategy seeks to assist the consolidated group in meeting its financial targets, while minimising potential adverse effects on financial performance. Its functions include the review of the use of hedging derivative instruments, credit risk policies and future cash flow requirements.

Specific Financial Risk Exposures and Management

The main risks the Group is exposed to through its financial instruments are credit risk, liquidity risk and market risk consisting of interest rate risk, foreign currency risk and commodity and equity price risk.

a. Credit Risk

Exposure to credit risk relating to financial assets arises from the potential non-performance by counterparties of contract obligations that could lead to a financial loss to the Group.

Credit risk is managed through the maintenance of procedures (such procedures include the utilisation of systems for the approval, granting and renewal of credit limits, regular monitoring of exposures against such limits and monitoring of the financial stability of significant customers and counterparties), ensuring to the extent possible, that customers and counterparties to transactions are of sound credit worthiness. Such monitoring is used in assessing receivables for impairment. Credit terms are generally 30 days from the invoice date.

Risk is also minimised through investing surplus funds in financial institutions that maintain a high credit rating. Where the Group is unable to ascertain a satisfactory credit risk profile in relation to a customer or counterparty, the risk may be further managed through title retention clauses over goods or obtaining security by way of personal or commercial guarantees over assets of sufficient value which can be claimed against in the event of any default.

Credit Risk Exposures

The maximum exposure to credit risk by class of recognised financial assets at balance date, excluding the value of any collateral or other security held, is equivalent to the carrying value and classification of those financial assets (net of any provisions) as presented in the statement of financial position.

The Group has no significant concentration of credit risk with any single counterparty or group of counterparties. However, on a geographical basis, the Group has significant credit risk exposures to Australia. Details with respect to credit risk of Trade and Other Receivables are provided in Note 12.

Trade and other receivables that are neither past due or impaired are considered to be of high credit quality. Aggregates of such amounts are as detailed in Note 12.

Credit risk related to balances with banks and other financial institutions is managed by the RAC in accordance with approved Board policy. Such policy requires that surplus funds are only invested with counterparties with a rating of at least AA-. - monitoring undrawn credit facilities
- obtaining funding from a variety of sources
- maintaining a reputable credit profile
- managing credit risk related to financial assets
- only investing surplus cash with major financial institutions, and
- comparing the maturity profile of financial liabilities with the realisation profile of financial assets.

The tables below reflect an undiscounted contractual maturity analysis for financial liabilities. Bank overdrafts have been deducted in the analysis as management does not consider that there is any material risk that the bank will terminate such facilities. The bank does however maintain the right to terminate the facilities without notice and therefore the balances of overdrafts outstanding at year end could become repayable within 12 months. Financial guarantee liabilities are treated as payable on demand since the Group has no control over the timing of any potential settlement of the liabilities.
